WHITE NOISE CALCULUS AND NONLINEAR FILTERING THEORY

A self-contained outline of recent work on the white noise approach to nonlinear filtering is given together with the necessary background of white noise calculus.

1. Introduction. An informal description of the filtering problem is the following: Let the unobserved signal process $X = (X_u)$ be a stochastic (usually assumed to be Markov) process taking values in R^d . Information concerning X is provided by a process $y = (y_i)$ which is continuously observed over time

(1.1)
$$y_t = h_t(X_t) + n_t, \quad 0 \le t \le T,$$

where h_i is a known function and $n=(n_i)$ is a noise process. The problem is to obtain the "best" estimate of X_i given by the set of observations $\{y_s, 0 \le s \le t\}$ or, equivalently, to find the conditional distribution of X_i given $\{y_s, 0 \le s \le t\}$.

A rigorous formulation of (1.1) requires the choice of a mathematical model for the noise process. The latter is an extremely important question when continuous time processes are involved. The usual procedure is to regard the noise n_i , heuristically, as the "derivative" W_i of the Wiener process and to replace (1.1) by its "integrated" version

(1.2)
$$Y_t = \int_0^t h_s(X_s) ds + W_t, \quad 0 \le t \le T.$$

In the martingale approach to filtering theory (which we will also refer to as the stochastic calculus or conventional theory) (1.2) is taken to be the canonical observation model and it is assumed that $X = (X_i)$, $W = (W_i)$ are defined on a probability space $(\Omega, \mathscr{A}, \Pi)$, $h : [0, T] \times \mathbb{R}^d \to \mathbb{R}^m$ is a measurable function satisfying

(1.3)
$$\int_0^T |h_u(X_u)|^2 du < \infty, \quad \Pi-a.s.,$$

and W is a standard m-dimensional Wiener process.

Martingale calculus and the theory of Itô stochastic differential equations (SDEs) have been applied with spectacular success in solving the problem of nonlinear filtering based on (1.2). The first phase of this development culminating

in the derivation of the most general form of the SDE for the optimal filter was essentially given in the papers of Mortenson (1966), Kushner (1967), Kallianpur and Striebel (1969), Zakai (1969) and Fujisaki et al. [FKK] (1972).

In the important case when the signal process is an \mathbb{R}^{d} -valued diffusion most recent work has led to the study of the existence of unique solutions of stochastic partial differential equations (SPDEs) of Itô type satisfied by the unnormalized conditional density of the filtering problem [Rozovakii (1975), Krylov-Rozovskii (1978, 1981) and Pardoux (1979, 1982)].

Despite its elegance, the power of its mathematical techniques, and the enormous stimulus it has provided to the theory of SDEs, the practical validity of the stochastic calculus theory of nonlinear filtering is open to serious criticism. In a series of papers in which he was the first to advocate a finitely additive (f.a.) white noise approach, Balakrishnan has expressed the view (ahared by some engineers) that the model (1.2) is not suitable for applications because the results obtained cannot be instrumented [Balakrishnan (1977, 1980)]. While this objection to the role of the Wiener process in physical problems may not be new, this criticism has stimulated a search for a rigorous theoretical framework for nonlinear filtering that is faithful to the observed phenomena.

The purpose of this article is to present a connected and self-contained account of the work we have done over the last two years in constructing a rigorous white noise calculus and applying it to develop nonlinear filtering theory.

Two things should be pointed out in connection with our theory:

- (i) The natural space of observations and of the noise is a Hilbert space (or a suitable subspace of it) of Wiener measure zero. An insistence on countably additive probabilistic techniques would require an enlargement of this space either to a Wiener space of continuous functions C([0, T]; R^m) or to an even larger space such as \(\mathcal{S}^{m}(R^{d}) \), the Schwarz space of tempered distributions. (The latter is an interesting possibility yet to be fully explored.) The alternative is to resort to a finitely additive white noise measure on Hilbert space.
- (ii) The role of the Wiener process as a model for noise is customarily that given in (1.2). However, Wiener himself, in a conversation with one of the authors several years ago at the Indian Statistical Institute, stated that n(f) given by the stochastic integral folicity dW, can be used to define Gaussian white noise over the Hilbert space L²[0, 1]. The latter is indeed an example of a (finitely additive) cylinder measure or weak distribution used in later work by I. E. Segal (1956) and by L. Gross (1960, 1962). It is the model adopted by us in the definition of the abstract statistical model to be given in Section 4.

The plan of the paper is as follows: We begin by giving, in Section 2, a concise description of the main results of nonlinear filtering theory based on stochastic calculus. For more details see Part I of our survey paper [Kallianpur and Karandikar (1983b)]. Other and more comprehensive accounts of this theory are available in books. (See the references in Section 2.)

Section 3 and part of Section 4 contain preparatory material on the theory of f.a. quasicylindrical probability measures (QCPs), for which we cannot find any

reference in the literature. The notion of a lifting with respect to a QCP is, of course, based on ideas of Segal and Gross but it has been found necessary to develop these further for our purpose. The definition of absolute continuity for finitely additive measures and the version of the Radon-Nikodym theorem given in the book of Dunford and Schwartz (1958) are not suitable from our point of view. The same is true of the definitions given in Gross's paper [Gross (1962)]. We have introduced new—and for us, the right—definitions of all these concepts. The development presented is entirely self-contained and culminates in the abstract nonlinear filtering model and the finitely additive version of the Kallianpur-Striebel Bayes formula.

In Section 5, the white noise versions of the Zakai and FKK equations are obtained. We then specialize to the case when the signal is an \mathbb{R}^d -valued diffusion process. When the unnormalized conditional density exists it is shown to satisfy a partial differential equation (PDE) which we call the Zakai equation for the unnormalized density. The other main results of this section (Theorems 5.5 and 5.6) establish the existence of a unique solution of the Zakai PDE under conditions which do not assume the boundedness of h. As mentioned earlier, the Zakai and FKK equations as well as the PDE are not stochastic differential equations but "ordinary" differential (or partial differential) equations in which the observed path occurs as a parameter in the coefficients.

In Section 6 we study the f.a. white noise theory in a more general framework that includes applications to signal and observation processes taking values in infinite-dimensional separable Hilbert spaces. In the model (1.2) the state space of X is assumed to be a complete separable, metric (Polish) space S, e is X-valued white noise, where X is possibly infinite-dimensional Hilbert space, and $h: [0,T] \times S \to X$ is a measurable function such that $E \int_0^T ||h_x||_X^2 ds < \infty$. The chief difficulty here is that we have no conditional density since there is no Lebesgue measure (or any natural measure) in Hilbert space. Instead of the PDEs of the preceding section we obtain f.a. analogues of measure-valued equations of FKK, Zakai, and Kunita types. The equations (of which the first two are differential equations) are derived, and the equivalence and the uniqueness of solutions of these equations are established in Theorems 6.1-6.4. An approximation procedure is also set forth involving convergence in variation norm.

It seems worth remarking that the white noise calculus approach is seen to its best advantage in its treatment of problems where infinite-dimensional signal processes are encountered. This is an important area of application to filtering and prediction of random fields (though a great deal still remains to be done). At present, the stochastic calculus treatment has not gone beyond deriving the SDEs for the optimal filter [see, e.g., Korezlioglu and Martias (1984) and the references therein). The difficulties in the way of proving existence of unique solutions seem to be formidable.

Section 7 is a brief digression devoted to likelihood ratios in the f.a. framework, a topic whose applications to statistical problems will be considered elsewhere. Formulas for likelihood ratios for random fields are also given, since in principle, the white noise theory poses no special difficulties for multiparameter processes.

There have been attempts in recent years to modify the stochastic calculus filtering theory so as to bring it closer to applications. The work on pathwise or "robust" solutions to the SDEs of the filtering problems [Clark (1978), Davis (1979, 1980), Pardoux (1979), (1982)] as well as the investigations of the approximations to Itô SDEs and their solutions [discussed in Ikeda and Watanabe (1981)] may be viewed in this light. The white noise approach is entirely different in spirit in that it avoids the complexities inherent in the stochastic calculus treatment of the subject. Our lack of familiarity with f.a. measure theory necessitates a careful definition of concepts well known in countably additive probability theory: conditional expectations, absolute continuity, Radon-Nikodym derivatives, change of variables formula, etc. Once this is done, however, the simplicity and the advantages of the new approach are apparent.

The question that naturally arises, however, is whether the white noise calculus gives the same results as the martingale-theoretic approach to the subject. This important point is discussed in some detail in Section 8 where we show that our theory is consistent with the conventional theory. In fact, the robust filter of the latter can be recovered by using the theorems of Section 8. In Section 9 we list some of the open problems on which we and some of our colleagues are working.

2. A brief survey of nonlinear filtering theory based on stochastic calculus. The stochastic calculus approach to nonlinear filtering theory takes the model (1.2) as its starting point. Since detailed expositions of the theory are now available in books and survey articles [Elliott (1982), Kallianpur (1980), Liptser and Shiryaev (1977), Kunita (1983)], we give here only a highly condensed account of the principal results concerning the derivation of the stochastic differential equation (SDE) of the optimal filter and on the existence and uniqueness of the solution. Our object is to give the reader a flavour of the martingale approach and to enable him to contrast it with the theory described in the later sections.

In the model (1.2)

$$Y_t = \int_0^t h_u \, du \, + \, W_t, \qquad 0 \leq t \leq T,$$

 h_t is measurable wrt \mathscr{F}_t^X where \mathscr{F}_t^X is the σ field generated by the family $\{X_u, 0 \leq u \leq t\}$ augmented by the inclusion of zero probability sets. Here $X = (X_t)$, called the signal process, is usually taken to be a Markov process with state space \mathbb{R}^d , though more general infinite dimensional spaces can be considered (see Sec. 6). The process $h = (h_t)$ is taken to be R^m -valued and contains information about $X = (X_t)$. Furthermore, it is assumed that

$$E\int |h_t|^2\,dt<\infty.$$

The noise in (1.2) is given by $W = (W_t)$, an \mathbb{R}^m -valued standard Wiener process. The most general assumptions on the noise and signal process are that for each t, the σ fields $\sigma(X_u, W_u, 0 \le u \le t)$ and $\sigma(W_v - W_u, t \le u < v \le T)$ are

independent. An important special case to be treated in greater detail later is the independence of signal and noise, i.e., of $\sigma(X_t, 0 \le t \le T)$ and $\sigma(W_t, 0 \le t \le T)$. [The processes $(X_t)_t$, $(h_t)_t$, and $(W_t)_t$ are defined on a countably additive probability space $(\Omega, \mathscr{A}, \Pi)_t$.]

Given the observations $\{Y_i, 0 \le s \le t\}$, the basic nonlinear filtering problem is to find the conditional distribution $\Pi(X_i \in (\cdot)|\mathcal{F}_i^{\mathcal{F}_i})$ of the "present" state of the system. A crucial requirement is that the solution be a recursive estimate since in most applications the data are observed continuously in time so that it is important to be able to compute the conditional distribution at time $t + \delta t$ ($\delta t > 0$) using its value at time t. In other words, one seeks a SDE for the conditional distribution or, equivalently, for the conditional expectation $\Pi_i(I) = E[f(X_i)|\mathcal{F}_i^{\mathcal{F}_i}]$ for a wide enough class of functions $f: \mathbb{R}^d \to \mathbb{R}$. In most cases of interest, e.g., if X is a diffusion process it is enough to consider $f \in C_k^2$.

The following simple result is the natural starting point of the martingale theoretic approach to the subject.

PROPOSITION 2.1. Let $\xi_t = \xi_0 + A_t + M_t$, $t \in [0, T]$ be a d-dimensional semi-martingale relative to (\mathcal{G}_t) . Assume the following conditions hold:

- (i) (A_t) is a right-continuous (𝒞_t)-adapted process of bounded variation in [0, T] with A₀ = 0.
- (ii) $E|Var_T A|^2 < \infty$.
- (iii) (M_0, \mathcal{G}_0) is a right-continuous L^2 martingale with $M_0 = 0$.
- (iv) $E|\xi_0|^2 < \infty$.

Then $\Pi_i(\xi) = E(\xi_i|\mathscr{F}_i)$ is an L^2 -semimartingale relative to \mathscr{F}_i , where (\mathscr{F}_i) is a right-continuous family of σ fields such that $(\mathscr{F}_i) \subseteq (\mathscr{G}_i)$ for all t. Further,

(2.1)
$$\Pi_{i}(\xi) = \Pi_{0}(\xi_{0}) + \overline{A}_{i} + \overline{M}_{i};$$

(2.2) \overline{A}_i is the dual predictable projection of A_i relative to (\mathcal{F}_i) with $\overline{A}_0 = 0$;

$$(2.3) E|\operatorname{Var}_{\tau} \overline{A}|^2 < \infty;$$

(2.4)
$$(\overline{M}_i, \mathcal{F}_i)$$
 is a right-continuous martingale with $\overline{M}_0 = 0$.

Now suppose that the signal process is an \mathbb{R}^d -valued diffusion process with generator \mathscr{L} , given by

$$\mathcal{L}f = \frac{\partial f}{\partial t} + \mathcal{L}_t f$$

for $f \in C_0^{1,2}([0,T] \times \mathbb{R}^d)$ and for $g \in C_0^2(\mathbb{R}^d)$.

$$(2.5) \qquad (\mathscr{L}_{ig})(x) = \frac{1}{2} \sum_{i,j=1}^{d} a_{ij}(t,x) \frac{\partial^{2}g}{\partial x^{i}\partial x^{j}}(x) + \sum_{i=1}^{d} b_{i}(t,x) \frac{\partial g}{\partial x^{i}}(x),$$

for suitable measurable functions a_{ij} , b_i such that the matrix $((a_{ij}(t,x)))$ is nonnegative definite.

The process (X,) can be realized as a (weak) solution to the SDE

$$(2.5) dX_t = b(t, X_t) dt + \sigma(t, X_t) dB_t,$$

where B_t is an \mathbb{R}^d -valued Brownian motion and σ is such that $a(t,x) = \phi(t,x)\sigma^{\alpha}(t,x)$.

For an integrable function f on $(\Omega, \mathcal{A}, \Pi)$, introduce the notation

$$\hat{\Pi}_{i}(I) = E_{ii}(I)\mathcal{F}_{i}^{Y}$$

and for a function $g: \mathbb{R}^d \to \mathbb{R}$ such that $E_{11}[g(X_t)] < \infty$,

$$\Pi_{\epsilon}(g) = \tilde{\Pi}_{\epsilon}(g(X_{\epsilon})) = E_{\epsilon i}(g(X_{\epsilon})|\mathcal{F}_{\epsilon}^{Y}).$$

By Itô's formula (or Lemma A.1), we have that for $g \in C_0^2(\mathbb{R}^d)$,

$$(2.7) M_t = g(X_t) - \int_0^t (\mathcal{L}_* g)(X_*) ds$$

is an \mathscr{F}_i^X martingale. In view of the assumption on the independence of $\sigma(X_u, W_u, u \le t)$ and $\sigma(W_u = W_t, t \le u \le T)$, this implies that M_t is an $\mathscr{F}_i^{X,Y}$ martingale.

Applying Proposition 2.1 with $\xi_i = g(X_i)$, $A_i = \int_0^1 (\mathscr{L}_s g \setminus X_s) ds$, $\mathscr{G}_i = \mathscr{F}_i^{(V_s)}$ and $\mathscr{F}_i = \mathscr{F}_i^{(Y_s)}$, we get

(2.8)
$$\Pi_{i}(g) = \Pi_{0}(g) + \vec{A}_{i} + \vec{M}_{i},$$

where \overline{M}_t is an \mathcal{F}_t^Y martingale. It can be shown that $\overline{A}_t = \int_0^t \Pi_s(\mathcal{L}_s g) ds$ so that

(2.9)
$$\Pi_{i}(g) = \Pi_{0}(g) + \int_{0}^{t} \Pi_{s}(\mathcal{L}_{s}g) ds + \overline{M}_{i}.$$

It will be seen from (2.9) that the problem of obtaining an Itô-type SDE for $\Pi_I(I)$ reduces to the problem of expressing \overline{M}_i as a stochastic integral with respect to an (\mathcal{F}_i^{Y})-adapted Wiener process. That such a Wiener process exists is shown by the following result.

Proposition 2.2.

(i) The process v, defined by

(2.10)
$$\nu_t = Y_t - \int_0^t \tilde{\Pi}_s(h_s) ds$$

is a Wiener martingale with respect to (F, Y);

(ii) For any t, $\sigma[\nu_{t} - \nu_{t}, t \leq v \leq T] \perp \mathcal{F}_{t}^{\gamma}$.

See FKK (1972) for the proof. The Wiener martingale (r_i, \mathscr{F}_i^Y) is called an innovation process.

Clearly from the definition $\mathscr{F}_i^* \subseteq \mathscr{F}_i^{Y}$. The equality of the σ fields (for each t) holds in the case of linear (Kalman-Bucy) filtering [Kailath (1968)]. For nonlinear filtering, Allinger and Mitter (1981) extending an earlier result due to Clark (1969), have shown that equality holds if the processes (h_i) and W_i are independent and $E[a_i^T]h_i|^2ds < \infty$.

The significance of this result from the point of view of nonlinear filtering is obvious for the representation of the martingale \overline{M}_i of (1.9) as a stochastic integral, with respect to ν_i , is then an immediate consequence of the celebrated results of Cameron and Martin and of Itô [see Kallianpur (1980)]. However, a counterexample due to Tsirel'son shows that equality cannot hold in general. Although the problem is of independent interest, Fujisaki, Kallianpur, and Kunita have shown that the desired stochastic integral representation is available without having to prove first that $\mathscr{F}_i^{\,\nu} = \mathscr{F}_i^{\,\nu}$.

PROPOSITION 2.3 [Fujisaki et al. (1972)]. Let $(\overline{M}_i, \mathcal{F}_i^{\gamma})$ be a right-continuous (or separable) L^2 -martingale with $\overline{M}_0 = 0$. Then there is a process ϕ_i which is \mathcal{F}_i^{γ} -predictable such that

(2.11)
$$\overline{M}_{t} = \int_{0}^{t} (\phi_{s}, d\nu_{s}) = \sum_{i=1}^{m} \int_{0}^{t} \phi_{s}^{i} d\nu_{s}^{i},$$

Furthermore, $\int_0^T E |\phi_s|^2 ds < \infty$.

The process ϕ_s appearing in (2.11) is related to the processes $(X_t), (Y_t)$ as follows [see Kallianpur (1980)]. Let $\tilde{D}_s^{h,\iota}$ be the $\mathscr{F}_t^{X,Y}$ -predictable process given by

$$\langle B^{k}, W^{i} \rangle_{i} = \int_{0}^{t} \overline{D}_{s}^{k,i} ds$$

and let

$$(2.13) \qquad (\tilde{D}_{s}^{i}g)(x) = \sum_{k=1}^{d} \sum_{j=1}^{d} \tilde{D}_{s}^{k,i} \sigma_{k,j}(s,x) \frac{\partial}{\partial x^{i}} g(x).$$

Then

$$(2.14) \qquad \phi_s^i = \tilde{\Pi}_s(g(X_s)h_s^i) - \Pi_s(g)\tilde{\Pi}_s(h_s^i) + \tilde{\Pi}_s(\tilde{D}_sg(X_s)).$$

The basic SDE given in the next result is a consequence of the above arguments and Proposition 2.3.

THEOREM 2.4 [FKK (1972)]. Under the conditions stated earlier, for all $f \in C_b^2(\mathbb{R}^d)$,

$$\begin{split} \Pi_{t}(f) &= \Pi_{0}(f) + \int_{0}^{t} \Pi_{s}(h_{s}f) \, ds \\ (2.15) &+ \sum_{i=1}^{m} \int_{0}^{t} \left[\tilde{\Pi}_{s}(f(X_{s})h_{s}^{i}) - \Pi_{s}(f)\tilde{\Pi}_{s}(h_{s}^{i}) + \tilde{\Pi}_{s}(\tilde{D}_{s}^{i}f(X_{s}))\right] \, d\nu_{s}^{i}. \end{split}$$

Stochastic equations for the conditional distribution $\Pi_i(X_i \in \mathcal{F}_i^Y)$. Suppose that the functions h and D [appearing in (2.12)] are given by

$$(2.16) h_{\bullet}^{i}(\omega) = h_{\bullet}^{i}(X_{\bullet}(\omega)) \text{ and } \tilde{D}_{\bullet}^{k,i}(\omega) = D_{\bullet}^{k,i}(X_{\bullet}(\omega))$$

for suitable measurable functions h_s^i , $D_s^{k,i}$ from $\mathbb{R}^+ \times \mathbb{R}^d$ to \mathbb{R}^1 . Let

(2.17)
$$D_{s}^{i}g(x) = \sum_{k=1}^{d} \sum_{j=1}^{d} D_{s}^{k,i}(x) \sigma_{k,j}(s,x) \frac{\partial}{\partial x^{i}} g(x).$$

In view of (2.16), the equation (2.15) reduces to the following equation, which is a SDE for the conditional distribution $\Pi_i(X_i \in \cdot | \mathcal{F}_i^Y)$ [recall: $\Pi_i(f) = \iint (x) \Pi_i(X_i \in dx | \mathcal{F}_i^Y)$].

(2.18)
$$\Pi_{t}(f) = \Pi_{0}(f) + \int_{0}^{t} \Pi_{s}(\mathcal{L}_{s}f) ds \\ + \sum_{i=1}^{m} \int_{0}^{t} \left[\Pi_{s}(fh_{s}^{i}) - \Pi_{s}(f) \Pi_{s}(h_{s}^{i}) + \Pi_{s}(D_{s}^{i}f) \right] d\nu_{s}^{i}.$$

This equation was first derived by Kushner (1967).

Zakai (1969) obtained a SDE equivalent to (2.18) which is easier to handle, It may be derived from (2.18) as follows: Let

(2.19)
$$\alpha_{t} = \exp \left(\int_{0}^{t} \sum_{i=1}^{m} \Pi_{s}(h_{s}^{i}) dY_{s}^{i} - \frac{1}{2} \int_{0}^{t} \sum_{i=1}^{m} \left[\Pi_{s}(h_{s}^{i}) \right]^{2} ds \right).$$

Then,

$$\alpha_t = \exp\left(\int_0^t \sum_{i=1}^m \Pi_s(h_s^i) d\nu_s^i + \frac{1}{2} \int_0^t \sum_{i=1}^m \left[\Pi_s(h_s^i)\right]^2 ds\right).$$

Itô's formula gives

(2.20)
$$d\alpha_{t} = \alpha_{t} \sum_{i=1}^{m} \left(\prod_{t} (h_{t}^{i}) \right)^{2} + \alpha_{t} \sum_{i=1}^{m} \prod_{t} (h_{t}^{i}) d\nu_{t}^{i}.$$

Using (2.18) and applying Itô's formula to $\sigma_i(f) = \Pi_i(f) \cdot \alpha_i$, we get

(2.21)
$$d\sigma_t(f) = \sigma_t(\mathcal{L}_t f) + \sum_{i=1}^m \sigma_t(D_t^i f + h_t^i f) dY_t^i.$$

The equation (2.21) is called the Zakai equation and is a measure-valued SDE. From the relation $\sigma_i(f) = \Pi_i(f) \cdot \alpha_i$, we have $\sigma_i(1) = \Pi_i(1) \cdot \alpha_i$ and since $\alpha_i > 0$ a.s., we get

(2.22)
$$\Pi_{t}(f) = \frac{\sigma_{t}(f)}{\sigma_{t}(1)}.$$

Thus, $\sigma_l(f)$ is called the unnormalized conditional expectation of f.

A derivation of the Zakai equation that is closer in spirit to the white noise approach of this paper, is based on what is known as the reference probability method. It is the approach followed by Pardoux (1979) and several other writers.

The following representation for $\Pi_i(f)$ can be obtained under the assumption that h is bounded (or a suitable integrability condition). Let

$$N_{t} = \exp\left\{\int_{0}^{t} \sum_{i=1}^{m} h_{s}^{i}(X_{s}) dY_{s}^{i} - \frac{1}{2} \int_{0}^{t} |h_{s}(X_{s})|^{2} ds\right\},\,$$

and let Π' be a measure on (Ω, \mathscr{A}) given by

$$d\Pi' = N_T^{-1} d\Pi.$$

By Girsanov's theorem, Π' is a probability measure and $\{Y_i\}$ is a Wiener process under Π' . It can be shown that

(2.23)
$$\Pi_{t}(f) = \frac{E_{\Pi} \left(f(X_{t}) N_{t} | \mathcal{F}_{t}^{Y} \right)}{E'_{\Omega} \left(N_{t} | \mathcal{F}_{t}^{Y} \right)}$$

and that the numerator in (2.23) is $\sigma_i(f)$. Π' is called the reference probability.

The Zakai equation (2.21) can now be obtained directly from (2.23) which may be regarded as an "extended" Bayes formula. In Theorem 2.7 below, we employ this method to give an explicit derivation of (2.21) for the case of interest to us, viz., when the signal and noise are independent. Formula (2.23) then takes a simpler form equivalent to the Bayes formula obtained in Theorem 2.6.

Stochastic PDE for the unnormalized conditional density. When the (unconditional) distribution of X_i admits a density wrt the Lebesgue measure on \mathbb{R}^d , then (under certain conditions) the functional $\sigma_i(f)$ also admits a density, i.e.,

(2.24)
$$\sigma_t(f) = \int_{\mathbb{R}^d} f(x) p_t(x) dx$$

for a suitable \mathcal{F}_{i}^{Y} -adapted process $p_{i}(x)$. In view of (2.22), we have

(2.25)
$$E_{\Pi}(f(X_t)|\mathscr{F}_t^{\Upsilon}) = \frac{\int f(x)p_t(x) dx}{\int p_t(x) dx}$$

and hence $p_i(x)$ (if it exists) is called the unnormalized conditional density of X_i , given \mathcal{F}_i^{γ} . It follows from (2.21) that $p_i(x)$ satisfies the following stochastic PDE (SPDE)

(2.26)
$$dp_{t}(x) = \mathcal{L}_{t}^{*}p_{t}(x) dt + \sum_{j=1}^{m} \left(D_{t}^{j*} + h_{t}^{j}\right)p_{t}(x) dY_{t}^{j},$$

where \mathcal{L}_{i}^{*} and D_{i}^{*} are formal adjoints of \mathcal{L}_{i} , and D_{i}^{*} .

The problem of identifying the unnormalized conditional density as the unique solution to a SPDE has been studied by Krylov-Rozovskii (1981) and Pardoux (1979). We state Pardoux's result using his notation.

Let the system process (X_i) and observation (Y_i) be given by

$$dX_t = b(t, X_t) dt + \sigma(t, X_t) dW_t,$$

$$dY_t = h(t, X_t) dt + g(t) dW_t + g'(t) dW_t',$$

where W_i and W_i' are independent standard Wiener processes with values in \mathbb{R}^d and \mathbb{R}^m , respectively, $\sigma_{i,i}(t,x)$ are continuous, bounded on $[0,T]\times\mathbb{R}^d$, $i,j=1,\ldots,d$; $b_i(t,x),h_i(t,x)$ are Borel-measurable, bounded on $[0,T]\times\mathbb{R}^d$, $i=1,\ldots,d$

1,..., d; h = 1,...,m; $g_{k,i}(t), g_{k,j}^*(t)$ are continuous on \mathbb{R}^+ , k, j = 1,...,m; i = 1,...,d; and $g(t)g^*(t) + g'(t)g'^*(t) = I$. Further, assume that $\sigma\sigma^*$ and

 $g'g'^{\bullet}$ are uniformly positive definite and for i, j = 1, ..., d:

$$\frac{\partial}{\partial x^i} \sigma_{ij}$$
 exists and is bounded.

Let $a=\sigma\sigma^*$, $c=g^*$, and $\bar{h}^k_t=h^k_t-\sum_{i=1}^d\{[\partial c_{k,i}(t)]/\partial x^i\}$. With these notations, the Zakai equation (2.26) reduces to

$$(2.27) dp_t = \mathcal{L}_t^{\bullet} p_t dt + \left[\overline{h}_t p_t - c_t \cdot \nabla p_t, dY_t \right], p_0 = \phi,$$

where ϕ is the density of X_0 and \mathcal{L}_t is given by (2.5). Let

$$W^{1,2} = \left\{ u \in L^2(\mathbb{R}^d) \colon \frac{\partial u}{\partial x^i} \in L^2(\mathbb{R}^d) \right\}$$

and let \mathcal{L}_{i} , \mathcal{L}_{i}^{*} be defined by

$$\begin{split} \langle \mathcal{L}_{t}u,v\rangle &= \langle L_{t}^{\bullet}v,u\rangle = -\tfrac{1}{2}\sum_{i,j=1}^{d}\int a_{ij}(t,x)\frac{\partial u}{\partial x^{i}}\frac{\partial v}{\partial x^{j}}\,dx \\ &+\int\sum_{i=1}^{d}a_{i}(t,x)\frac{\partial u}{\partial x^{i}}\,dx, \end{split}$$

where $u, v \in W^{1,2}$ and

$$a_i = b_i - \frac{1}{2} \sum_{i=1}^d \frac{\partial a_{ij}}{\partial x^j}.$$

The equation (2.27) is to be taken as an equation for a $W^{1,2}$ -valued process. Pardoux (1979) has proved the following result.

THEOREM 2.5. The SPDE (2.27) has a unique solution
$$p_i(x)$$
 in the class $L^2(\Omega \times (0,T),W^{1,2}) \cap L^2(\Omega,C[0,T],L^2(\mathbb{R}^d)).$

Further, $p_i(x)$ is the unnormalized conditional density of X_i given \mathcal{F}_i^{γ} [i.e., $p_i(x)$ satisfies (2.25)].

Bayes formula and Zakai equation in the signal-noise independent case. We now specialize to the important case of nonlinear filtering when the signal process and noise are independent. Formula (2.23) reduces to a simpler form and can be looked upon as a Bayes formula. This gives the conditional expectations in terms of function space integrals. The SDEs for the optimal filter can be derived directly from this formula without using the sophisticated martingale-theoretic arguments. [See Kallianpur-Striebel (1969).]

In the model (1.2), let (X_t) and (W_t) be independent and let $h_t = h_t(X_t(\omega))$, where $h_t(x)$ satisfies

(2.28)
$$\int_0^T |h_t(X_t(\omega))|^2 dt < \infty, \quad \Pi\text{-a.s.}$$

Let $Z=(Z_t)$ be the canonical coordinate process on $\Omega_0=C([0,T],\mathbb{R}^m)$, Π_0 , the standard Wiener measure, and \mathscr{A}_0 be the Borel σ field on Ω_0 , augmented with Π_0 null sets.

THEOREM 2.6 [Kallianpur-Striebel (1968)]. Let g be a \mathcal{F}_T^{\times} -measurable integrable random variable. Then we have

(2.29)
$$E_{\Pi}(g|\mathcal{F}_{i}^{\gamma}) = \tilde{\Pi}_{i}(g,Y) - \frac{\tilde{\sigma}_{i}(g,Y)}{\tilde{\sigma}_{i}(1,Y)},$$

where $\delta_i(g, Z)$ is defined by

(2.30)
$$\delta_t(g, Z) = \int_{\Omega} g(\omega) \exp \left(\sum_{i=1}^m \int_0^i h_s^i(X_s(\omega)) dZ_s^i \right. \\ \left. - \frac{1}{2} \int_0^i \left| h_s(X_s(\omega)) \right|^2 ds \right) d\Pi(\omega).$$

The stochastic integral appearing in (2.30) is to be interpreted as a stochastic integral on $(\Omega \times \Omega_0, \mathscr{A} \times \mathscr{A}_0, \Pi \times \Pi_0)$. Here, (2.30) defines $\tilde{o}_i(g,Z)$ as a Wiener functional for Π_0 -a.e. Z. Since ΠY^{-1} is equivalent to Π_0 , $\tilde{\sigma}_i(g,Y(\omega))$ is defined for Π -a.e. ω .

REMARK 2.1. $\partial_i(g, Y(\omega))$ can be described directly as follows.

$$\bar{\sigma}_{i}(g, Y(\omega)) = \int_{\Omega} g(\omega') \exp\left[\sum_{s=1}^{d} \int_{0}^{t} h_{s}'(X_{s}(\omega')) dY_{s}'(\omega) - \frac{1}{2} \int_{0}^{t} |h_{s}(X_{s}(\omega'))|^{2} ds\right] d\Pi(\omega'),$$
(2.31)

where the stochastic integral in (2.31) is to be interpreted as a stochastic integral on $(\Omega \times \Omega, \mathscr{A} \otimes \mathscr{A}, \Pi \otimes \Pi)$. That (2.31) is equivalent to (2.30) follows from the fact that since ΠY^{-1} is equivalent to Π_0 , $\iint dZ$ (under Π_0) = $\iint dZ$ (under ΠY^{-1}) [see Meyer (1976)].

Now suppose in addition that (X_i) is an S-valued Markov process with generator $\mathscr L$ [where $(S,\mathscr L)$ is a measurable space]. Let $\mathscr L$ be the domain of $\mathscr L$. Let $\mathscr L$, S be the class of bounded measurable functions on $(S,\mathscr L)$. Let $\mathscr L$ 0 be the class of functions $f \in \mathscr F(S,\mathscr L)$ s.t. f1, defined by

$$f_1(s,x) = f(x)$$

belongs to \mathcal{P} and let $(\mathcal{L}_f/(x) - (\mathcal{L}_f/(t,x))$. As before, let us write for $f \in \mathcal{J}(S,\mathcal{L})$

$$\sigma_{\ell}(f, Y) = \tilde{\sigma}_{\ell}(f(X_{\ell}), Y).$$

The Zakai equation (2.21) in this special case can be derived easily from the Bayes formula (2.29). For a proof, see Kallianpur-Karandikar (1983b). Ocone (1985) has shown that condition (2.32) can be replaced by the conditions $E_{11}f_0^T[h_1(X_s)]^2 ds < \infty$ and $E_{11}h_1(X_s)[<\infty$ for $0 \le s \le T$.

THEOREM 2.7. Suppose that

$$(2.32) E_{\Pi}\left[\exp\left(\int_{0}^{T}\left|h_{s}(X_{s})\right|^{2}ds\right)\right] < \infty.$$

Then for all $f \in \mathcal{D}_0$,

(2.33)
$$d\sigma_{\ell}(f,Y) = \sigma_{\ell}(\mathcal{L}_{\ell}f,Y) dt + \sum_{i=1}^{m} \sigma_{\ell}(h_{i}^{i}f,Y) dY_{\ell}^{i}.$$

When the process (X_i) is an \mathbb{R}^d -valued diffusion process, the Zakai equation for the unnormalized conditional density $p_i(x, Y)$ (2.27) reduces to

(2.34)
$$dp_t(x,Y) = \mathcal{L}_t^* p_t(x,Y) dt + \sum_{i=1}^m h_i^i(x) p_t(x,Y) dY_t^i.$$

The existence of a solution to (2.34) and its identification as the unnormalized conditional density follow from Pardoux's result (Theorem 2.5 above).

A different approach to the solution of the filtering problem due to Davis (1980) is as follows. For each $Z \in C([0,T],\mathbb{R}^m)$, define a two parameter semi-group acting on $\mathscr{J}(S,\mathscr{S})$ by

$$(T_{s,t}^{Z}f)(x) = E_{\Pi} \left(f(X_{t}) \exp \left(\sum_{i=1}^{m} \left\{ -Z_{t}^{i} h_{t}^{i}(X_{t}) + \int_{s}^{t} h_{u}^{i}(X_{u}) dZ_{u}^{i} \right. \right. \right.$$

$$\left. + Z_{s}^{i} h_{s}^{i}(X_{s}) + \int_{s}^{t} h_{u}^{i}(X_{u}) dZ_{u}^{i} - \frac{1}{2} \int_{s}^{t} \left(h_{u}^{i}(X_{u}) \right)^{2} du \right\} \right) \left| X_{s} = x \right|.$$

It is easy to verify that

(2.36)
$$\sigma_t(f,Y) = \int_{\mathbb{R}^d} T_{s,t}^Y \left(\exp\left(\sum_{i=1}^m Y_i^i h_t^i(\cdot)\right) f \right) (x) d\mu(x),$$

where μ is the distribution of X_0 . If we assume that $h_i(X_i)$ is a continuous semimartingale, then by the integration by parts formula, we have

$$(T_{s,t}^{Z}g)(x) = E_{\Pi} \left\{ f(X_{t}) \exp\left\{ -\int_{s}^{t} \sum_{i=1}^{m} Z_{u}^{i} dh_{u}^{i}(X_{u}) - \frac{1}{2} \int_{s}^{t} |h_{u}(X_{u})|^{2} du \right\} \middle| X_{s} = x \right\}.$$

Observe that the path Z appears as a parameter in (2.37). If (X_i) is an \mathbb{R}^{d} -valued diffusion and h is smooth, it is possible to compute the generator $\{A_x^Z\}$ of $T_{x,i}^{Z}$ for each Z. This, in view of (2.36), gives a "pathwise solution" to the filtering problem since, given an observation path Y, we can construct the semigroup $T_{x,i}^Y$ from its generator $\{A_x^Y\}$ and then compute $\sigma_i(f,Y)$ by (2.36). Davis (1980) has obtained an expression for $\{A_x^Z\}$ when (X_i) is a Lévy process.

Another approach to the pathwise solution of the filtering problem will be discussed in Section 8.

3. Some basic ideas of finitely additive white noise theory. As explained in the Introduction, in our approach to filtering theory, the noise is defined by a Gaussian cylinder measure whereas the signal (or system) process is understood to be a stochastic process in the usual customary sense, i.e., a process, usually assumed to be Markov, defined on a countably additive probability space. For a rigorous treatment of a noise independent signal model we first need to define several important definitions and concepts upon which our work is based. The major thrust of these definitions is to create a theory general enough for the purpose of nonlinear prediction, filtering, and estimation theory. We introduce integration with respect to a quasicylinder probability measure (QCP) of suitable classes of cylinder functions, followed by a definition of absolute continuity of QCPs. The notions of a representation and lifting associated with a QCP are indispensable and, though very similar ideas are met with in the works of Segal and of Gross [Segal (1956), Gross (1962)], our problems are sufficiently different as to require a detailed and independent treatment. One of the most useful and important of our concepts is that of a quasicylindrical mapping (QCM), which has most of the desirable properties of a random variable in the countably additive theory. A QCM defined on a quasicylindrical probability space induces a QCP on the range space and an associated induced representation. Furthermore, it enables us to give a definition of conditional expectation more inclusive than the one to be found in an earlier paper of ours [Kallianpur and Karandikar (1983a)].

Let H be a real separable infinite-dimensional Hilbert space with inner product (\cdot, \cdot) and norm $|\cdot|$. Let $\mathscr{P} = \mathscr{P}(H)$ be the class of orthogonal projections on H with finite-dimensional range. For $P \in \mathscr{P}$, let

$$\mathscr{G}_P = \{P^{-1}B: B \text{ a Borel set in range } P\}$$

and

$$\mathcal{C}=\mathcal{C}(H)=\bigcup_{P\in\mathcal{P}}\mathcal{C}_{P}.$$

DEFINITION. A cylinder measure n on (H, \mathscr{C}) is a finitely additive probability measure on (H, \mathscr{C}) such that for all $P \in \mathscr{P}$ its restriction to \mathscr{C}_P is countably additive.

Gross has defined #fdn for a certain class of functions. We will generalize Gross's definition to a space which is a "product" of a measurable space and a Hilbert space. Such a product space was used in Kallianpur-Karandikar (1983a) as a model for nonlinear filtering with white noise. There, we did not define integration on the product space for a sufficiently large class of functions, but defined conditional expectation by going over to the range.

Let (Ω, \mathcal{A}) be a measurable space and let

$$E = \Omega \times H$$
.

For $P \in \mathcal{P}$, let

and

$$\mathcal{E} = \bigcup_{P \in \mathcal{Q}} \mathcal{E}_P$$
.

Here, $\mathscr{A} \otimes \mathscr{C}_P$ denotes the product σ -field on $\Omega \times H = E$. Thus, \mathscr{C}_P is a σ -field on E for each P and \mathscr{C} is a field. We will denote (E,\mathscr{C}) by $(\Omega,\mathscr{A}) \odot (H,\mathscr{C})$. (E,\mathscr{C}) will be called a quasicylindrical measurable space.

DEFINITION. A quasicylinder probability measure β on (E, \mathscr{E}) is a finitely additive positive measure on (E, \mathscr{E}) with $\beta(E) = 1$ such that for all $P \in \mathscr{P}$, β_P , its restriction to \mathscr{E}_P , is countably additive.

Dunford and Schwartz (1966) have given a definition of integration wrt finitely additive measures for a certain class of functions. We need to integrate a larger class of functions wrt β using the property that β_P is countably additive for each P. For this, we need the notion of a "representation" of a quasicylinder probability measure, which is defined below.

DEFINITION. A representation of a quasicylinder probability measure β is a triplet $(\rho, L, \vec{\Pi})$, where $\vec{\Pi}$ is a countably additive probability measure on a measurable space $(\vec{\Omega}, \vec{\mathscr{A}})$, ρ is a measurable mapping from $(\vec{\Omega}, \vec{\mathscr{A}})$ into (Ω, \mathscr{A}) , and L is a mapping from H into the space of real-valued Borel-measurable functions on $(\vec{\Omega}, \vec{\mathscr{A}})$ such that for all $A \in \mathscr{A}$ and for all $C \in \mathscr{C}$,

$$(3.1) \quad \beta(A \times C) = \tilde{\Pi} \{ \tilde{\omega} : \rho(\tilde{\omega}) \in A, (L(h_1)(\tilde{\omega}), \dots, L(h_i)(\tilde{\omega})) \in B \},$$

where $C \in \mathscr{C}$ is given by

(3.2)
$$C = \{h \in H: ((hh_1), ..., (h, h_j)) \in B\}$$

for $h_i \in H$ and a Borel set B in \mathbb{R}^j .

REMARK 3.1. If $(\rho, L, \vec{\Pi})$ is a representation of a quasicylinder probability measure β , then it can be easily seen that

(3.3)
$$L(a_1h_1 + a_2h_2) = a_1L(h_1) + a_2L(h_2), \quad \bar{\Pi}$$
-a.e.

for all $h_i \in H$, $a_i \in R$, i = 1, 2. Indeed, take $h_3 = a_1 h_1 + a_2 h_2$ and $B = \{(x_1, x_2, x_3) \in R^3: x_3 = a_1 x_1 + a_2 x_2\}$. Let C be defined by (3.2) with j = 3 and let $A = \Omega$. Then, $\beta(A \times C) = \beta(E) = \bar{\Pi}(\bar{\Omega})$ and by (3.1),

$$\tilde{\Pi}(\tilde{\Omega}) = \tilde{\Pi}\{\tilde{\omega} : L(a_1h_1 + a_2h_2)(\tilde{\omega}) = a_1L(h_1)(\tilde{\omega}) + a_2L(h_2)(\tilde{\omega})\}.$$

Also, if a priori, it is known that L satisfies (3.3) then in order to show that $(\rho, L, \tilde{\Pi})$ is a representation of β , it suffices to verify (3.1)-(3.2) for j = 1. To see this, first observe that (3.1) is equivalent to

(3.4)
$$\int_{E} 1_{A}(\omega) \exp\left(i \sum_{k=1}^{j} \alpha_{k}(h, h_{k})\right) d\beta_{P}(\omega, h) \\ = \int_{\tilde{\Omega} \times \rho^{-1}(A)} 1(\tilde{\omega}) \exp\left(i \sum_{k=1}^{j} \alpha_{k} L(h_{k})(\tilde{\omega})\right) d\tilde{\Pi}(\tilde{\omega})$$

for all $A \in \mathscr{A}$, $h_A \in H$, $a_A \in \mathbb{R}$, $j \geq 1$, where P is the orthogonal projection onto span $\{h_1, \dots, h_j\}$. [Observe that the integrand on the left-hand side of (3.4) is β_F measurable and since β_F is countably additive on \mathscr{E}_P , the integral is well defined.] If L satisfies (3.3), then clearly, (3.4) is equivalent to

(3.5)
$$\int_{E} I_{A}(\omega) \exp(i(h, h_{0})) d\beta_{\rho}(\omega, h)$$

$$= \int_{\tilde{0}} I_{\rho^{-1}(A)}(\tilde{\omega}) \exp(iL(h_{0})(\tilde{\omega})) d\tilde{\Pi}(\tilde{\omega})$$

for all $A \in \mathcal{A}$ and $h_0 \in H$, P being the projection onto the linear span of h_0 , which in turn is equivalent to (3.1)-(3.2) for j=1.

Before we proceed, we remark that the following result, stated here without proof, guarantees the existence of a representation of β for a large class of quasicylinder measures.

THEOREM 3.1. Let β be a quasicylinder probability measure on (E, \mathcal{E}) . Assume that there exists a probability measure Π on (Ω, \mathcal{A}) and a mapping $\lambda: \Omega \times \mathcal{C} \to \mathbb{R}^+$ such that

- (i) For all $C \in \mathscr{C}$, $\omega \to \lambda(\omega, C)$ is A-measurable.
- (ii) For all $\omega \in \Omega$, $C \to \lambda(\omega, C)$ is a cylinder probability measure on (H, \mathscr{C}) .
- (iii) For $A \in \mathcal{A}$, $C \in \mathcal{C}$.

(3.6)
$$\beta(A \times C) = \int_{\Omega} 1_A(\omega) \lambda(\omega, C) d\Pi(\omega).$$

Then a representation of β exists.

REMARK 3.2. Given λ, Π satisfying (i), (ii) (in Theorem 3.1), the formula

$$\beta(F) = \int_{\Gamma} \lambda(\omega, F^{\omega}) d\Pi(\omega), \qquad F \in \mathscr{E},$$

where $F^{\omega} = \{h \in H: (\omega, h) \in F\}$, defines a quasicylinder probability measure on (E, \mathscr{E}) .

If \mathscr{A} is countably generated, then it can be shown that a representation exists for any quasicylinder probability measure β on $(\Omega, \mathscr{A}) \odot (H, \mathscr{C})$.

For the remaining part of this section, we will consider a fixed quasicylinder probability measure β on $(E, \mathscr{E}) = (\Omega, \mathscr{A}) \odot (H, \mathscr{E})$. We will assume throughout that a representation of β exists and $(\rho, L, \hat{\Pi})$ will denote a (fixed) representation of

Let S be a complete separable metric space with a distance function d. Let $\mathscr{L}(\hat{\Omega}, \vec{\mathscr{A}}, \hat{\Pi}; S)$ denote the space of S-valued $(\vec{\mathscr{A}}, \mathscr{B}(S))$ -measurable functions X on $\hat{\Omega}$, where two such mappings X_1, X_2 are equivalent if $X_1 = X_2$ a.e. $\hat{\Pi}$. For $X_1, X_2 \in \mathscr{L}(\hat{\Omega}, \vec{\mathscr{A}}, \hat{\Pi}; S)$, let $d^*(X_1, X_2)$ be defined by

$$d^{\bullet}(X_1, X_2) = \int [d(X_1(\tilde{\omega}), X_2(\tilde{\omega}))] \wedge ld\tilde{\Pi}(\tilde{\omega}).$$

Then, it is well known that d^* is a metric on $\mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi}; S)$ and $d^*(X_n, X) \to 0$ if and only if $X_n \to X$ in $\tilde{\Pi}$ probability. Also, $\mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi}; S)$ is a complete metric space under the metric d^* . This can be checked using the completeness of S under d. We will denote $\mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi}; \mathbb{R})$ by $\mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi})$.

DEFINITION. A function $f: E \rightarrow S$ is called a (S-valued) cylinder function if it can be written as

(3.7)
$$f(\omega, h) = f_1(\omega, (h, h_1), \dots, (h, h_j))$$

for some $h_1, \ldots, h_j \in H$ and some measurable function $f_1: (\Omega \times \mathbb{R}^j, \mathscr{A} \oplus \mathscr{B}(\mathbb{R}^j)) \to (S, \mathscr{B}(S))$.

It can be verified that f is a cylinder function if and only if for some $P \in \mathcal{P}$,

$$(3.8) f^{-1}(\mathcal{B}(S)) \subseteq \mathcal{E}_p.$$

For a cylinder function f given by (3.7), define $R_g(f) \in \mathcal{L}(\tilde{\Omega}, \bar{\mathcal{A}}, \tilde{\Pi}; S)$ by

(3.9)
$$R_{\theta}(f) = f_1(\rho, L(h_1), \dots, L(h_i)).$$

If (Ω', \mathscr{A}') is a measurable space, then Ω' -valued cylinder functions f and $R_{\mathcal{B}}(f)$ for such an f can be defined as above by replacing $(S, \mathscr{B}(S))$ by (Ω', \mathscr{A}') .

LEMMA 3.2. Let f be an S-valued cylinder function. Then

- (i) R_p(f) is unambiguously defined by (3.7) and (3.9) as an element of L(Ω, x̄, Π; S);
- (ii) if $P \in \mathcal{P}$ is such that (3.8) holds, then

(3.10)
$$\tilde{\Pi}[R_{\theta}(f)]^{-1} = \beta_{P}[f]^{-1}.$$

We now extend the mapping R_{β} to a larger class of functions for which a useful theory of integration can be developed.

Define a partial order on $\mathscr P$ by $P_1 < P_2$ if range $P_1 \subseteq \operatorname{range} P_2$. It is easy to see that $(\mathscr P, <)$ is a directed set. (We also write $P_2 > P_1$).

DEFINITION. Let $\mathscr{L}(E,\mathscr{E},\beta;S)$ be the class of functions f from E into S such that for all $P\in\mathscr{P}$, f_P defined by

$$(3.11) f_P(\omega, h) = f(\omega, Ph)$$

is $(\mathscr{E}_p,\mathscr{B}(S))$ -measurable and the net $\{R_p(f_p)\colon P\in\mathscr{P}\}$ is d*-Cauchy (i.e., Cauchy in Π probability). For such an f, let

(3.12)
$$R_{\beta}(f) = \lim_{R \to R} \text{ in } \overline{\Pi} \text{ probability } R_{\beta}(f_P).$$

The following lemma shows that the class $\mathscr{L}(E, \mathscr{E}, \beta; S)$ does not depend upon the choice of the representation.

LEMMA 3.3. Let (p', L', Π') be another representation of β and let R'_{θ} be the map defined by (3.9) for cylinder functions. Let $f \colon E \to S$ be such that for all $P \in \mathcal{P}$, f_{P} [defined by (3.11)] is $(\mathcal{E}_{P}, \mathcal{B}(S))$ -measurable. Then

- (i) (R_p(f_p): P∈ P) is Cauchy in Π measure if and only if (R'_p(f_p): P∈ P) is Cauchy in Π' measure.
- (ii) If (i) holds, then denoting the limit of $R'_{B}(f_{P})$ by $R'_{B}(f)$, we have

(3.13)
$$\tilde{\Pi} \left[R_{\mathbf{A}}(f) \right]^{-1} = \Pi' \left[R'_{\mathbf{A}}(f) \right]^{-1}.$$

The proof is omitted.

Elements of $\mathcal{L}(E, \mathcal{E}, \beta; S)$ will be called S-valued β -measurable functions and the mapping R_{β} defined by (3.12), R_{β} : $\mathcal{L}(E, \mathcal{E}, \beta; S) \rightarrow \mathcal{L}(\tilde{\Omega}, \tilde{\mathcal{A}}, \tilde{\Pi}; S)$ will be called the β -lifting corresponding to $(\rho, L, \tilde{\Pi})$.

Clearly, $\mathscr{L}(E,\mathscr{E},\beta;S)$ contains S-valued cylinder functions. For, if f satisfies (3.8) with $P \in \mathscr{P}$, then for all P' > P, $P' \in \mathscr{P}$, $f_P = f$ and $R_\beta(f_P) = R_\beta(f)$. This also shows that (3.12) holds for cylinder functions and hence the definition (3.12) of $R_\beta(f)$ for a cylinder function f does not contradict the previous definition (3.9).

An equivalent description of the class $\mathcal{L}(E, \mathscr{E}, \beta; S)$ which avoids the use of nets is given by the following result:

LEMMA 3.4. Let $f: E \to S$ be such that for each $P \in \mathcal{P}$, f_P defined by (3.11) is $(\mathcal{E}_P, \mathcal{B}(S))$ -measurable. Then, f belongs to $\mathcal{L}(E, \mathcal{E}, \beta; S)$ if and only if

(3.14) there exists
$$\{P_k\} \subseteq \mathcal{P}, P_k \uparrow I$$
, such that for all $\{P_k'\} \subseteq \mathcal{P}, P_k \neq P_k \text{ for all } k \geq 1, \{R_\beta(f_{P_k})\} \text{ is a } d \cdot \text{-Cauchy sequence.}$

Further, if (3.14) holds, then for all $\{P'_k\} \subseteq \mathcal{P}, P'_k > P_k \ \forall k \geq 1$,

(3.15)
$$R_{\beta}(f) = \lim_{n \to \infty} \inf \operatorname{In} \operatorname{In-probability} R_{\beta}(f_{P_{\alpha}}).$$

PROOF. Suppose $f \in \mathcal{L}(E,\mathscr{E},\beta;S)$. For each $k \geq 1$, get $\check{P}_k \in \mathscr{P}$ such that for all $P, P' \in \mathscr{P}, P > \check{P}_k, P' > \check{P}_k$

$$(3.16) d \cdot (R_{\beta}(f_{P}), R_{\beta}(f_{P})) < \frac{1}{k}.$$

Choose a sequence $\{P_k\}\subseteq \mathcal{P}, P_k\uparrow I$ such that $P_k>\tilde{P}_k$ for all k. Then (3.14) holds for this choice of $\{P_k\}$.

For the other part, suppose (3.14) holds. Completeness of $\mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi}; S)$ under the metric d^{\bullet} and the usual interlacing argument gives the existence of $Z \in \mathscr{L}(\tilde{\Omega}, \mathscr{A}, \tilde{\Pi}; S)$ such that for all $\{P'_k\} \subseteq \mathscr{P}, P'_k > P_k \ \forall k \geq 1$,

(3.17)
$$R_s(f_{Pl}) \rightarrow Z$$
 in $\tilde{\Pi}$ measure.

We now show that (3.17) implies that the net $\{R_{\beta}(f_P): P \in \mathcal{P}\}$ converges to Z in Π probability. Suppose $\{R_{\beta}(f_P)\}$ does not converge to Z. Then there exists an

 $\epsilon > 0$ such that for all $P \in \mathcal{P}$, there exists a $P' \in \mathcal{P}$, P' > P, with

$$(3.18) d \bullet (R_{\delta}(f_{P'}), Z) \geq \varepsilon.$$

Now, for each $k \ge 1$, choose $P_k' \in P$, $P_k' > P_k$ such that (3.18) holds for $P' = P_{k'}$. Then $d^*(R_\beta(f_{P_k'}), Z) \ge \epsilon$ for all k. This contradicts (3.17). Thus, $f \in \mathcal{L}(E, \mathcal{S}, \beta; S)$ and (3.15) holds. \square

The next result lists some properties of the mapping R_s .

THEOREM 3.5.

- (i) Let S = R. Then the space L(E, ℓ, β; R) is a linear space and is closed under pointwise multiplication of functions and the mapping R_β: L(E, ℓ, β; R) → L(Ω, A, Π; R) is linear and multiplicative. Also, if a ≤ f ≤ b, then Π(a ≤ R_β(f) ≤ b) = 1.
- (ii) For each k, let S_k be a complete separable metric space and let S = X[∞]_{k-1}S_k be the product of S_ks with the product topology. S itself is a complete separable metric space (under a suitable metric). Suppose f_k ∈ L(E, S, β; S_k) for k ≥ 1. Let f: E → S be defined by

$$f(\omega, h) = (f_1(\omega, h), \dots, f_k(\omega, h), \dots), (\omega, h) \in E.$$

Then $f \in \mathcal{L}(E, \mathcal{E}, \beta; S)$ and further

$$R_{\beta}(f) = (R_{\beta}(f_1), \ldots, R_{\beta}(f_k), \ldots).$$

(iii) Let S₁, S₂ be complete separable metric spaces and let U ∈ ℛ(S₁). Let g be a continuous function from U into S₂. Suppose f ∈ ℒ(E, ℰ, β; S₁) is such that (rangef) ⊆ U and Π(R_g(f) ∉ U) = 0. Then g ∘ f ∈ ℒ(E, ℰ, β; S₂) and

$$(3.19) R_{\beta}(g \circ f) = g(R_{\beta}(f)).$$

Also, if $f \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; S_1)$ then $g \circ f \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; S_2)$.

PROOF. (i) and (ii) follow from the definition of the mapping R_{β} and the properties of convergence in probability on countably additive measure spaces. For (iii), first observe that for $P \in \mathcal{P}$, $(g \circ f)_P$ [defined by (3.11)] is equal to $g \circ f_P$ and hence

$$(3.20) R_{\beta}((g \circ f)_{P}) = R_{\beta}(g \circ f_{P})$$

$$= g(R_{\beta}(f_{P})).$$

Now, $\tilde{\Pi}(R_{\beta}(f) \notin U) = 0$, continuity of g from U into S_2 , and the fact that $R_{\beta}(f_P) \to R_{\beta}(f)$ in $\tilde{\Pi}$ probability implies that $R_{\beta}((g \circ f)_P) \to g(R_{\beta}(f))$ in $\tilde{\Pi}$ probability. This proves (iii). \square

We will now define $ff d\beta$ for a suitable class of functions f. The motivation for this definition is that the distribution of $R_{\beta}f$ under $\tilde{\Pi}$ can be considered as the "distribution of f under β ."

DEFINITION. Let

$$\mathcal{L}^1(E,\mathcal{E},\beta) = \left\{ f \in \mathcal{L}(E,\mathcal{E},\beta;\mathbb{R}) \colon \int_{\mathbb{R}} |R_{\beta}(f)| \, d\tilde{\Pi} < \infty \right\}$$

and for $f \in \mathcal{L}^1(E, \mathcal{E}, \beta)$, define

$$\int_{E} f \, d\beta = \int_{\tilde{D}} R_{\beta}(f) \, d\tilde{\Pi}.$$

In view of Lemma 3.3, the class $\mathcal{L}^1(E, \mathcal{E}, \beta)$ and the value of the integral $\iint d\beta$ for $f \in \mathcal{L}^1(E, \mathcal{E}, \beta)$ do not depend on the particular choice of the representation $(a, L, \vec{\Pi})$.

The definitions given above subsume the definition of integration wrt a cylinder measure n on $(H, \mathscr C)$. In fact, take Ω to be a singleton $\{\omega\}$ and let $\lambda(\omega, \cdot) = n$. Then, we can identify $\{E, \mathscr C, \beta\}$ with $(H, \mathscr C, n)$ in the obvious way. Thus, all the notions defined on $(E, \mathscr C, \beta)$ have a similar meaning on $(H, \mathscr C, n)$. If β is as above and $(\rho, L, \hat{\Pi})$ is a representation of β , then since Ω is a singleton, ρ is constant and we will call $(L, \hat{\Pi})$ itself a representation of β (or n).

We will now introduce subclasses of $\mathcal{L}(E, \mathcal{E}, \beta; S)$ and $\mathcal{L}^1(E, \mathcal{E}, \beta)$. The elements of these subclasses satisfy a stronger approximation property.

Let $\mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; S)$ be the class of functions f from E to S such that for all $P \in \mathcal{P}$, f_P defined by (3.11) is $(\mathcal{E}_P, \mathcal{R}(S))$ -measurable and for all sequences $\{P_k\} \subset \mathcal{P}$, converging strongly to the identity (written as $P_k \stackrel{\bullet}{\to} I$), $R(f \circ P_k)$ is Cauchy in Π probability. In view of the Lemma 3.4,

(3.21)
$$\mathscr{L}^{\bullet}(E, \mathscr{E}, \beta, S) \subseteq \mathscr{L}(E, \mathscr{E}, \beta; S)$$

and for $f \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; S)$,

$$R_{\mathcal{B}}(f \circ P_{k}) \to R_{\mathcal{B}}(f)$$
 in $\tilde{\Pi}$ -probability

for all $P_h \xrightarrow{\pi} I$, $\{P_h\} \subseteq \mathcal{P}$. Let

$$\mathcal{L}^{1\bullet}(E, \mathcal{E}, \beta) = \left\{ f \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; \mathbb{R}) : \forall \{P_h\} \subseteq \mathcal{P}, P_h \stackrel{\circ}{\to} I, \right.$$
$$\int_{\mathbb{R}} |R_{\beta}(f_{P_h}) - R_{\beta}(f)| d\tilde{\Pi} \to 0 \right\}.$$

Again, it is easy to see that

$$(3.22) \mathscr{L}^{1\bullet}(E,\mathscr{E},\beta) \subseteq \mathscr{L}^{1}(E,\mathscr{E},\beta).$$

The most commonly used definition of absolute continuity for finitely additive measures is the following: Let μ_1, μ_2 be finitely additive measures on (D, \mathcal{P}) , where \mathcal{P} is a field on D. Then μ_1 is said to be absolutely continuous wrt μ_2 if given $\epsilon > 0$, there exists $\delta > 0$ a.t. for $A \in \mathcal{P}$, $\mu_2(A) < \delta$ implies $\mu_1(A) < \epsilon$. However, this does not imply the existence of Radon-Nikodym derivative. We can only assert the following: Given any $\epsilon > 0$, there exists a simple function f, a.t. $|\mu_1(A) - \int_A \int_{\epsilon} d\mu_2| < \epsilon$ for all $A \in \mathcal{P}$. This is known as Bochner's theorem and

 f_{ϵ} is known as an ϵ -derivative of μ_1 wrt μ_2 . [See Dunford-Schwartz (1958).] The notion of ϵ -derivative is not suitable for statistical purposes, namely for defining likelihood ratios or conditional expectation.

Balakriahnan has used this ϵ - δ definition in the context of cylinder measures. Again, in his setup, absolute continuity does not imply existence of a Radon-Nikodym derivative.

Gross's notion of a Radon-Nikodym derivative for cylinder measures is also unsuitable for statistical purposes, for roughly speaking, his Radon-Nikodym derivative is a measurable function on the representation space.

We will use a stronger notion of absolute continuity—one in which the existence of Radon-Nikodym derivative is built into the definition.

Let β , β , be quasicylinder probability measures on (E, \mathcal{E}) .

DEFINITION. β_1 is absolutely continuous wit β (written as $\beta_1 \ll \beta$) if there exists a nonnegative function $f \in \mathcal{L}^1(E, \mathscr{E}, \beta)$ such that for all $F \in \mathscr{E}$

$$\beta_1(F) = \int_F 1_F \cdot f \, d\beta.$$

Further, f is defined to be the Radon-Nikodym derivative of β_1 wrt β and will also be written as $d\beta_1/d\beta$.

The following theorem gives some of the properties of the Radon-Nikodym derivative in our setup.

THEOREM 3.6. Let β_1 and β_2 be quasicylinder probability measures on (E, \mathcal{E}) , such that $\beta_i \ll \beta$, i = 1, 2.

(i) If $a_1, a_2 \in \mathbb{R}^+$, then $(a_1\beta_1 + a_2\beta_2) \ll \beta$ and

$$\frac{d(a_1\beta_1 + a_2\beta_2)}{d\beta} = a_1 \frac{d\beta_1}{d\beta} + a_2 \frac{d\beta_2}{d\beta}.$$

- (ii) If $g \in \mathcal{L}(E, \mathscr{E}, \beta; S)$, then $g \in \mathcal{L}(E, \mathscr{E}, \beta; S)$ and $R_{\beta_i}(g) = R_{\beta}(g)$. Further, if $g \in \mathcal{L}^{\bullet}(E, \mathscr{E}, \beta; S)$, then $g \in \mathcal{L}^{\bullet}(E, \mathscr{E}, \beta; S)$.
- (iii) Suppose $g \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \beta; \mathbb{R})$. Then
- (3.25) $g \in \mathcal{L}^1(E, \mathcal{E}, \beta_1)$ if and only if $g \cdot (d\beta_1/d\beta) \in \mathcal{L}^1(E, \mathcal{E}, \beta)$.

Further, if $g \in \mathcal{L}^1(E, \mathcal{E}, \beta_1)$, then

(3.26)
$$\int_{\mathcal{E}} \mathbf{g} \cdot \frac{d\beta_1}{d\beta} \cdot d\beta = \int \mathbf{g} \cdot d\beta_1.$$

(iv) If $d\beta_1/d\beta > 0$ and $R_8(d\beta_1/d\beta) > 0$ a.s. $\vec{\Pi}$, then $\beta \ll \beta_1$ and

$$\frac{d\beta}{d\beta_1} = \left[\frac{d\beta_1}{d\beta}\right]^{-1}.$$

PROOF. (i) follows easily from the definition. For the remaining parts, let $\chi = R_g(d\beta_1/d\beta)$ and let Π' be the measure on $(\tilde{\Omega},\tilde{\mathscr{A}}')$ defined by

(3.28)
$$\Pi'(\tilde{A}) = \int_{\tilde{A}} R_{\beta} \left(\frac{d\beta_1}{d\beta} \right) d\tilde{\Pi}, \quad \text{for } \tilde{A} \in \tilde{\mathscr{A}}.$$

Now let $A \in \mathcal{A}$, and let $C \in \mathcal{C}$ be given by (3.2). Let

$$\tilde{A} = \{ \tilde{\omega} \in \tilde{\Omega} : \rho(\tilde{\omega}) \in A, (L(h_1)(\tilde{\omega}), ..., L(h_j)(\tilde{\omega})) \in B \}.$$

[Recall that $(\rho, L, \tilde{\Pi})$ is a (fixed) representation of β .] Then,

$$(3.29) 1_{\lambda} = R_{\theta}(1_{A \times C})$$

and hence

(3.30)
$$\Pi'(\bar{A}) \simeq \int_{\bar{A}} R_{\beta} \left(\frac{d\beta_{1}}{d\beta} \right) d\bar{\Pi}$$

$$= \int_{\bar{\Omega}} R_{\beta} (1_{A \times C}) \cdot R_{\beta} \left(\frac{d\beta_{1}}{d\beta} \right) \cdot d\bar{\Pi}$$

$$= \int_{\bar{E}} 1_{A \times C} \cdot \frac{d\beta_{1}}{d\beta} \cdot d\beta$$

$$= \beta_{1} (A \times C).$$

Thus, (ρ, L, Π') is a representation of β_1 . Let R_{β_1} be the β_1 -lifting corresponding to (ρ, L, Π') . Then, it follows from the definitions of R_{β} , R_{β_1} that for a cylinder function f,

$$(3.31) R_{\theta}(f) = R_{\theta}(f).$$

Since $\Pi' \ll \tilde{\Pi}$, convergence in $\tilde{\Pi}$ -measure for a sequence implies convergence in $\tilde{\Pi}$ -measure for the same sequence. This observation along with (3.31) and Lemma 3.4 implies (ii). For (iii), $R_{g_i}(g) = R_{g_i}(g)$ by (ii) and then $R_{g_i}(g) \in \mathbb{Z}$ $\mathbb{Z}^1(\tilde{\Omega}, \vec{\mathscr{A}}, \tilde{\Pi}')$ if and only if $R_{g_i}(g) \cdot X \in \mathcal{L}^1(\tilde{\Omega}, \vec{\mathscr{A}}, \tilde{\Pi})$ which is the same as (3.25). Also

$$\int_{\tilde{\Omega}} R_{\beta_i}(g) \, d\Pi' = \int_{\tilde{\Omega}} R_{\beta}(g) \cdot R_{\beta} \left(\frac{d\beta_i}{d\beta} \right) \cdot d\tilde{\Pi},$$

which is the same as (3.26). For (iv), let $g_1 = [d\beta_1/d\beta]^{-1}$. Since $R_\beta(d\beta_1/d\beta) > 0$ a.s. $\tilde{\Pi}$, (iii) in Theorem 3.5 (with $S_1 = \mathbb{R}$ and $U = (0, \infty)$, $S_2 = (0, \infty)$ and g(x) = 1/x) implies that

$$R_{\beta}(g_1) = \left[R_{\beta} \left(\frac{d\beta_1}{d\beta} \right) \right]^{-1}$$

Thus, for $F \in \mathcal{S}$, taking $f = 1_F \cdot g_1$ and applying (iii) above, we get

$$\int f \cdot \frac{d\beta_1}{d\beta} \cdot d\beta = \int f \cdot d\beta_1,$$

which is the same as

$$\int 1_F d\beta = \int 1_F g_1 d\beta_1.$$

Since $F \in \mathcal{S}$ is arbitrary, this proves (iv). \square

We will later define conditional expectation on the quasicylindrical probability space (E, \mathcal{E}, β) given a quasicylindrical mapping.

Let $(E', \mathscr{E}') = (\Omega', \mathscr{A}') \odot (H', \mathscr{E}')$ be another quasicylindrical measurable space, where (Ω', \mathscr{A}') is a measurable space, H' is a real separable Hilbert space with inner product $(\cdot, \cdot)'$, and $\mathscr{E}' = \mathscr{C}(H')$. Let $\mathscr{P}' = \mathscr{P}(H')$ and for $P' \in \mathscr{P}'$, let

$$\mathscr{C}_{P'} = \{(P')^{-1}B: B \text{ a Borel set in range } P'\}$$

and as before, $\mathscr{E}'_{P} = \mathscr{A}' \otimes \mathscr{E}'_{P}$.

DEFINITION. A quasicylindrical mapping from (E,\mathscr{E}) into (E',\mathscr{E}') is a mapping $\phi\colon E\to E'$ such that for all $P'\in\mathscr{P}'$, there exists a $P\in\mathscr{P}$ for which

$$\phi^{-1}(\mathscr{E}_{p'}) \subseteq \mathscr{E}_{p}.$$

LEMMA 3.7. Let ϕ be a quasicylindrical mapping from (E, \mathscr{E}, β) into (E', \mathscr{E}') . Then, the set function β' defined by

$$\beta'(F') = \beta(\phi^{-1}F'), \qquad F' \in \mathscr{E}'$$

defines a quasicylinder probability measure on (E', \mathscr{E}') .

PROOF. Let $P' \in \mathscr{P}'$ and let $\beta'_{P'}$ be the restriction of β' to $\mathscr{E}'_{P'}$. Get $P \in \mathscr{P}$ such that (3.32) holds. Then, clearly

$$\beta_{P}' = \beta_{0} \lceil \phi \rceil^{-1}$$

and hence β'_{P} is countably additive on \mathscr{E}'_{P} . \square

The quasicylinder measure β' is the measure induced by the quasicylindrical mapping ϕ and will also be denoted by $\beta[\phi]^{-1}$. Let $\phi = (\phi_1, \phi_2)$ where $\phi_1 \colon E \to \Omega'$ and $\phi_2 \colon E \to H'$. The following lemma, stated without proof, gives a representation $R_{\beta'}$ of β' closely related to $R_{\beta'}$.

LEMMA 3.8. Let $h' \in H'$. Then $(\phi_2, h')'$ and ϕ_1 are cylindrical functions. Let ρ' , L' be defined by

$$\rho' - R_{\theta}(\phi_1)$$

and

$$L'(h') = R_{\beta}[(\phi_2, h')'],$$

 $h' \in H'$. Then $(\rho', L', \overline{\Pi})$ is a representation of β' . $(\rho', L', \overline{\Pi})$ will be called the representation of β' induced by the mapping ϕ . Further, for any (S-valued)

Olinder function g on (E', &').

$$(3.35) R_{\beta'}(g) = R_{\beta}(g \circ \phi).$$

REMARK 3.3. It is important to observe that (3.35) may not hold for all g belonging to $\mathcal{L}(E', \mathscr{E}', \beta'; S)$. It seems so because the families $\{g_P: P' \in \mathscr{P}'\}$ and $\{(g \circ \phi)_P: P \in \mathscr{P}\}$ are not comparable.

In view of this, we consider the following class. Let ϕ be a quasicylindrical mapping from (E, \mathcal{E}, β) into (E', \mathcal{E}') . Let

As observed earlier in (3.35), $\Psi(\phi)$ contains cylinder functions.

We are now ready to define conditional expectation of a function $f \in \mathcal{L}^1(E, \mathcal{S}, \beta)$ with respect to a quasicylindrical mapping ϕ .

DEFINITION. If there exists a function $g \in \mathcal{U}(\phi)$ and $g \circ \phi \in \mathcal{L}^1(E, \mathscr{E}, \beta)$ such that for all $F' \in \mathscr{E}'$,

(3.36)
$$\int_{F} f 1_{F'}(\phi) d\beta = \int_{F} g \circ \phi \cdot 1_{F'}(\phi) d\beta,$$

then we define $g \circ \phi$ to be the conditional expectation of f given ϕ and write it as (3.37) $E_g(f|\phi) = g \circ \phi.$

REMARK 3.4. We have not asserted the existence of a function g satisfying (3.36). Also, in view of the requirement $g \in \Psi(\phi)$ (3.36) is equivalent to

(3.38)
$$\int_{\mathcal{C}} 1_{F'}(\phi) d\beta = \int_{\mathcal{C}} g 1_{F'} d\beta', \quad \text{for all } F' \in \mathscr{E}'.$$

In our earlier papers, we had used (3.38) as the definition of conditional expectation without requiring that $g \in \mathcal{U}(\phi)$.

The following theorem shows that the conditional expectation defined above has the usual properties.

THEOREM 3.9. Let ϕ be a quasicylindrical mapping from (E, \mathcal{E}, β) and let $\beta' = \beta \phi^{-1}$. Let $f, f_1, f_2 \in \mathcal{L}^1(E, \mathcal{E}, \beta)$ be such that $E_{\beta}(f|\phi)$ and $E_{\beta}(f_i|\phi)$, i = 1, 2 exist. Then

- (i) For $a_1, a_2 \in \mathbb{R}$, $E_8(a_1/1 + a_2/2|\phi)$ exists and
- (3.39) $E(a_1 f_1 + a_2 f_2 | \phi) = a_1 E_8(f_1 | \phi) + a_2 E_8(f_2 | \phi).$
- (ii) Let $g \in \mathcal{U}(\phi)$ be such that $f \cdot g(\phi) \in \mathcal{L}^1(E, \mathcal{E}, \beta)$. Then $[E_{\beta}(f|\phi)] \cdot g(\phi) \in \mathcal{L}^1(E, \mathcal{E}, \beta)$ and

(3.40)
$$\int_{E} f \cdot g(\phi) d\beta = \int_{E} E_{\beta}(f|\phi) \cdot g(\phi) d\beta.$$

(iii) If
$$(f)^2 \in \mathcal{L}^1(E, \mathcal{E}, \beta)$$
, then $[E_{\beta}(f|\phi)]^2 \in \mathcal{L}^1(E, \mathcal{E}, \beta)$.

(iv) If
$$(f)^2 \in \mathcal{L}^1(E, \mathcal{E}, \beta)$$
, then

(3.41)
$$\int_{\mathcal{E}} \left[f - E_{\beta}(f|\phi) \right]^2 d\beta = \min_{g \in \Phi(\phi)} \int_{\mathcal{E}} \left[f - g(\phi) \right]^2 d\beta.$$

PROOF. (i) Let $g_i = E_\beta(f_i|\phi)$, i = 1, 2. Then linearity of R_β , R_β . [Theorem 3.5(i)] implies that $a_1g_1 + a_2g_2 \in \Psi(\phi)$. Also, for $F' \in \mathscr{E}'$,

$$\begin{split} \int_{E} 1_{F'}(\phi) \cdot \left[a_{1} g_{1}(\phi) + a_{2} g_{2}(\phi) \right] d\beta &= a_{1} \int_{E} 1_{F'}(\phi) g_{1}(\phi) d\beta + a_{2} \int_{E} 1_{F'}(\phi) g_{2}(\phi) d\beta \\ &= a_{1} \int_{E} 1_{F'}(\phi) f_{1} d\beta + a_{2} \int_{E} 1_{F'}(\phi) f_{2} d\beta \\ &= \int_{E} 1_{F'}(\phi) \cdot \left[a_{1} f_{1} + a_{2} f_{2} \right] d\beta \end{split}$$

and hence (3.39) holds.

Let \mathscr{D}_{\bullet} be the σ field on $\tilde{\Omega}$ generated by the family $\mathscr{F} = \{A \in \mathscr{A}: 1_A = R_{\beta}(1_{F'}(\phi)) \text{ for some } F' \in \mathscr{E}'\}$ augmented by $\tilde{\Pi}$ null sets. Since \mathscr{E}' is a field and the mapping R_{β} is linear and multiplicative on $\mathscr{L}(E, \mathscr{E}, \beta; \mathbb{R})$, \mathscr{F} is a field and hence from the definition of conditional expectation, for all $D \in \mathscr{D}_{\bullet}$,

(3.42)
$$\int_{D} R_{\beta}(f) d\tilde{\Pi} = \int_{D} R_{\beta} \left[E_{\beta}(f|\phi) \right] d\tilde{\Pi}.$$

We will show first that $g \in \mathcal{U}(\phi)$ implies that $R_{\theta}(g(\phi))$ is \mathcal{D}_{ϕ} -measurable.

If g is a bounded real-valued cylinder function on (E', \mathscr{E}') , say $g^{-1}(\mathscr{E}'_P) \subseteq \mathscr{B}(\mathbb{R}^1)$, then g can be uniformly approximated by \mathscr{E}'_P -measurable simple functions g_k . Since $R_{\beta'}(g_k) = R_{\beta}(g_k \circ \phi)$, and g_k is a \mathscr{E}'_P -measurable simple function it follows that $R_{\beta'}(g_k)$ is \mathscr{D}_{\bullet} -measurable. Now $g_k \to g$ uniformly and hence (see Theorem 3.5) $R_{\beta'}(g_k)$ converges to $R_{\beta'}(g)$ in $\tilde{\Pi}$ -probability and hence $R_{\beta'}(g)$ is \mathscr{D}_{\bullet} -measurable. Let g be any cylinder function. Let τ_k : $\mathbb{R} \to \mathbb{R}$ be defined by $\tau_k(x) = x$ if $-k \le x \le k$ and $\tau_k(x) = (\operatorname{sgn} x) \cdot k$ if $|x| \ge k$. Then

$$R_{\beta'}(\tau_k(g)) = \tau_k(R_{\beta'}(g))$$

and hence $R_{\beta'}(\tau_{\mathbf{A}}(g))$ converges to $R_{\beta'}(g)$. Thus $R_{\beta'}(g)$ is \mathscr{D}_{\bullet} -measurable.

Now, let $g \in \mathscr{U}(\phi)$ be arbitrary. Then, get $P'_k \in \mathscr{P}'$ such that $R_{\beta'}(g_{P'_k})$ converges to $R_{\beta'}(g)$ in Π -probability. Since $R_{\beta'}(g_{P'_k})$ is \mathscr{D}_{ϕ} -measurable for all $k \geq 1$, it follows that $R_{\beta}(g)$ is \mathscr{D}_{ϕ} -measurable. Since $g \in \mathscr{U}(\phi)$, $R_{\beta}(g(\phi)) = R_{\beta'}(g)$. Thus, for any $g \in \mathscr{U}(\phi)$, $R_{\beta}(g(\phi))$ is \mathscr{D}_{ϕ} -measurable. Now, (3.42) implies that

$$(3.43) E_{fi}(R_{\beta}(f)|\mathcal{D}_{\bullet}) = R_{\beta}(E_{\beta}(f|\Phi)).$$

Now (ii), (iii), and (iv) follow from (3.43), the observation that $R_g(g(\phi))$ is \mathcal{D}_{ϕ} -measurable for all $g \in \mathcal{U}(\phi)$ and the standard properties of conditional expectation in the countably additive theory. \square

4. The abstract statistical model and the Bayes formula. We begin by recalling the definition of the canonical Gauss measure m on (H, \mathscr{C}) [see Gross (1962)]. Fix $P \in \mathscr{P}$. Let dimension (range P) be k and let $\{e_1, e_2, \ldots, e_k\}$ be an orthonormal (ON) besis for range P. For $C \in \mathscr{C}_P$ given by

(4.1)
$$C = \{h: (h, e_1), \dots, (h, e_k) \in B\}$$

for $B \in \mathcal{B}(\mathbb{R}^{k})$, define

(4.2)
$$m_p(C) = \left(\frac{1}{\sqrt{2\pi}}\right)^k \int_{\mathbb{R}^k} 1_{\sigma}(\underline{x}) \exp\left(-\frac{1}{2} \sum_{j=1}^k x_i^2\right) d\underline{x},$$

where d_X denotes integration wrt the Lebesgue measure on \mathbb{R}^k . Using the rotational invariance of the normal distribution or Gauss measure on finite-dimensional Euclidean spaces, it can be checked that m_P does not depend upon the choice of $\{e_1,\dots,e_k\}$ and that the family $\{m_P,P\in\mathcal{P}\}$ is consistent. Let m on (H,\mathscr{C}) be defined by $m=m_P$ on \mathscr{C}_P for $P\in\mathcal{P}$. Then by its construction, m is a (finitely additive) cylinder probability measure on (H,\mathscr{C}) . m is called the canonical Gauss measure on (H,\mathscr{C}) . The measure m is determined by its characteristic functional

Let $(\Omega, \mathscr{A}, \Pi)$ be a countably additive probability space and let $\{: (\Omega, \mathscr{A}, \Pi) \rightarrow (H, \mathscr{R}(H)) \text{ be a measurable mapping. Let } (E, \mathscr{B}) = (\Omega, \mathscr{A}) \odot (H, \mathscr{C}).$ For $P \in \mathscr{P}$, let α_P be the product of Π and m_P on $\mathscr{E}_P - \mathscr{A} \otimes \mathscr{C}_P$. Then, it is easy to see that $\{\alpha_P: P \in \mathscr{P}\}$ is a consistent family and determines a QCP α on (E, \mathscr{E}) such that $\alpha = \alpha_P$ on \mathscr{E}_P . Clearly, the conditions of Theorem 3.1 are satisfied with $\lambda(\omega, \cdot) = m$.

We shall be working henceforth with a particular representation of α constructed as follows: First let (L_0, Π_1) be a representation of m whose existence and special properties are assured by the following result.

THEOREM 4.1. There exists a representation (L_0,Π_1) where Π_1 is a probability measure on (Ω_1,\mathscr{A}_1) of m s.t. the mapping $(\omega_1,h)\to L_0(h)(\omega_1)$ is measurable wrt $\mathscr{A}_1\otimes \mathscr{B}(H)$. Further, if $\{e_j\}$ is any complete orthonormal basis (CONS) of H, then

(4.4)
$$L_0(h) = \sum_{j=1}^{\infty} L_0(e_j)(h, e_j), \quad \Pi_1 \text{-}a.s.$$

Now taking $(\tilde{\Omega}, \tilde{\mathscr{A}}, \tilde{\Pi}) = (\Omega, \mathscr{A}, \Pi) \otimes (\Omega_1, \mathscr{A}_1, \Pi_1)$, define $\rho(\tilde{\omega}) = \omega$ and $L(h\chi\tilde{\omega}) = L_0(h\chi\omega_1)$ for $\tilde{\omega} = (\omega, \omega_1)$. Then $(\rho, L, \tilde{\Pi})$ is the desired representation of α . It is easy to see that (4.4) implies

(4.5)
$$L(h)(\tilde{\omega}) = \sum_{j=1}^{\infty} L(e_j)(\tilde{\omega}) \cdot (h, e_j), \quad \tilde{\Pi}\text{-}a.s.$$

Let e be the identity mapping on H. Considered as a mapping from (H, \mathcal{C}, m) into (H, \mathcal{C}) , e will be called Gaussian white noise.

Abstract statistical model. We will adopt the usual convention of regarding a function defined on either H or Ω as defined on E itself. With this convention, let $y: E \to H$ be defined by

$$(4.6) y = \xi + e$$

so that for $(\omega, h) \in H$, $y(\omega, h) = \xi(\omega) + e(h) = \xi(\omega) + h$.

We shall call (4.6) the abstract statistical model. It is the prototype of the filtering model to be considered in Section 5. It is convenient to list below the problems that need to be resolved before a satisfactory theory can emerge:

- (1) Is it possible to speak of the distribution of the "observation" y in the abstract model (4.6)? In other words, define the induced measure $n = \alpha[Y]^{-1}$ or, more generally, the induced measure $\alpha[Qy]^{-1}$, where Q is an arbitrary orthogonal projection on H. In view of the work of the previous section, this can be achieved by showing that y (resp. Qy) is a QCM from (E, \mathscr{E}, α) into (H, \mathscr{E}) [resp. into (H, \mathscr{E}) where H' = QH and $\mathscr{E}' = \mathscr{C}(H')$].
- (2) To show that n is absolutely continuous wrt m and to evaluate the Radon-Nikodym (R-N) derivative dn/dm.
- (3) For an integrable function g on $(\Omega, \mathscr{A}, \Pi)$ considered as a function on (E, \mathscr{A}, α) and for an orthogonal projection Q on H, show that the conditional expectation $E_{\alpha}(g|Qy)$ exists and obtain a formula for it. The latter is the Bayes formula which is the basic statistical tool in our theory and is the finitely additive analogue of the formula obtained by Kallianpur and Striebel (1968) in the stochastic calculus treatment of the filtering problem.

Before we can settle these questions we need several preparatory results. Of these, Theorems 4.2 and 4.4 are concerned with mixtures of translates of the canonical Gauss measure m on (H, \mathscr{C}) and their R-N derivatives wrt m.

Let $\mathcal{I}(H)$ be the class of real-valued functions f on H of the form

(4.7)
$$f(h) = \int_{H} \exp((h, k) - \frac{1}{2}|k|^2) d\nu(k), \quad h \in H$$

for some $\nu \in \mathscr{M}_0(H)$ where $\mathscr{M}_0(H)$ is the class of countably additive probability measures on $(H, \mathscr{B}(H))$. Since $(h, k) - \frac{1}{2}|k|^2 \le |h|^2$, the integral in (4.7) exists for each $h \in H$.

THEOREM 4.2.

- (i) $\mathscr{I}(H) \subseteq \mathscr{L}^{1*}(H,\mathscr{C},m)$.
- (ii) If $f \in \mathcal{I}(H)$ is given by (4.7), then

(4.8)
$$R_m(f) = \int_{U} \exp(L_0(k) - \frac{1}{2}|k|^2) d\nu(k).$$

PROOF. Fix $\{P_i\} \subseteq \mathscr{P}, P_i \stackrel{*}{\to} I$. Recall that (L_0, Π_1) is a fixed representation of m, so that under Π_1 , $L_0(k)$ is a normal random variable with mean zero and variance $|k|^2$. Also, if $k_1 \perp k_2$, then $L_0(k_1)$ and $L_0(k_2)$ are independent. Now, for

a fixed i, if (e_1, e_2, \dots, e_i) is a basis of range P_i ,

$$\begin{split} f_{P_i}(h) &= f(P_i h) \\ &= \int_H \exp((P_i h, k) - \frac{1}{2} |k|^2) \, d\nu(k) \\ &= \int \exp\left(\sum_{r=1}^{j} (h, e_r) (k, e_r) - \frac{1}{2} |k|^2\right) d\nu(k) \end{split}$$

and hence by the definition of the m-lifting R_m for cylinder functions

(4.9)
$$R_{m}(f_{P_{r}})(\omega_{1}) = \int \exp \left(\sum_{r=1}^{r} L_{0}(e_{r})(\omega_{1})(k, e_{r}) - \frac{1}{2}|k|^{2} \right) dr(k) \\ = \int \exp \left(L_{0}(P_{r}k)(\omega_{1}) - \frac{1}{2}|k|^{2} \right) dr(k), \quad \Pi \cdot a.s.$$

as $P_i k = \sum_{r=1}^{j} e_r(k, e_r)$ and L_0 satisfies (3.3).

$$(4.10) V(\omega_1) = \int \exp(L_0(k)(\omega_1) - \frac{1}{2}|k|^2) d\nu(k).$$

Since $(k, \omega_1) \to L_0(k)(\omega_1)$ is $\mathcal{B}(H) \otimes \mathcal{A}_1$ -measurable, the integral in (4.10) is well defined. To complete the proof, we will show that $R_m(f_{\rho_1}) \to V$ in $\mathscr{L}'(\Omega_1, \mathscr{A}_1, \Pi_1)$. Let

(4.11)
$$U_i = \int_{\Omega} \int_{H} \left| \exp\left(L_0(P_i k) - \frac{1}{2} |k|^2\right) - \exp\left(L_0(k) - \frac{1}{2} |k|^2\right) \right| d\nu(k) d\Pi_1$$

Then clearly

$$\int_{\Omega} |R_{m}(f_{P_{i}}) - V| d\Pi_{1} \leq U_{i}$$

and thus it suffices to show that $U_i \to 0$. Let P_i^{\perp} be the orthogonal complement of P_i . Then since $k = P_i k + P_i^{\perp} k$, we have, using (3.3)

$$L_0(k) = L_0(P_i k) + L_0(P_i^{\perp} k).$$

This and Fubini's theorem imply that

$$U_{i} = \int_{\mathcal{H}} \left[\int_{\Omega_{i}} \exp\left(L_{0}(P_{i}k) - \frac{1}{2} |P_{i}k|^{2} \right) \exp\left(-\frac{1}{2} |P_{i}^{\perp}k|^{2} \right) \right. \\ \left. \cdot \left| 1 - \exp\left(L_{0}(P_{i}^{\perp}k) \right) \right| d\Pi_{1} \right] d\nu.$$

As observed earlier, under Π_1 , for fixed k, $L_0(P_ik)$ and $L_0(P_i^+k)$ are independent and further, $\int_{\Omega} \exp(L_0(P_ik) - \frac{1}{2}|P_ik|^2) d\Pi_1 = 1$. Thus,

$$(4.12) U_i = \int_H \int_{\Omega} \exp(-\frac{1}{2}|P_i^{\perp}k|^2) |1 - \exp(L_0(P_i^{\perp}k))| d\Pi_1 d\nu.$$

For $\varepsilon > 0$, let

$$\delta(\varepsilon) = \frac{1}{\sqrt{2\pi}} \int_{\mathbb{R}} |1 - \exp(\varepsilon x)| \exp\left(-\frac{1}{2} |x|^2\right) dx.$$

Then, $\delta(\epsilon) \to 0$ as $\epsilon \to 0$ and $\delta(\epsilon) \le 1 + e^{\epsilon^2/2}$. Also, under Π_1 , the distribution of $L_0(P_i^{\perp}k)$ is normal with mean zero and variance $|P_i^{\perp}k|^2$. Hence

$$\int_{\Omega} \left| 1 - \exp\left(L_0(P_i^{\perp} k) \right) \right| d\Pi_1 = \delta(|P_i^{\perp} k|).$$

From (4.12) we then have

(4.13)
$$U_{i} = \int_{U} \exp(-\frac{1}{2}|P_{i}^{\perp}k|^{2})\delta(|P_{i}^{\perp}k|) d\nu(k).$$

As $\delta(|P_i^\perp k|) \le 1 + \exp(\frac{1}{2}|P_i^\perp k|^2)$, the integrand in (4.13) is dominated by 2. Since $P_i \to I$, $|P_i^\perp k| \to 0$ for all $k \in H$ the integrand in (4.13) goes to zero for all $k \in H$. Since ν is a finite measure, the dominated convergence theorem implies (4.14) $U_i \to 0.$

For $C \in \mathscr{C}$ and $h \in H$, let $C - h \subseteq H$ be defined by $C - h = \{h_0 : h_0 + h \in C\}.$

If $C \in \mathscr{C}_P$ is given by $C = P^{-1}B$, $B \in \mathscr{B}(\text{range } P)$, then

(4.15)
$$C - h = \{h_0: h_0 + h \in C\}$$
$$= \{h_0: Ph_0 + Ph \in B\}$$
$$= \{h_0: h_0 \in P^{-1}(B - Ph)\}$$

and hence

$$(4.16) C - h \in \mathscr{C}_{P}.$$

Also, (4.15) implies that for $C \in \mathscr{C}_p$,

$$(4.17) C-h=C-Ph.$$

LEMMA 4.3. Let $h \in H$ and let m' be defined by

$$(4.18) m'(C) = m(C - h), for C \in \mathscr{C}.$$

Then m' is a cylinder measure and m' ≪ m with

(4.19)
$$\frac{dm'}{dm}(k) = \exp((h,k) - \frac{1}{2}|h|^2).$$

REMARK 4.1. From the properties of Gaussian measures on finite-dimensional linear spaces, it also follows that for $C \in \mathscr{C}_{\rho}$, the mapping

$$h' \rightarrow m_P(C - h')$$

from range P into R is continuous and thus for all $C \in \mathscr{C}$, the mapping

$$h \rightarrow m(C-h)$$

is continuous from H into R. In particular, $h \to m(C - h)$ is $\mathcal{B}(H)$ -measurable.

THEOREM 4.4. Let $\mu \in \mathcal{M}(H)$.

(i) The set function n: V → R defined by

(4.20)
$$m^{\mu}(C) = \int_{C} m(C - h) d\mu(h)$$

is a cylinder measure on (H, C).

(ii) m" ≪ m and

(4.21)
$$\frac{dm''}{dm}(h) = \int_{H} \exp((h, h) - \frac{1}{2}|h|^2) d\mu(h).$$

- (iii) $\mathcal{J}(H) \subseteq \mathcal{L}^{\bullet}(H, \mathcal{C}, m^*)$.
- (iv) There exists a representation (L', W) of m" [W is a probability measure on (Ω', A')] such that
- $(4.22) \qquad (h,\omega') \to L'(h)(\omega') \quad \text{is } \mathscr{A}' \otimes \mathscr{A}(H) \cdot measurable.$
- (v) If (L', Π') is any representation of n satisfying (4.22), and R'_m, is the corresponding m*-lifting then for f ∈ F(H) given by (4.8), we have

(4.23)
$$R'_{m^*}(f)(\omega') = \int_{H} \exp(L'(k)(\omega') - \frac{1}{2}|k|^2) d\nu(k).$$

We now return to the abstract statistical model (4.6) and the questions raised at the beginning of this section.

Let Q be an orthogonal projection on H. Let H' be the range of Q. H' itself is a Hilbert space with the inner product $(\cdot, \cdot)'$, which is the restriction of (\cdot, \cdot) to $H' \times H'$. Let C' = C(H') and $\mathscr{P}' = \mathscr{P}(H')$.

Lemma 4.5. $Q: H \rightarrow H'$ is a quasicylindrical mapping and the induced measure $m[Q]^{-1}$ is the canonical Gauss measure m' on H'.

The first two questions posed at the beginning of the section are answered by the following result:

THEOREM 4.6.

- (i) Qy is a quasicylindrical mapping from (E, 8, a) into (11', 6').
- (ii) Let n' = a[Qy] 1. Then n' ≪ m' and

(4.24)
$$\frac{dh'}{dm'}(h') = \int_{\Omega} \exp((h', Q\xi(\omega)) - \frac{1}{2}|Q\xi(\omega)|^2) d\Pi(\omega), \quad h' \in H$$

In particular, if $n = \alpha[y]^{-1}$, then $n \ll m$ and

$$(4.25) \qquad \frac{dn}{dm}(h) = \int_{0}^{\infty} \exp\left((h, \xi(\omega)) - \frac{1}{2} |\xi(\omega)^{2}|\right) d\Pi(\omega), \qquad h \in H$$

PROOF. Let $C_1 \in \mathscr{C}_{P_1} \subseteq \mathscr{C}'$, for $P_1 \in \mathscr{P}'$ be given by

$$(4.26) C_1 = \{h': P_1h' \in B\}.$$

 $B \in \mathcal{B}(\text{range } P_1)$. Then $P = P_1Q \in \mathcal{P}$ and

$$D = \{(\omega, h) : Qy(\omega, h) \in C_1\}$$

$$= \{(\omega, h) : Py(\omega, h) \in B\}$$

$$= \{(\omega, h) : P\xi(\omega) + Ph \in B\}$$

$$\in \mathscr{E}_P.$$

Thus, $Q_{\mathcal{P}}$ is a QCM from (E, \mathscr{E}, α) into (H', \mathscr{E}') . Now, recall that α_{P} , which is the restriction of α to \mathscr{E}_{P} , is countably additive and is equal to $\Pi \otimes m_{P}$. Thus, using Fubini's theorem, we have from the definition of n',

$$n'(C_1) = \alpha(D)$$

$$= \alpha_P(D)$$

$$= \int_{\Omega} m_P(h: Ph + P\xi(\omega) \in B) d\Pi(\omega)$$

$$= \int_{\Omega} m(h: Qh + Q\xi(\omega) \in P_1^{-1}B) d\Pi(\omega) \quad \text{as } P = P_1Q$$

$$= \int_{\Omega} m'(h': h' + Q\xi(\omega) \in C_1) d\Pi(\omega)$$

$$\text{as } m' = m[Q]^{-1}, C_1 = P_1^{-1}B$$

$$= \int_{\Omega} m'(C_1 - Q\xi(\omega)) d\Pi(\omega).$$

Thus, if $\mu \in \mathcal{M}(H')$ is given by $\mu = \Pi[Q\xi]^{-1}$, then

(4.29)
$$n'(C_1) = \int_{\mu'} m'(C_1 - k) d\mu(k)$$

and now (4.24) follows from Theorem 4.4. Of course, (4.25) is a special case of (4.24). \Box

REMARK 4.2. Let $C_1 \in \mathscr{C}'$. Then

(4.30)
$$n(Q^{-1}C_1) = \alpha((\omega, h): \xi(\omega) + h \in Q^{-1}C_1)$$
$$= \alpha((\omega, h): Q\xi(\omega) + Qh \in C_1)$$
$$= n'(C_1).$$

Thus,

$$(4.31) n' = n[Q]^{-1}.$$

LEMMA 4.7. Let g: $H' \rightarrow S$ and let

$$(4.32) g_1(h) = g(Qh), h \in H.$$

Then

(i)
$$g_1 \in \mathcal{L}^{\bullet}(H, \mathcal{C}, m; S) \Rightarrow g \in \mathcal{U}(Q) = \mathcal{U}(H, \mathcal{C}, m; S, Q)$$

(ii)
$$g_1 \in \mathcal{L}^{\bullet}(H, \mathcal{C}, n; S) \rightarrow g \in \mathcal{L}(Q) = \mathcal{L}(H, \mathcal{C}, n; S, Q)$$

(iii)
$$g_1 \in \mathcal{L}^{\bullet}(H, \mathscr{C}, n; S)$$
 and $g_1 \in \mathscr{U}(y) - \mathscr{U}(E, \mathscr{C}, \alpha; S, y) \rightarrow g \in \mathscr{U}(Qy) - \mathscr{U}(E, \mathscr{C}, \alpha; S, Qy)$.

THEOREM 4.8. Let $g \in \mathcal{J}(H')$. Then

$$g \in \mathcal{U}(Qy) = \mathcal{U}(E, \mathcal{S}, \alpha; Qy, \mathbb{R})$$

and

$$g(Qy) \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \alpha; \mathbf{R}).$$

We are now in a position to prove the main result, which answers the last question raised at the beginning of this section.

THEOREM 4.9 (Bayes formula). Let g be an integrable function on $(\Omega, \mathscr{A}, \Pi)$. Then, $E_{*}(g|Q_{Y})$ exists and

$$(4.33) E_{\mathfrak{g}}(g|Qy) = \frac{\sigma_{Q}(g,Qy)}{\sigma_{Q}(l,Qy)},$$

where for $h' \in H'$.

(4.34)
$$\sigma_Q(g, h') = \int_Q g(\omega) \exp[(h', Q\xi(\omega)) - \frac{1}{2}|Q\xi(\omega)|^2] d\Pi(\omega)$$

and

$$\sigma_{Q}(1,h) = \int_{0} \exp((h',Q\xi(\omega)) - \frac{1}{2}|Q\xi(\omega)|^{2}) d\Pi(\omega).$$

PROOF. Because of the linearity of $E_s(\cdot|Qr)$ (Theorem 3.8) it suffices to prove (4.33) for positive g such that $\int g \, d\Pi = 1$. For $C_1 \in \mathscr{C}'$, let

$$\phi_{\mathbf{g}}(C_1) = \int_{\mathcal{Q}} \mathbf{g}(\omega) 1_{C_1}(Q_{\mathbf{y}}(\omega, h)) d\alpha(\omega, h).$$

We will first show that

$$(4.36) \qquad \qquad \phi_{\mathbf{g}}(C_1) = \int_{\mathcal{C}} \mathbf{g}(\omega) m'(C_1 - Q\xi(\omega)) d\Pi(\omega).$$

The proof of (4.36) follows the proof of (4.28) in Theorem 4.6. If C_1 is given by (4.26) for $P_1 \in \mathcal{P}'$ and $P = P_1Q$, then

$$\begin{aligned} \phi_{g}(C_{1}) &= \int_{\mathcal{E}} g(\omega) 1_{C_{1}}(Qy(\omega, h)) d\alpha(\omega, h) \\ &= \int_{\mathcal{E}} g(\omega) 1_{B}(P\xi(\omega) + Ph) d\alpha_{P}(\omega, h) \\ &= \int_{\Omega} g(\omega) [m_{P}(h: Ph + P\xi(\omega) \in B)] d\Pi(\omega) \\ &= \int_{\Omega} g(\omega) m'(C_{1} - Q\xi(\omega)) d\Pi(\omega). \end{aligned}$$

Hence, if $\mu' \in \mathcal{M}_0(H')$ is defined by

then from (4.36)

$$\phi_{\mathbf{g}}(C_1) = \int_{H'} m'(C_1 - k) \, d\mu'(k)$$

and thus by Theorem 4.4, ϕ_g is a cylinder probability measure on (H',\mathscr{C}') , $\phi_g \ll m'$, and

(4.39)
$$\frac{d\phi_{g}}{dm'}(h') = \int_{H} \exp((h',k) - \frac{1}{2}|k|^{2}) d\mu'(k)$$

$$= \int_{\Omega} g(\omega) \exp((h',Q\xi(\omega)) - \frac{1}{2}|Q\xi(\omega)|^{2}) d\Pi(\omega)$$

$$= \sigma_{Q}(g,h').$$

Also, as observed in Theorem 4.6 [Equation (4.24)],

$$\frac{dn'}{dm'}(h) = \sigma_{Q}(1, h').$$

Also, Theorem 4.2 implies that $R_{m'}(dn'/dm') > 0$ a.s. Thus, by Theorem 3.6(iv), $\phi_g \ll n'$ and

(4.41)
$$\frac{d\phi_g}{dn'}(h') = \frac{\sigma_Q(g,h')}{\sigma_Q(1,h')}$$

and hence

(4.42)
$$\phi_g(C_1) = \int_{H'} 1_{C_1}(h') \frac{\sigma_Q(g, h')}{\sigma_Q(1, h')} dn'(h').$$

By Theorem 4.8, $\sigma_Q(g,\cdot)$ and $\sigma_Q(1,\cdot)$ belong to $\mathscr{U}(Qy)$. Since $R_{\pi'}(\sigma_Q(1,\cdot)>0$ a.s., $R_{\pi'}(\sigma_Q(1,\cdot)>0$ a.s. Hence

$$\frac{\sigma_{\mathbb{Q}}(g,\cdot)}{\sigma_{\mathbb{Q}}(1,\cdot)} \in \mathscr{U}(\mathbb{Q}y).$$

(4.42) and (4.43) imply that for $C_1 \in \mathscr{C}'$,

(4.44)
$$\phi_g(C_1) = \int_E 1_{C_1}(Qy) \frac{\sigma_Q(g,Qy)}{\sigma_Q(l,Qy)} d\alpha.$$

Now, (4.35), (4.43), and (4.44) imply that $E_a(g|Qy) = [\sigma_Q(g,Qy)]/[\sigma_Q(1,Qy)]$.

5. Equations for the optimal filter: \mathbb{R}^d -valued Markov signal process. In this section we formulate and solve the nonlinear filtering problem when the signal process $X = (X_i)$ is an \mathbb{R}^d -valued Markov process wrt a family (\mathscr{A}_i) given on a countably additive probability space $(\Omega_i,\mathscr{A}_i, \Pi_i)$. It is assumed that (X_i)

admits a transition probability function and that the paths X_i are progressively measurable wrt (\mathscr{A}_i) , but (X_i) will not be restricted to be time homogeneous. Let $m \geq 1$ be an integer and let $h: [0,T] \times \mathbb{R}^d \to \mathbb{R}^m$ be Borel-measurable such that

(5.1)
$$\int_0^T |h_t(X_t)|^2 dt < \infty, \quad \Pi\text{-a.s.}$$

Here and in what follows, $|\cdot|$ denotes the norm on \mathbb{R}^m and, generally on any Euclidean space.

It is necessary first, to recast the abstract nonlinear filtering model and the Bayes formula in a form which explicitly brings into focus the role played by the parameter t. Let

$$H = \{ \eta = (\eta^1, \eta^2, \dots \eta^m) \colon [0, T] \to R^m, |\eta| \in L^2[0, T] \}.$$

Then H is a real separable Hilbert space with the inner product

(5.2)
$$(\eta, \bar{\eta}) = \int_0^T \sum_{i=1}^m \eta_i' \bar{\eta}_i' dt$$

and norm $\|\eta\| = (\eta, \eta)^{1/2}$. Let $\xi_s(\omega) = h_s(X_s(\omega)), 0 \le s \le T$. In view of (5.1), for Π almost all ω , we have $\xi(\omega) \colon [0,T] \to \mathbb{R}^m$ with $|\xi(\omega)| \in L^2[0,T]$ so that $\xi(\omega) \in H$. Since no loss of generality is involved we will assume that these relations hold for all ω . The progressive measurability of (X_s) and the conditions on h imply that the map $\omega \to \xi(\omega)$ is $(\mathscr{A}, \mathscr{B}(H))$ -measurable, where $\mathscr{B}(H)$ is the σ -field of Borel sets in H.

Let (E, \mathscr{E}, α) be the quasicylindrical probability space constructed in Section 3. The abstract statistical model (4.6)

$$y = \xi + e$$

now takes the form

$$(5.3) y_s = h_s(X_s) + e_s, 0 \le s \le T,$$

where $e = (e_i)$ is the Gaussian white noise independent of the signal (X_i) and y_i is the observation process.

Let Q_t for $0 < t \le T$ denote the orthogonal projection on H with range

(5.4)
$$H_t = \left\{ \eta \in H: \int_t^T |\eta_s|^2 ds = 0 \right\}.$$

so that for $\eta \in H$,

$$(Q_t\eta)(s) = \eta(s),$$
 for $0 \le s \le t$,
= 0, for $t < s \le T$.

Then, Q,y represents the observation $(y_s; 0 \le s \le t)$ over the time interval [0,t]. Applying the Bayes formula Theorem 4.9 for $Q = Q_t$, we obtain the conditional expectation formula for an integrable function g on $(\Omega, \mathscr{A}, \Pi)$

$$(5.5) E_a(g|Q,y) = \frac{\bar{\sigma}_t(g,y)}{\bar{\sigma}_t(1,y)},$$

expectation formula for an integrable function g on $(\Omega, \mathcal{A}, \Pi)$

$$\tilde{\sigma}_{t}(f, \eta) = \int_{\Omega} f(\omega) \exp\left(\left(\eta, Q_{t}\xi(\omega)\right) - \frac{1}{2} \|Q_{t}\xi(\omega)\|^{2}\right) d\Pi(\omega)$$

$$= \int_{\Omega} f(\omega) \exp\left(\sum_{j=1}^{m} \int_{0}^{t} \eta_{s}^{j} h_{s}^{j}(X_{s}(\omega)) ds - \frac{1}{2} \int_{0}^{t} \left|h_{s}(X_{s}(\omega))\right|^{2} ds d\Pi(\omega)$$

For a Borel-measurable function $f \colon \mathbf{R}^d \to \mathbf{R}$, such that $f(X_t)$ is integrable, writing

(5.7)
$$\sigma_{\ell}(f,\eta) = \tilde{\sigma}_{\ell}(f(X_{\ell}),\eta)$$

we have

(5.8)
$$E_{\mathbf{a}}(f(X_t)|Q_t y) = \frac{\sigma_t(f, y)}{\sigma_t(1, y)}.$$

Thus, the family $(\sigma_t(f, \eta))$ determines the conditional distribution of X, given $\{y_i: 0 \le s \le t\}$.

We shall now derive an evolution equation for $\{\sigma_i(f,\eta)\}$. This is analogous to the Zakai equation in the usual nonlinear filtering theory.

Let $\mathscr L$ be the extended generator of X_t and let $\mathscr D$ be its domain. [See the Appendix for the definitions of $\mathscr L$ and $\mathscr D$. In the standard terminology, $\mathscr L$ is the generator of the $[0,\infty)\times \mathbf R^d$ -valued time homogeneous Markov process (t,X_t) and $\mathscr D$ is the domain of $\mathscr L$.] Let $\mathscr D_0$ be the class of functions f from $\mathbf R^d$ into $\mathbf R$ such that f_1 defined by

$$(5.9) f_1(s,x) = f(x), (s,x) \in [0,\infty) \times \mathbb{R}^d,$$

belongs to \mathcal{D} . For $f \in \mathcal{D}_0$, $0 \le t < \infty$, define \mathcal{L}_t by

$$(\mathfrak{L}_{f})(x) = (\mathfrak{L}_{f_{1}})(t, x),$$

where f_1 is given by (5.9). Observe that by Lemma A.1, for $f \in \mathcal{D}_0$,

(5.11)
$$\left\{ f(X_t) - \int_0^t (\mathcal{L}_{\bullet} f)(X_{\bullet}) ds, \mathcal{A}_t \right\} \text{ is a martingale.}$$

The following theorem gives the white noise version of the Zakai equation for the unnormalized conditional expectation $\sigma_i(f, y)$.

Theorem 5.1. Suppose that

$$(5.12) E \int_0^T |h_s(X_s)|^2 ds < \infty.$$

Then, for all $y \in H$ and for all $f \in \mathcal{D}_0$

(5.13)
$$\frac{d}{dt}\sigma_{t}(f, y) = \sigma_{t}(\mathcal{L}_{t}f, y) + \sum_{j=1}^{m} \sigma_{t}(h_{t}^{j}f, y)y_{t}^{j} - \frac{1}{2}\sigma_{t}(|h_{t}|^{2}f, y).$$
for a.e. t

PROOF. Let $q_t(\eta, \omega)$ for $\eta \in H$, $\omega \in \Omega$, and $0 < t < \infty$ be defined by

(6.14)
$$q_t(\eta,\omega) = \exp\left[\sum_{i=1}^m \int_0^t \eta_s^i h_s^j(X_s(\omega)) ds - \frac{1}{2} \int_0^t \left[h_s^j(X_s(\omega))\right]^2 ds\right].$$

Then, recall that [see (5.6), (5.7)]

(5.15)
$$\sigma_{t}(f, \eta) = \int_{\Omega} f(X_{t}(\omega)) q_{t}(\eta, \omega) d\Pi(\omega).$$

Since (X_s) is progressively measurable, $q_i(\eta, \cdot)$ is \mathscr{A}_i -measurable and hence we have for an integrable g_i

$$\tilde{\sigma}_{t}(g, \eta) = \tilde{\sigma}_{t}(E(g/\mathscr{A}_{t}), \eta).$$

Fix $f \in \mathcal{D}_0$ and $0 \le t \le T$. Let $g_t : \Omega \to R$ be defined by

$$g_t(\omega) = f(X_T(\omega)) - \int_s^T (\mathcal{L}_s f)(X_s(\omega)) ds.$$

Then (5.11) implies that $E(g_t|\mathscr{A}_t) = f(X_t)$ and hence in view of (5.16), we have (5.18) $\sigma_t(f,\eta) = \bar{\sigma}_t(g_t,\eta)$.

Now, clearly, for all $\omega \in \Omega$, $\eta \in H$, g_t, q_t are absolutely continuous functions of t and for a.e. t

(5.19)
$$\frac{d}{dt}g_t(\omega) = (\mathcal{L}_t f)(X_t(\omega)),$$
(5.20)
$$\frac{d}{dt}q_t(\eta,\omega) = \left[\sum_{i=1}^m h_t^i(X_t(\omega))\eta_t^i - \frac{1}{2}|h_t(X_t(\omega))|^2\right]q_t(\eta,\omega).$$

Hence, g_tq_t is also an absolutely continuous function of t and for all $\omega\in\Omega$, $\eta\in H$, and $0\leq t\leq T$, we have

$$(5.21) g_{s}(\omega)q_{s}(\eta,\omega) = g_{0}(\omega) + \int_{0}^{t} (\mathcal{L}_{s}f)(X_{s}(\omega))q_{s}(\eta,\omega) ds$$

$$+ \sum_{j=1}^{m} \int_{0}^{t} g_{s}(\omega)h_{s}^{j}(X_{s}(\omega))\eta_{s}^{j}q_{s}(\eta,\omega) ds$$

$$- \frac{1}{2} \int_{0}^{t} g_{s}(\omega)[h_{s}(X_{s}(\omega))]^{2}q_{s}(\eta,\omega) ds.$$

Recall that by the definition of $\mathscr L$ and $\mathscr D$, for $f \in \mathscr D_0$, $f, \mathscr L_f$ are bounded (uniformly in t) and hence g_i is also bounded (uniformly in t for $0 \le t \le T$). Integrating both sides in (5.21) wrt Π and using Fubini's theorem (which is justified as $\mathscr L_f$, $g_s(\omega)$ are uniformly bounded and h satisfies (5.12)] we get for $n \in H$ and $0 \le t \le T$.

$$\begin{split} \tilde{\sigma}_{t}(\boldsymbol{g}_{t}, \boldsymbol{\eta}) &= \int_{\Omega} \boldsymbol{g}_{0}(\omega) \, d \, \Pi(\omega) + \int_{0}^{t} \boldsymbol{\sigma}_{s}(\boldsymbol{\mathcal{L}}_{s}\boldsymbol{f}, \boldsymbol{\eta}) \, ds \\ &+ \sum_{j=1}^{m} \int_{0}^{t} \tilde{\boldsymbol{\sigma}}_{s}(\boldsymbol{g}_{s}\boldsymbol{h}_{s}^{j}(\boldsymbol{X}_{s})\boldsymbol{\eta}_{s}^{j}, \boldsymbol{\eta}) \, ds - \frac{1}{2} \int_{0}^{t} \tilde{\boldsymbol{\sigma}}_{s}(\boldsymbol{g}_{s}|\boldsymbol{h}_{s}(\boldsymbol{X}_{s})|^{2}, \boldsymbol{\eta}) \, ds. \end{split}$$

Also, $E(g_t|\mathcal{A}_t) = f(X_t)$ and (5.16) also imply

(5.23)
$$\tilde{\sigma}_{a}(g_{a}h_{a}^{j}(X_{a})\eta_{a}^{j},\eta) = \sigma_{a}(fh_{a}^{j}\eta_{a}^{j},\eta)$$

and

(5.24)
$$\tilde{\sigma}_s(g_s|h_s(X_s)|^2,\eta) = \sigma_s(f|h_s|^2,\eta).$$

From (5.18), (5.22), (5.23), and (5.24) it follows that

(5.25)
$$\sigma_{\epsilon}(f,\eta) = Eg_0 + \int_0^t \sigma_{\epsilon}(\mathcal{L}_{\epsilon}f,\eta) ds + \sum_{j=1}^m \int_0^t \sigma_{\epsilon}(fh_{\epsilon}^j\eta_{\epsilon}^j,\eta) ds - \frac{1}{2} \int_0^t \sigma_{\epsilon}(f|h_{\epsilon}|^2,\eta) ds.$$

Now (5.13) follows by differentiating (5.25) and substituting y for η . \Box

In the recent work on robust nonlinear filtering [e.g., Davis, (1979)] it is customary to use the Stratonovich form of the Zakai equation of the Itô theory and then to make the heuristic change from dY_i to $y_i dt$. The resulting equation is precisely Equation (5.13). We shall comment on this in greater detail later in Section 10.

For f such that $f(X_i)$ is integrable let us write

(5.26)
$$\Pi_{l}(f,\eta) = \frac{\sigma_{l}(f,\eta)}{\sigma_{l}(l,\eta)}$$

so that $\Pi_i(f, y)$ is the conditional expectation of $f(X_i)$ given $Q_i y$. Equation (5.13) yields the following equation for $\Pi_i(f, y)$ which is the analogue of the Fujisaki-Kallianpur-Kunita (FKK) equation in our white noise setup.

THEOREM 5.2. Let h satisfy (5.12). Then for all $y \in H$,

$$\frac{d}{dt}\Pi_{t}(f, y) = \Pi_{t}(\mathcal{L}_{t}f, y) + \sum_{j=1}^{m} \Pi_{t}(fh_{t}^{j}y_{t}^{j}, y) - \frac{1}{2}\Pi_{t}(f|h_{t}|^{2}, y)
-\Pi_{t}(f, y) \left[\sum_{j=1}^{m} \Pi_{t}(h_{t}^{j}y_{t}^{j}, y) - \frac{1}{2}\Pi_{t}(|h_{t}|^{2}, y) \right] \quad \text{for a.e. } t$$

PROOF. We have, using (5.26)

(5.28)
$$\frac{d}{dt}\Pi_{t}(f,\eta) = \frac{\left[(d/dt)\sigma_{t}(f,\eta)\right]\sigma_{t}(l,\eta) - \sigma_{t}(f,\eta)(d/dt)\sigma_{t}(l,\eta)}{\left[\sigma_{t}(l,\eta)\right]^{2}}.$$

Now, (5.27) follows from (5.13), (5.26), and the fact that $\mathcal{L}_{i}1 = 0$. \Box

For $0 \le t < \infty$ and $\eta \in H$, let $\Gamma_t(\eta, \cdot)$ and $F_t(\eta, \cdot)$ be measures on \mathbb{R}^d defined by

(5.29)
$$\Gamma_t(\eta, A) = \int_{\Omega} 1_A(X_t(\omega)) q_t(\eta, \omega) d\Pi(\omega)$$

and

$$(5.30) F_t(\eta, A) = F_t(\eta, A) [\Gamma_t(\eta, \mathbb{R}^m)]^{-1}, A \in \mathcal{B}(\mathbb{R}^d).$$

Then it follows by standard arguments that for f such that $E|f(X_t)| < \infty$,

(5.31)
$$\sigma_t(f, \eta) = \int_{\Omega} f(x) \Gamma_t(\eta, dx)$$

and

(5.32)
$$E_a(f(X_t)|Q,y) = \prod_i (f,y) = \int_{\Omega} f(x)F_i(y,dx).$$

Equations (5.13) and (5.27) are actually equations for the measures $\{\Gamma_i(\eta,\cdot)\}$ and $\{F_i(\eta,\cdot)\}$. Under stronger conditions on h, $\{\Gamma_j\}$, $\{F_j\}$ can be characterized as the unique solutions to (a slight modification of) equations (5.13) and (5.27). We will consider this problem in a more general (infinite-dimensional) context in Section 6. We specialize now to the case when X is a diffusion process (see the Appendix for the definition) so that the paths X_i are continuous. Moreover, $C_i^{1,2}(\{0, \infty) \times \mathbb{R}^d\} \subseteq \mathcal{P}$ and for $f \in C_i^{1,2}(\{0, \infty) \times \mathbb{R}^d\}$,

(5.33)
$$(\mathscr{L}_f)(t,x) = \left(\frac{\partial}{\partial t}f\right)(t,x) + (\mathscr{L}_i f)(t,x),$$

where

(5.34)
$$(\mathscr{L}_{i}f)(t,x) = \frac{1}{2} \sum_{i,j=1}^{d} a_{ij}(t,x) \left(\frac{\partial^{2}f}{\partial x^{i} \partial x^{j}} \right) (t,x) + \sum_{i=1}^{d} b_{i}(t,x) \left(\frac{\partial f}{\partial x^{i}} \right) (t,x).$$

The coefficients $a_{i,j}$, b_i are measurable functions from $\{0,\infty\} \times \mathbb{R}^d$ into \mathbb{R} , and the matrix $(a_{i,j}(t,x))$ is symmetric and nonnegative definite for each $(t,x) \in \{0,\infty\} \times \mathbb{R}^d$.

The following result shows that if the process (X_i) admits a density wrt the Lebesgue measure λ on \mathbb{R}^d , then the measures $\Gamma_i(\eta_i, \cdot)$ also admit a density $p_i(x, \eta)$ wrt λ (called the unnormalized conditional density) which is a (weak) solution of a second order parabolic differential equation.

THEOREM 5.3. Suppose that for each t, the distribution of X, is absolutely continuous wrt λ . Then for all $\eta \in H$, the measure $\Gamma_{\eta}(\eta, \cdot)$ admits a density $p_{\eta}(x, \eta)$ wrt λ . Further, for each $y \in H$, $p_{\eta}(x, \eta)$ is a weak solution of the PDE:

(5.35)
$$\frac{\partial}{\partial t} p_i(x, y) = \mathcal{L}_t^{\bullet} p_i(x, y) + \left(\sum_{i=1}^m h_i^i(x) y_i^i - \frac{1}{2} |h_i(x)|^2 \right) p_i(x, y).$$

REMARK 5.1. By a weak solution to (5.35) we mean that for all $f \in C_0^{\infty}(\mathbb{R}^d)$

$$\frac{\partial}{\partial t} \int_{\mathbb{R}} f(x) p_i(x, y) d\lambda = \int_{\mathbb{R}^d} \left[\mathcal{L}_i^{\bullet} p_i(x, y) \right] f(x) dx
+ \int_{\mathbb{R}^d} \left[\sum_{j=1}^m h_i^j(x) y_i^j - \frac{1}{2} |h_i(x)|^2 \right] p_i(x, y) f(x) dx.$$

PROOF. If $A \in B(\mathbb{R}^d)$ is such that $\lambda(A) = 0$, then by our hypothesis, $El_A(X_t) = 0$ and hence clearly [see (5.29)], $\Gamma_t(\eta, A) = 0$ for all $\eta \in H$. Thus, $\Gamma_t(\eta, \cdot)$ is absolutely continuous wrt λ and hence admits a (t, x)-measurable version of a density, say $p_t(x, \eta)$ wrt λ . Now (5.36) is the same as the equation (5.13). This completes the proof. \square

We now turn to the following questions:

- (1) Under what conditions on a, b, h does the PDE (5.35) admit a unique classical solution (unique within a class to be specified)?
- (2) Under what conditions is the unique solution obtained in (1) the unnormalized conditional density?

It should be noted that the second question is not trivial, for a priori, we can only say that the unnormalized conditional density is a weak solution of (5.35).

We present two results which show that the PDE (5.35) has a unique solution in a certain class, which is indeed the unnormalized conditional density. In both results, no assumption of boundedness of h is made. The first of these assumes merely that h is locally Hölder continuous and proves uniqueness for y in a dense subset of H. The following lemma shows that given $p_i(x, y)$ for y in a dense set in H, $\Gamma_i(x, y)$ can, in principle, be computed for all y in H.

LEMMA 5.4. If $\eta_j \to \eta$ in H, then $\Gamma_t(\eta_j, \cdot)$ converges to $\Gamma_t(\eta, \cdot)$ in the total variation norm.

PROOF. It is easy to see that for each $\omega \in \Omega$, $q_i(\eta_j, \omega) \to q_i(\eta, \omega)$ and further, $q_i(\eta_j, \omega)$ is uniformly bounded by $\sup_{j \in \mathbb{N}} (\frac{1}{2}||\eta_j||^2)$ finite as $\eta_j \to \eta$. This implies the required result. \square

THEOREM 5.5. Suppose that h: $[0,T] \times \mathbb{R}^d \to \mathbb{R}^m$ is a locally Hölder continuous function. Suppose that the diffusion and drift coefficients a and b of the signal process (X_t) satisfy

(5.37)
$$\sum_{i,j-1}^{d} a_{ij}(t,x)z_{i}z_{j} \geq K_{1} \sum_{i=1}^{d} z_{i}^{2}, \qquad K_{1} < \infty,$$

for all (t, x), for all $(z_1, \ldots, z_d) \in \mathbb{R}^d$;

(5.38)
$$a_{ij}$$
, $\frac{\partial}{\partial x^i}a_{ij}$, $\frac{\partial^2}{\partial x^i\partial x^j}a_{ij}$, b_i , $\frac{\partial}{\partial x^i}b_i$

are locally Hölder continuous functions satisfying the growth condition

$$|g(t,x)| \le K_2(1+|x|^2)^{1/2}$$

for some $K_2 < \infty$. Suppose that the distribution of X_0 has a continuous density ϕ satisfying for some $\varepsilon > 0$, $K_3 < \infty$,

$$|\phi(x)| \le \exp(K_1(1+|x|^2))^{\frac{1}{2}-r}.$$

Let $H_0 = \{ y \in H : y, \text{ is H\"older continuous} \}$. Then for all $y \in H_0$, the PDE

(5.41)
$$\frac{\partial p_{t}(x, y)}{\partial t} = \mathcal{L}_{t}^{*}p_{t}(x, y) + \left(\sum_{i=1}^{m} h_{i}^{i}(x)y_{i}^{j} - \frac{1}{2}|h_{t}(x)|^{2}\right)p_{t}(x, y),$$

with the initial condition

$$p_0(x, y) = \phi(x),$$

has a unique solution in the class \mathcal{G} , where \mathcal{G} is the class of $C^{1,2}([0,T]\times\mathbb{R}^d)$ functions g satisfying the growth condition

$$|g(t,x)| \le \exp(K_4(1+|x|^2)^{1/2})$$

for some $K_{+} < \infty$.

Furthermore, the unique solution $p_i(x, y)$ (for $y \in H_0$) is the unnormalized conditional density of X, given Q, y, i.e.,

(5.43)
$$\Gamma_{t}(y,B) = \int_{\mathbb{R}^{d}} 1_{B}(x) p_{t}(x,y) d\lambda(x)$$

for all $y \in H_0$ and for all $B \in \mathcal{B}(\mathbb{R}^d)$, or equivalently,

(5.43')
$$\sigma_t(f, y) = \int_{\mathbb{R}^d} f(x) p_t(x, y) d\lambda(x)$$

for every bounded, Borel function f from Rd to R.

PROOF. In Equation (5.41), \mathcal{L}_{l}^{*} is the formal adjoint of \mathcal{L}_{l} , so that,

$$(\mathcal{L}_{i}^{\bullet}g)(x) = \frac{1}{2} \sum_{i,j=1}^{d} a_{ij}(t,x) \left(\frac{\partial^{2}g}{\partial x^{i} \partial x^{j}} \right)(x) + \frac{1}{2} \sum_{i=1}^{d} b_{i}^{\bullet}(t,x) \left(\frac{\partial g}{\partial x^{i}} \right)(x) + c^{\bullet}(t,x)g(t,x),$$

where

$$b_i^{\bullet}(t,x) = -b_i(t,x) + \sum_{j=1}^d \frac{\partial a_{ij}}{\partial x^j}(t,x)$$

and

$$(5.46) c^{\bullet}(t,x) = -\sum_{i=1}^{d} \frac{\partial b_{i}(t,x)}{\partial x^{i}} + \frac{1}{2} \sum_{i,j=1}^{d} \frac{\partial^{2} a_{ij}(t,x)}{\partial x^{i} \partial x^{j}}.$$

It is easily seen that a, b^* satisfy (5.38) and c^* is a locally Hölder continuous function satisfying the growth condition (5.39).

Let $c(t, x, y) = \sum_{j=1}^{m} h_{j}^{j}(x)y_{j}^{j} - \frac{1}{2}|h_{j}(x)|^{2}$. Then, for $y \in H_{0}$ c(t, x, y) is a locally Hölder continuous function and

$$(5.47) c(t, x, y) \le \frac{1}{2} |y|^2 \le K$$

for some $K < \infty$ as y_t is continuous. For $y \in H_0$ fixed, let a differential operator $\bar{\mathscr{L}}$ be defined for $g \in C^{1,2}([0,T] \times \mathbb{R}^d)$ by

$$(5.48) \qquad (\bar{\mathscr{L}}g)(t,x) = (\mathscr{L}_t^*g)(t,x) + c(t,x,y)g(t,x) - \frac{\partial}{\partial t}g(t,x).$$

Taking $H(t,x)=\exp(K_5(1+|x|^2)^{1/2}e^{\beta t})$, it can be checked that $\bar{\mathscr{L}}(H)\leq 0$, $\bar{\mathscr{L}}^{\bullet}(H^{-1})\leq 0$ for suitable K_5 , β . [See Bodanko (1966) and Kallianpur-Karandikar (1984a).] Thus, by Theorems 1 and 3 in Besala (1979), $\bar{\mathscr{L}}$ admits a fundamental solution G(t,x,s,z) and

(5.50)
$$p_{t}(x, y) = \int_{\mathbb{R}^{d}} \phi(z) G(t, x, 0, z) d\lambda(z)$$

is a solution to $\bar{\mathcal{L}}u = 0$ with the initial condition $p_0(x, y) = \phi(x)$. That p_t defined by (5.50) is the unique solution to (5.41) follows from the results of Bodanko (1966).

The formal adjoint $\bar{\mathscr{L}}^{\bullet}$ of $\bar{\mathscr{L}}$ is easily seen to be

$$(\bar{\mathscr{L}}^{\bullet}g)(t,x) = (\mathscr{L}_{t}g)(t,x) + c(t,x,y)g(t,x) + \frac{\partial}{\partial t}g(t,x)$$
$$= \mathscr{L}g(t,x) + c(t,x,y)g(t,x).$$

Fix $f \in C_0^{\infty}(\mathbb{R}^d)$ and $0 < t_0 \le T$ and define $v(s, z), 0 \le s \le t_0, z \in \mathbb{R}^d$ by

(5.51)
$$v(s,z) = \int_{\mathbb{R}^d} f(x)G(t_0,x,s,z) d\lambda(z).$$

Then, by Theorem 2 in Besala (1979), v satisfies $\bar{\mathscr{L}}^*v=0$, i.e.,

(5.52)
$$\mathscr{L}v(t,x) + c(t,x,y)v(t,x) = 0, \quad 0 \le t < t_0, x \in \mathbb{R}^d$$
 with the boundary condition

$$v(t_0,x)=f(x).$$

By the estimates on G in Besala (1979), it follows that v is bounded and hence by the Feynman-Kac formula, Theorem A.3 (the conditions of Theorem A.3 are satisfied as v is bounded and c is bounded above)

(5.53)
$$v(0, X_0) = E_{\Pi} \left(f(X_{t_0}) \exp \left(\int_0^{t_0} c(t, X_t, y) dt \right) | \sigma(X_0) \right).$$

Thus

$$\int \phi(z)v(0,z) d\lambda(z) = E_{\Pi}v(0,X_0)$$

$$= E_{\Pi} \left(f(X_{t_0}) \exp\left(\int_0^{t_0} c(t,X_t,y) dt \right) \right)$$

$$= \sigma_{t_0}(f,y).$$

Using (5.40) and the estimates on G given in Bessla (1979) it follows that

$$\int_{\mathbb{R}^d} \int_{\mathbb{R}^d} |\phi(z)| |f(x)| G(t_0, x, 0, z) d\lambda(x) d\lambda(x) < \infty$$

and hence by Fubini's theorem, (5.50), (5.51), and (5.53), we have

$$\int_{\mathbb{R}^d} f(x) p_{i_0}(x, y) d\lambda(x) = \int_{\mathbb{R}^d} f(x) \int_{\mathbb{R}^d} \phi(x) G(t_0, x, 0, x) d\lambda(x) d\lambda(x)$$

$$= \int_{\mathbb{R}^d} \phi(x) \left[\int_{\mathbb{R}^d} f(x) G(t_0, x, 0, x) d\lambda(x) \right] d\lambda(x)$$

$$= \int_{\mathbb{R}^d} \phi(x) v(0, x) d\lambda(x)$$

$$= \sigma_L(f, y).$$

Since (5.55) holds for all $f \in C_0^\infty(\mathbb{R}^d)$, it follows (by the usual arguments) that (5.55) also holds for all bounded measurable functions. Hence, taking $f = 1_H$, we get (5.43). This completes the proof. \square

It is clear from Equation (5.41) that $[\partial p_i(x, y)]/\partial t$ cannot be continuous in t for all $y \in H$. Hence there can be no classical solution of (5.41) for every $y \in H$. However, in our next result we show the existence of a unique solution of (5.41) (for every $y \in H$) in a slightly weaker sense.

For reasons of convenience, we shall postpone the proof of parts (i) and (ii) of the following theorem to Section 8. Here, we only prove (iii).

Theorem 5.6. Suppose that the diffusion and drift coefficients a,b of the signal process (X_1) satisfy (5.37) and (5.38). Further suppose that the density ϕ of X_0 satisfies (5.40). For some suitable $\alpha>0$ let

$$E \exp(\alpha |X_0|^2) < \infty$$
,

and for all i, j, k, suppose

(5.56) a, is bounded;

$$(5.57) h^h, \frac{\partial h^h}{\partial x^i}, \frac{\partial^2 h^h}{\partial x^i \partial x^j}, \frac{\partial h^l}{\partial t}$$

are locally Hölder continuous in (t, x) and

(5.58)

$$h^{\lambda}$$
, $\frac{\partial h^{\lambda}}{\partial t}$, $\sum_{j} a_{ij} \frac{\partial h^{\lambda}}{\partial x^{i}}$, $\sum_{i,j} a_{ij} \left(\frac{\partial^{3} h^{\lambda}}{\partial x^{i} \partial x^{j}} + \frac{\partial h^{\lambda}}{\partial x^{i}} \cdot \frac{\partial h^{\lambda}}{\partial x^{j}} \right)$, $\sum_{i} b_{i} \frac{\partial h^{\lambda}}{\partial x^{i}}$

satisfy the growth condition (5.39). Then

(i) for every y ∈ H, there is a unique p_i(x, y) such that (5.41) is satisfied for a.e. t and

$$(5.59) p_i(x, y) \cdot \exp \left[- \sum_{i=1}^m h_i^i(x) \int_0^t y_i^i ds \right] \in \mathscr{F}.$$

- (ii) The mapping y → p_i(x, y) is continuous in the following sense: if y_n → y in
 H, then p(·, y_n) converges to p_i(·, y) uniformly on compact subsets of
 [0, T] × R^d.
- (iii) For all y ∈ H, the unique solution p_i(x, y) of (5.41) is the unnormalized conditional density, i.e., (5.43') holds for all y ∈ H and for all bounded measurable functions f from R^d to R.

PROOF. We will prove (i) and (ii) later. For (iii), observe that for $y \in H_0$, as proved in Theorem 5.4, for all $B \in \mathcal{B}(\mathbb{R}^d)$,

(5.60)
$$\Gamma_t(y,B) = \int_{\mathbf{D}^d} 1_B(x) p_t(x,y) d\lambda(x).$$

For $B \in \mathcal{B}(\mathbb{R}^d)$ bounded, by Lemma 5.4 and part (ii) above, both sides of (5.60) are continuous functions of y and hence the denseness of H_0 in H implies that (5.60) holds for all $y \in H$. The restriction that $B \in \mathcal{B}(\mathbb{R}^d)$ is bounded can be removed by the usual arguments. \square

REMARK 5.2. Note that $h(x) = x^3$ (the cubic sensor) satisfies the conditions of Theorem 5.5.

6. Equations for the optimal filter: Markov signal with general state space. Our purpose in this section is to study the finitely additive white noise theory in a more general framework so as to include applications to signal and observation processes taking values in infinite-dimensional Hilbert spaces. The chief difficulty here is the lack of a conditional density since there is no Lebesgue measure (or any natural measure) in Hilbert space. The partial differential equations of Section 5 are now replaced by finitely additive analogues of measure-valued equations of FKK and Zakai and of a type of equations introduced by Kunita (1971) and studied also by Szpirglas (1978). The equivalence and uniqueness of solutions of these equations are established in the four principal results of this section. The proofs, of which only an outline is given, are based on auxiliary results on equations governing measures induced by multiplicative transformations of Markov processes. The full details are to be found in Kallianpur-Karandikar (1984b).

Let $\mathscr S$ be a Poliah space with its Borel σ -field $\mathscr R(S)$ and let $\{X_i\}_{0 \le i \le T}$ defined on a countably additive probability space $(\Omega, \mathscr A, \Pi)$, be an $\mathscr S$ -valued Markov process wrt a family $(\mathscr A_i)$ of sub- σ fields of $\mathscr S$. We will assume that the paths of $\{X_i\}$ are progressively measurable and that the process $\{X_i\}$ admits a transition probability function. Let $\{V_i^*\}$ be the two parameter semigroup associated with $\{X_i\}$ acting on $\mathscr S(S,\mathscr R(S))$ and let $\{T_i\}$ be the one parameter semigroup associated with $X_i = (t,X_i)$ acting on $\mathscr S(S,\mathscr R(S))$, $S = [0,\infty) \times S$.

Let $\mathscr L$ be the extended generator of $\{T_t\}$ and let $\mathscr D$ be the domain of $\mathscr L$. (See the Appendix.)

Let \mathcal{X} be a real separable Hilbert space with the inner product $(\cdot, \cdot)_{\mathcal{X}}$ and norm $\|\cdot\|_{\mathcal{X}}$. Let $0 < T < \infty$ and let h be a measurable function from $[0, T] \times$

S - X such that

(6.1)
$$\int_0^T \|h_s(X(\omega))\|_{\mathcal{X}}^2 ds < \infty, \quad \Pi\text{-a.s. }\omega.$$

Let

(6.2)
$$H = L^{2}([0,T], \mathcal{X}) = \{ \eta : [0,T] \to \mathcal{X} : \int_{s}^{T} \|\eta(s)\|_{\mathcal{X}}^{2} ds < \infty \}.$$

H is itself a real separable Hilbert space with the inner product

$$(\eta_1, \eta_2) = \int_0^T (\eta_1(s), \eta_2(s))_{\mathcal{X}} ds.$$

Let $e = (e_t)$ be the Gaussian white noise on (H, \mathscr{C}, m) , where m is the Gaussian measure on (H, \mathscr{C}) . Let $\xi : (\Omega, \mathscr{A}, \Pi) \to H$ be defined by

(6.3)
$$\xi_s(\omega) = h_s(X_s(\omega)), \quad \text{if (6.1) holds, } 0 \le s \le T,$$

$$= 0. \quad \text{otherwise.}$$

The measurability of h and the assumption that paths of (X_i) are progressively measurable implies that ξ is Borel-measurable. Let $(\mathcal{E}, \mathscr{E}) = (\Omega, \mathscr{A}) \odot (H, \mathscr{C})$ and let α be the product of Π and m constructed in Section 4. The abstract statistical model (4.6) with H, ξ given by (6.2), (6.3) on $(\mathcal{E}, \mathscr{E}, \alpha)$

$$(6.4) y = \xi + e$$

now becomes

(6.4')
$$y_s = h_s(X_s) + e_s, \quad 0 \le s \le T.$$

In this section, (6.4') is our model of nonlinear filtering. For $0 \le s < t \le T$, let

(6.5)
$$H_t^s = \left\{ \eta \in H: \int_0^s \|\eta(u)\|_{\mathcal{X}}^2 du + \int_0^T \|\eta(u)\|_{\mathcal{X}}^2 du = 0 \right\}.$$

It is easily seen that H_i^s is a closed linear subspace of H. Let Q_i^s be the orthogonal projection onto H_i^s . For the sake of convenience, we will denote H_i^0 and Q_i^0 by H_i and Q_i , respectively.

For $B \in \mathcal{B}(S)$, $0 \le t \le T$, and $\eta \in H$ let $\Gamma(\eta)(B)$, $F(\eta)(B)$ be defined by

(6.6)
$$\Gamma_{t}(\eta)(B) = \int_{\Omega} 1_{B}(X_{t}(\omega)) \exp\left[\left(\eta, Q_{t}\xi(\omega)\right) - \frac{1}{2} \|Q_{t}\xi(\omega)\|^{2}\right] d\Pi(\omega)$$

and

(6.7)
$$F_{\ell}(\eta)(B) = \left[\Gamma_{\ell}(\eta)(S)\right]^{-1}\Gamma_{\ell}(\eta)(B).$$

Since $(\eta, Q_i\xi(\omega)) - \frac{1}{2}||Q_i\xi(\omega)||^2 \le \frac{1}{2}||\eta||^2$, it is easy to see that for all $\eta \in H$, $\Gamma_i(\eta)$ is a countably additive finite measure on $(S, \mathcal{B}(S))$ and $F_i(\eta)$ is a countably additive probability measure on $(S, \mathcal{B}(S))$. Let $\mathcal{M}(S)$ be the class of countably additive finite measures on $(S, \mathcal{B}(S))$. Then, $\Gamma_i(\eta)$, $F_i(\eta) \in \mathcal{M}(S)$.

The Bayes formula (Theorem 4.9) implies that for all bounded Borel-measurable functions f on S,

(6.8)
$$E_{a}(f(X_{t})|Q_{t}y) = \int_{S} f(x)F_{t}(y)(dx).$$

Thus, $F_i(y)$ is the conditional distribution of X_i given $Q_i y$ and in view of (6.7), $\Gamma_i(y)$ will be called the unnormalized conditional distribution of X_i given $Q_i y$.

The next result shows that $\Gamma_i(y)$, $F_i(y)$ are $\mathcal{M}(S)$ -valued random variables on (E, \mathscr{E}, α) . Let $n = \alpha[y]^{-1}$

THEOREM 6.1. For $0 \le t \le T$,

(6.9)
$$\Gamma_{t}, F_{t} \in \mathcal{L}^{\bullet}(H, \mathscr{C}, n; \mathscr{M}(S)),$$

(6.10)
$$\Gamma_t(y), F_t(y) \in \mathcal{L}^{\bullet}(E, \mathcal{E}, \alpha; \mathcal{M}(S)),$$

and

(6.11)
$$\Gamma_{t}, F_{t} \in \mathcal{U}(y) = \mathcal{U}(E, \mathcal{E}, \alpha; \mathcal{M}(S), y).$$

PROOF. Recall that $\mathcal{M}(S)$ is itself a Polish space with a metric d_0 given by

$$d_0(\mu_1, \mu_2) = \sum_{j=1}^{\infty} \frac{1}{2^j} \left\{ \left| \int f_j d\mu_1 - \int f_j d\mu_2 \right| \wedge 1 \right\},\,$$

where $f_1 \equiv 1$ and $\{f_j : j \geq 1\}$ is a countable subset of $C_b(S)$ dense in the uniform norm topology. [See Stroock-Varadhan (1979).] Consider the map $g_1 : \mathcal{M}(S) \to \mathbb{R}^{\infty}$ defined by

$$g_1(\mu) = \{\langle f_j, \mu \rangle\}_{j \geq 1},$$

where $\langle f, \mu \rangle = \iint d\mu$. Let U be the range of g_1 . Then the form of the metric d_0 implies that g_1 is a homeomorphism onto U. Let $g: U \to \mathscr{M}(S)$ be the inverse of g_1 , which is continuous. Now, in view of Theorem 3.5, to prove the assertions for $\{\Gamma_i\}$, it suffices to prove that for all $j \geq 1$,

$$\langle f_i, \Gamma_t \rangle \in \mathcal{L}^*(H, \mathscr{C}, n; \mathbb{R}),$$

(6.13)
$$\langle f_j, \Gamma_l(y) \rangle \in \mathcal{L}^*(E, \mathscr{E}, \alpha; \mathbb{R}),$$

$$\langle f_j, \Gamma_t \rangle \in \mathscr{U}(y) = \mathscr{U}(E, \mathscr{E}, \alpha; \mathbb{R}, y),$$

and

(6.15)
$$\left\{R_n(\langle f_j, \Gamma_t \rangle)\right\}_{j \geq 1} \in U, \quad \text{a.s.,}$$

where R_n is an *n*-lifting. Now, it is easy to see that $\langle f_j, \Gamma_t \rangle \in \mathcal{I}(H)$ and hence (6.12), (6.13), and (6.14) follow from Theorems 3.5, 4.4, and 4.8.

Let L_1 be a measurable representative of $n, L_1: H \to \mathcal{L}(\Omega_1, \mathcal{A}_1, \Pi_1)$ say, and let R_n be the corresponding n-lifting. For a fixed $t \in [0, T]$, $\omega_1 \in \Omega$, let $\Lambda_t(\omega_1) \in \mathcal{M}(S)$ be defined by

(6.16)

$$\Lambda_{\ell}(\omega_{1})(B) = \int_{\Omega} 1_{B}(X_{\ell}(\omega)) \exp\left(L_{1}(Q_{\ell}\xi(\omega))(\omega_{1}) - \frac{1}{2}\|Q_{\ell}\xi(\omega)\|^{2}\right) d\Pi(\omega).$$

Then, using Theorem 4.4, it can be checked that

$$(6.17) R_n(\langle f_i, \Gamma_i \rangle) = \langle f_i, \Lambda_i(\omega_1) \rangle, j \ge 1,$$

so that (6.15) holds. To prove the assertions for $\{F_i\}$, observe that (6.17) implies that

Now, the assertions (6.12), (6.13), and (6.14) for F_t follow from the corresponding results for Γ_t (proved above), (6.18), and Theorem 3.5.

In Kallianpur-Karandikar (1984b), it has been shown that the measures $\{\Gamma_i\}$ and $\{F_i\}$ satisfy equations analogous to Zakai and FKK equations, and can be characterized as the unique solution to these equations. We will state these results and outline the proof. We assume that the process $\{X_i\}$ satisfies the condition A.13 (see the Appendix) and that h satisfies

$$||h_s(x)||_K \le q(s), \quad \forall \, x \in S$$

for a measurable function q on [0, T] satisfying

$$(6.20) \qquad \int_0^T q^2(s) ds < \infty.$$

THEOREM 6.2. For all $y \in H$, $\{\Gamma_i(y)\}$ satisfies

$$\langle f(t, \cdot), \Gamma_{t}(y) \rangle = \langle f(0, \cdot), \Gamma_{0}(y) \rangle + \int_{0}^{t} \langle (\mathcal{L}f)(s, \cdot), \Gamma_{s}(y) \rangle ds$$

(6.22) for all $A \in \mathcal{B}(S)$, $K_i(A)$ is a bounded measurable function of t and $K_0(A) = E_{11}I_A(X_0)$.

First, using the representation (6.28) and some elementary properties of the semigroup (V_i^*) , it is shown that $\Gamma_i(y)$ satisfies (6.24) and uniqueness is proved by a Gronwall-type inequality. Part (b) of Theorem 6.4 is proved by obtaining a recursive estimate of the total variation of $\Gamma_i(y) - \Gamma_i(y)$. Theorem 6.2 is deduced from Theorem 6.4 by showing that the equations (6.21) and (6.24) are equivalent, i.e., $\{K_i\}$ satisfying (6.22) is a solution of (6.21) if and only if it satisfies (6.24). The fact that $F_i(y)$ satisfies (6.23) follows from (6.7) and (6.21). Then it is shown that the equations (6.23) and (6.25) are equivalent in the sense described above, so that $F_i(y)$ satisfies (6.25). The uniqueness assertion in Theorem 6.5 is proved by a Gronwall-type inequality. This and the equivalence of equations (6.23) and (6.25) imply the uniqueness part of Theorem 6.3. The proof of Theorem 6.5(b) is similar to that of Theorem 6.4(b). \Box

In the stochastic calculus theory of nonlinear filtering, the optimal filter has been shown to be a measure-valued Markov process [see, e.g., Kunita (1971)]. The same question arises in our theory. However, the optimal nonlinear filter $F_i(y)$ is a measure-valued process defined on a finitely additive probability space and no definition of the Markov property in this context is available to us in the existing literature. With a suitable definition of this property we have been able to prove that $F_i(y)$ and $\Gamma_i(y)$ are Markov processes on (E, \mathcal{E}, α) . The Markov property also holds if these processes are regarded as defined on (H, \mathcal{E}, n) . The proofs will appear in a forthcoming monograph. Also see Kallianpur and Karandikar (1984c).

7. Likelihood ratios. The theory in Sections 3 and 4 can be used to derive likelihood ratios in the finitely additive framework. Their applications to detection problems and to parameter estimation will be postponed for future consideration. Earlier work related to the material of this section will be found in Balakrishnan (1982).

In order to allow infinite-dimensional processes as well as random fields as signals in statistical problems, in the abstract statistical model (4.6) we shall take

Let (X_t) be an S-valued process on a countably additive probability space $(\Omega, \mathscr{A}, \Pi)$, where S is a Polish space. Assume that the map $(\omega, t) \to X_t(\omega)$ is $\mathscr{A} \times \mathscr{B}_{[0,T]}$ measurable. Let $h: [0,T] \times S \to \mathscr{X}$ be a measurable function such that

For $0 \le t \le T$, let H_t be the closed linear subspace of H given by

In analogy with the usual terminology, we define $\rho_i(y)$ to be the likelihood ratio for the model (7.5) for observations over the interval [0, t].

By the definition of ρ_{ij} (7.8), and the expression (7.7), it follows that

noise) are multiparameter processes taking values in a possibly infinite-dimensional separable Hilbert space. For simplicity we consider only the case of two parameters.

Let $T = [0, T] \times [0, T]$. We will denote a generic element (t_1, t_2) of T by t. Let \mathscr{X} be a separable Hilbert space and let

Let the signal process $\{X_i \colon t \in T\}$ be an S-valued random field, defined on a countably additive probability space $(\Omega, \mathscr{A}, \Pi)$ where S is a Polish space. Let

be a measurable function such that

Let $(E, \mathscr{C}, \alpha) = (\Omega, \mathscr{A}, \Pi) \odot (H, \mathscr{C}, m)$. Now, the abstract statistical model (4.6) takes the form

Then, as in the previous section, we will call $\rho_1(y)$ the likelihood ratio for the model (7.32) for observations over $[0, t_1] \times [0, t_2]$, $t = (t_1, t_2)$.

For a function
$$g: S \to \mathbb{R}$$
 such that $E|g(X_i)| < \infty$, let

(7.37)
$$\Pi_{1}(g) = E_{n}(g(X_{1})|Q_{1}y).$$

Then, by the Bayes formula, Theorem 4.9,

(7.38)
$$\Pi_{i}(g) = \frac{\int_{\Omega} g(X_{i}(\omega))q_{i}(\omega, y) d\Pi(\omega)}{\rho_{i}(y)}.$$

We now obtain an expression for $\rho_i(y)$ analogous to (7.19). For simplicity in notation, we give the expression for the case $\mathcal{X} = \mathbb{R}$.

THEOREM 7.3. Assume that X = R and

$$A(s_1, s_2, y) = \prod_{s_1, s_2} (h_{s_1, s_2}) y_{s_1, s_2} - \frac{1}{2} \prod_{s_1, s_2} (\left[h_{s_1, s_2}\right]^2)$$

$$B(s_1, s_2, y) = \int_0^{s_1} \int_0^{s_2} \left[-\prod_{s_1, s_2} (h_{s_1, u_2} h_{u_1, s_2}) y_{s_1, u_2} y_{u_1, s_2} \right]$$

$$- \frac{1}{2} \prod_{s_1, s_2} (h_{s_1, u_2} h_{u_1, s_2}) y_{s_1, u_2}$$

$$- \frac{1}{2} \prod_{s_1, s_2} (h_{s_1, u_2}^2 h_{u_1, s_2}) y_{u_1, s_2}$$

$$+ \frac{1}{4} \prod_{s_1, s_2} (h_{s_2, u_2}^2 h_{u_1, s_2}) \left[du_1 du_s, \right]$$

and

$$C(s_1, s_2, y) = \int_0^{s_1} \int_0^{s_2} \left[\Pi_{s_1, s_2}(h_{s_1, u_2}) y_{s_1, u_2} - \frac{1}{2} \Pi_{s_1, s_2}(h_{s_1, u_2}^2) \right] \cdot \left[\Pi_{s_1, s_2}(h_{u_1, s_2}) y_{u_1, s_2} - \frac{1}{2} \Pi_{s_1, s_2}(h_{u_1, s_2}^2) \right] du_1 du_2.$$

PROOF. Let us denote, for a fixed $y \in H$,

Proceeding as in the proof of Theorem 7.2, it can be proved that:

- (i) for fixed t_1 , $F(t_1, t_2)$ is absolutely continuous in t_2 ;
- (ii) for a.e. t_2 (fixed), $[\partial F(t_1, t_2)]/\partial t_2$ is absolutely continuous in t_1 :
- (iii) $[\partial F(0, t_2)]/\partial t_2 = 0;$
- (iv) $[\partial^2 F(t_1, t_2)]/(\partial t_1 \partial t_2) = A(t_1, t_2) + B(t_1, t_2) + C(t_1, t_2)$, where A, B, and C are given by (7.41), (7.42), and (7.43) for $y \in H$ fixed.

Then,

(7.45)
$$\frac{\partial F(t_1, t_2)}{\partial t_2} = \frac{\partial F(0, t_2)}{\partial t_2} + \int_0^{t_1} \frac{\partial^2 F(s_1, t_2)}{\partial s_1 \partial t_2} ds_1$$
$$= \int_0^{t_1} \frac{\partial^2 F(s_1, t_2)}{\partial s_1 \partial t_2} ds_1$$

and

(7.46)
$$F(t_1, t_2) = F(t_1, 0) + \int_0^{t_2} \frac{\partial F(t_1, s_2)}{\partial s_2} ds_2$$

$$= \int_0^{t_2} \frac{\partial F(t_1, s_2)}{\partial s_2} ds_2$$

$$= \int_0^{t_2} \int_0^{t_1} \frac{\partial^2 F(s_1, s_2)}{\partial s_1 \partial s_2} ds_1 ds_2.$$

Now, (7.40) follows from (7.46) and (iv) above. \Box

Further simplification of the formula (7.40) requires an extension of the Bayes formula of Theorem 4.9 to a class of functions depending on both ω and y. These and other related problems concerning random fields will be investigated in our later work.

8. Robustness of the white noise theory and its consistency with the martingale-theoretic approach. In this section we prove a series of results whose main purpose is to show that the white noise theory of filtering is consistent with the more familiar theory based on martingale calculus and Itô stochastic differential equations. We begin by showing in Theorems 8.1 and 8.2 that the conditional expectation $E(f(X_t)|\mathcal{F}_t^Y)$ is the α -lifting of the conditional expectation $\Pi_{i}(f, y)$ of the white noise setup and, in fact, that it can be obtained as the limit in probability of a suitable sequence of white noise conditional expectations. (In the spirit of Theorem 8.2 a similar approximation result for a wider class of Wiener functionals is given in Theorem 8.4.) We next consider the unnormalized conditional density $p_i(x, y)$, which has been obtained as the unique solution of the finitely additive version of the Zakai equation. Roughly speaking what we show is that, given any path Y in $C([0,T],\mathbb{R}^d)$ and Y'' a sequence in \mathcal{X} approximating Y in the uniform topology, the sequence of corresponding $p_i(x, Y^n)$ converges to a unique limit $p'_i(x, Y)$ [independent of the sequence (Y'')] which is a version of the unnormalized conditional density of the conventional Zakai equation. Moreover, the extension thus obtained is robust in the sense in which that term has been used by recent writers [Clark (1978), Davis (1979), and Pardoux (1982)]. Theorem 8.9 and the remark following it are devoted to making the above statements precise. Corollary 8.10 yields a special result involving polygonal path approximations that might be of independent interest. Incidentally, the white noise filtering theory possesses an "internal" robustness property which is described in Lemma 5.4.

In the course of obtaining Theorem 8.9 we also derive in Theorem 8.8 a pathwise solution to the conventional Zakai equation essentially extending a result of Pardoux (1982) for the case of unbounded h.

We will first study the relationship between the finitely additive white noise model considered in Section 5 [given by (5.3)] and the usual countably additive model discussed in Section 2 in the signal-noise independent case [given by (1.2)] for a given \mathbb{R}^d -valued Markov process (X_i) on a countably additive probability space $(\Omega, \mathscr{A}, \Pi)$.

Let us recall that the model

(8.1)
$$y_s = h_s(X_s) + e_s$$

is given on the quasicylindrical probability space

(8.2)
$$(E, \mathscr{E}, \alpha) = (\Omega, \mathscr{A}, \Pi) \odot (H, \mathscr{C}, m).$$

Without loss of generality, we can assume that the model (1.2) in the signal-noise independent case is given by

$$(8.3) Y_t = \int_0^t h_s(X_s) ds + Z_t$$

on
$$(\tilde{\Omega}, \tilde{\mathscr{A}}, \tilde{\Pi}) = (\Omega, \mathscr{A}, \Pi) \otimes (\Omega_0, \mathscr{A}_0, \Pi_0)$$
 where

(8.4)
$$\Omega_0 = C_0([0, T], R^m)$$

is the space of continuous functions ω_0 : $[0,T] \to \mathbb{R}^m$ a.t. $\omega_0(0) = 0$ with the topology of uniform convergence, and as in Section 2, Π_0 is the Wiener measure

on $(\Omega_0, \mathscr{A}_0)$ and $\{Z_i\}$ are the coordinate maps on Ω_0 given by

$$(8.5) Z_t(\omega_0) = \omega_0(t)$$

so that $\{Z_t\}$ is a Brownian motion under Π_0 .

We will continue to use the notation established in Sections 2 and 5 with the following exception.

We will denote the unnormalized conditional expectation of $f(X_i)$ given \mathcal{F}_i^Y by $\hat{\sigma}_i(f,Y)$ [instead of $\sigma_i(f,Y)$, which was used in Section 2] and the conditional expectation itself will be denoted by $\hat{\Pi}_i(f,Y)$. In this setup, $\hat{\sigma}_i(f,Y)$ is given by

$$\hat{\sigma}_{t}(f, Y(\tilde{\omega})) = \int_{\Omega} f(X_{\bullet}(\omega)) \exp\left(\sum_{i=1}^{m} \int_{0}^{t} h_{\bullet}^{i}(X_{\bullet}(\omega)) dY_{\bullet}^{i}(\tilde{\omega}) - \frac{1}{2} \int_{0}^{t} |h_{\bullet}(X_{\bullet}(\omega))|^{2} ds\right) d\Pi(\omega),$$
(8.6)

where the stochastic integral in (8.6) is on the product space $(\Omega \times \tilde{\Omega}, \mathscr{A} \otimes \tilde{\mathscr{A}}, \Pi \otimes \tilde{\Pi})$, so that $\{X_s(\omega)\}, \{Y_s(\tilde{\omega})\}$ are independent under $\Pi \otimes \tilde{\Pi}$. This follows from Remark 2.1.

Let $L_0: H \to \mathcal{L}(\Omega_0, \mathcal{A}_0, \Pi_0)$ be defined by

(8.7)
$$L_0(\eta) = \sum_{i=1}^m \int_0^T \eta_s^i dZ_s^i, \quad \eta \in H.$$

where $\int_0^T \eta_s^1 dZ_s^1$ denotes the Wiener integral. It is easy to see that (L_0, Π_0) is a representation of m. In view of Theorem 4.1, we can and do choose a version of L_0 such that $(\omega_0, \eta) \to L_0(\eta)(\omega_0)$ is $\mathscr{A}_0 \times \mathscr{B}(H)$ -measurable. For $\bar{\omega} = (\omega, \omega_0) \in \bar{\Omega}$, let

(8.8)
$$L(\eta)(\tilde{\omega}) = L_0(\eta)(\omega_0)$$

and

$$\rho(\tilde{\omega}) = \omega.$$

Then $(\rho, L, \bar{\Pi})$ is a representation of α (as observed at the beginning of Section 4). Let R_{α} be the α -lifting corresponding to $(\rho, L, \bar{\Pi})$.

THEOREM 8.1. For all $f: \mathbb{R}^m \to \mathbb{R}$ with $E|f(X_t)| < \infty, 0 \le t \le T$,

 $(\rho, L, \bar{\Pi})$ and R_n be the corresponding n-lifting (see Lemma 3.8). Then

$$= (\eta, \xi(\omega)) + L_{0}(\eta)(\omega_{0}),$$

$$= \sum_{i=1}^{m} \int_{0}^{i} \eta_{\sigma}^{i} h_{\sigma}^{i}(X_{\sigma}(\omega)) ds + \sum_{i=1}^{m} \int_{0}^{i} \eta_{\sigma}^{i} dZ_{\sigma}^{i}(\omega_{0}), \quad \bar{\omega} = (\omega, \omega_{0}).$$

Now, the Wiener integral can also be thought of as the Itô integral (of a nonrandom function) and hence from (8.11)

$$(8.12) L_1(\eta)(\tilde{\omega}) = \left(\sum_{i=1}^m \int_0^T \eta_i^i dY_i^i\right)(\tilde{\omega}).$$

$$p(B) = \int f(X_i(\omega)) 1_B(Q_i \xi(\omega)) d\Pi(\omega).$$

Thus, $\sigma_i(f,\cdot) \in \mathcal{I}(H)$ and hence, by Theorems 4.4 and 4.6,

$$R_n(\sigma_t(f,\cdot)) = \int_H \exp\left(L_1(\eta') - \frac{1}{2}||\eta'||^2\right) d\nu(\eta')$$

$$= \int_H \exp\left(\sum_{i=1}^m \int_0^T \eta_s^i dY_s^i - \frac{1}{2} \int_0^T |\eta_s|^2 ds\right) d\nu(\eta).$$
(8.16)

Since the support of ν is H_i , we can rewrite (8.16) as

It can be seen that the right-hand sides of (8.17) and (8.6) are identical and hence we get

$$R_{a}(\sigma_{t}(f, y)) = R_{n}(\sigma_{t}(f, \cdot)).$$

From (8.18) and (8.20) we get

$$(8.21) R_{\alpha}(\sigma_{t}(f, y)) = \hat{\sigma}_{t}(f, Y).$$

Now. (8.21) for f = 1, implies

(8.22)
$$R_o(\sigma_t(1, y)) = \hat{\sigma}_t(1, Y)$$

and thus

(8.23)
$$R_{a}(\Pi_{I}(f, y)) = \frac{R_{a}(\sigma_{I}(f, y))}{R_{a}(\sigma_{I}(1, y))}$$
$$= \frac{\hat{\sigma}_{I}(f, Y)}{\hat{\sigma}_{I}(1, Y)}$$
$$= \hat{\Pi}(f, Y).$$

The previous theorem shows that the "functional" $\hat{\Pi}_i(f,Y)$ can be obtained from the "functional" $\Pi_i(f,y)$ via an α -lifting. The next theorem will give a better picture of this relationship.

Let $\mathscr H$ be the reproducing kernel Hilbert space of the Wiener space $(\Omega_0,\mathscr A_0,\Pi_0)$. It is well known that

(8.24)
$$\mathscr{H} = \left\{ \eta \colon [0,T] \to \mathbb{R}^m \colon \eta(0) = 0 \text{ and } \dot{\eta} = \frac{d\eta}{dt} \in H \right\}.$$

Let i be the identity mapping from $\mathscr H$ into Ω_0 , which is continuous. The adjoint map i^* maps the dual Ω_0^* of Ω_0 into $\mathscr H^* = \mathscr H$. It is well known that $i^*(\Omega_0^*) = \mathscr H_1$, where

and the duality map $((\cdot, \cdot))$ from $\mathcal{H}_1 \times \Omega_0 \to \mathbb{R}$ is given by

where we take the right continuous with left limits version of $\hat{\eta}_t$, continuous at T. Such a version exists as $\eta \in \mathcal{H}_1$. The integral $\int_0^T \omega_0^i(t) d\hat{\eta}_t^i$ is to be taken as a Riemann–Stieltjes integral. Observe that any $\hat{P} \in \mathcal{P}(\mathcal{H})$ with (range $\hat{P}) \subseteq \mathcal{H}_1$ can be extended to Ω_0 as follows. Let $\{\hat{\phi}_i: 1 \leq j \leq k\} \subseteq \mathcal{H}_1$ be a basis for range \hat{P} . Then

$$\Pi_{\tau}(f, \tau(\hat{P}, Y(\tilde{\omega}))) \rightarrow \hat{\Pi}_{\tau}(f, Y(\tilde{\omega}))$$
 in $\hat{\Pi}$ probability.

PROOF. As in the previous theorem, it is enough to prove the assertion for positive f. Let $P_i \in \mathcal{P} = \mathcal{P}(H)$ be defined by

$$= \int f(X_{i}(\omega')) \exp\left(\sum_{i=1}^{k} (\phi_{i}, \eta)(\phi_{i}, Q_{i}\xi(\omega')) - \frac{1}{2}\|Q_{i}\xi(\omega')\|^{2}\right) d\Pi(\omega')$$

and hence

(8.35)
$$\exp \left(\sum_{i=1}^{k} L_i(\phi_i) (\phi_i, Q_i \xi(\omega')) \right)$$

$$-\tfrac{1}{2}\|Q_t\xi(\omega')\|^2\bigg)d\Pi(\omega').$$

Since $\hat{\phi}_i \in (\text{range } \hat{P}_j) \subseteq \mathcal{H}_i$, using (8.12), (8.26), and the integration by parts formula, it can be checked that

-a.s.

Hence

$$\begin{split} \sum_{i=1}^{h} L_{1}(\phi_{i})(\phi_{i}, Q_{i}\xi(\omega')) &= \sum_{i=1}^{h} ((\hat{\phi}_{i}, Y(\tilde{\omega})))(\tau^{-1}\phi_{i}, \tau^{-1}Q_{i}\xi(\omega')) \\ &= \sum_{i=1}^{h} ((\hat{\phi}_{i}, Y(\tilde{\omega})))(\hat{\phi}_{i}, \tau^{-1}Q_{i}\xi(\omega')) \\ &= (\hat{P}_{j}Y(\tilde{\omega}), \tau^{-1}Q_{i}\xi(\omega')), \quad \tilde{\Pi}\text{-a.s.} \\ &= (\tau[\hat{P}_{j}Y(\tilde{\omega})], Q_{i}\xi(\omega')), \quad \tilde{\Pi}\text{-a.s.} \end{split}$$

Now (8.35) and (8.37) imply (8.33). Proceeding as in Theorem 8.1 we get

(8.38)
$$R_{n}(\Pi_{t}(f, P_{j}\eta)) = \frac{R_{n}(\sigma_{t}(f, P_{j}\eta))}{R_{n}(\sigma_{t}(1, P_{j}\eta))}$$
$$= \frac{\hat{\sigma}_{t}(f, \tau(\hat{P}_{j}Y(\tilde{\omega})))}{\hat{\sigma}_{t}(1, \tau(\hat{P}_{j}Y(\tilde{\omega})))}$$
$$= \hat{\Pi}_{t}(f, \tau(\hat{P}_{j}Y(\tilde{\omega}))), \quad \tilde{\Pi}\text{-a.s.}$$

Now the required assertion follows from (8.38), Theorem 8.1, and the fact that $\Pi_{\bullet}(f,\eta) \in \Psi(y) = \Psi(E,\mathscr{E},\alpha;\mathbb{R},y)$ (in view of Theorem 4.8). \square

for $t_{j-1}^h \le s \le t_j^h, 1 \le j \le m_h$. Then for all $f: \mathbb{R}^d \to \mathbb{R}$ such that $E|f(X_i)| \le \infty$,

 in $\bar{\Pi}$ probability.

where $\dot{Y}_h(\tilde{\omega}) = (d/ds)Y_h(\tilde{\omega})$. Observe that here, Y_h is the usual polygonal approximation to Y and \dot{Y}_h is an approximation of the nonexistent "derivative \dot{Y} " of Y.

This result can be deduced from Theorem 8.2 by identifying Y_k with $\hat{P}_k Y$ for an appropriate sequence $\{\hat{P}_k\}$ satisfying the conditions of Theorem 8.2.

Proceeding as in the proof of the previous result, we can also derive the following result on approximation of Wiener functionals.

THEOREM 8.4. Let $\mu \in \mathcal{M}_0(\mathcal{H})$ and let \hat{f} , \hat{g} be the Wiener functionals defined by

(8.42)
$$f(\omega_0) = \int_{\mathcal{R}} \exp \left(\sum_{i=1}^m \int_0^T \dot{\eta}_s^j dZ_s^j(\omega_0) - \frac{1}{2} \int_0^T |\dot{\eta}_s|^2 ds \right) d\mu(\eta)$$

and

(8.43)
$$\hat{g}(\omega_0) = \int_{\mathcal{A}} \exp \left(i \sum_{i=1}^m \int_0^T \dot{\eta}'_s dZ'_s(\omega_0)\right) d\mu(\eta), \quad \Pi_0 \cdot a.s.$$

where $\int_0^T \eta' dZ'$ is a Wiener integral.

For $\theta \in \mathcal{H}$, let f, g be functionals on \mathcal{H} defined by

(8.44)
$$f(\theta) = \int_{\mathcal{X}} \exp \left(\sum_{i=1}^{m} \int_{0}^{T} \dot{\eta}_{s}' \dot{\theta}_{s}' ds - \frac{1}{2} \int_{0}^{T} |\dot{\eta}_{s}|^{2} ds \right) d\mu(\eta).$$

and

(8.45)
$$g(\theta) = \int_{\mathcal{R}} \exp \left(i \sum_{j=1}^{m} \int_{0}^{T} \dot{\eta}_{s}^{j} \dot{\theta}_{s}^{j} ds \right) d\mu(\eta).$$

Then for all sequences $\{\hat{P}_j\}\subseteq \mathcal{P}(\mathcal{H})$ such that $\hat{P}_j\stackrel{*}{\to} I$ and $(\text{range }\hat{P}_j)\subseteq \mathcal{H}_1$,

$$(8.46) f(\hat{P}_i Z) \rightarrow \hat{f} in \mathcal{L}^1(\Omega_0, \mathscr{A}_0, \Pi_0)$$

and

$$(8.47) g(\hat{P}_{i}Z) \rightarrow \hat{g} in \mathcal{L}^{1}(\Omega_{0}, \mathcal{A}_{0}, \Pi_{0})$$

as $j \to \infty$.

The next corollary follows from Theorem 8.4 by choosing \hat{P}_{j} as given in Corollary 8.3.

COROLLARY 8.5. Let f, g, \hat{f}, \hat{g} be as in Theorem 8.4. Let $\{0 = t_0^k < t_1^k < \cdots < t_{m_k}^k = T\}$, $k \ge 1$ be a sequence of partitions of $\{0, T\}$ satisfying (8.39). Let $I_{\lambda}(\omega_0)$, $U_{\lambda}(\omega_0)$ and $U_{\lambda}(\omega_0)$ is defined by

$$(8.48) Z_k(\omega_0)(s) = \omega_0(t_{j-1}^k) + \frac{\omega_0(t_j^k) - \omega_0(t_{j-1}^k)}{t_j^k - t_j^k} (s - t_{j-1}^k),$$

for $t_{j-1}^k \leq s \leq t_{j+1}^k 1 \leq j \leq m_k$. Then

$$f(Z_k) \to \hat{f}$$
 in $\mathcal{L}^1(\Omega_0, \mathscr{A}_0, \Pi_0)$

and

$$g(Z_k) \rightarrow \hat{g}$$
 in $\mathcal{L}^1(\Omega_0, \mathscr{A}_0, \Pi_0)$.

In Theorem 8.2 we showed that the functional $\hat{\Pi}_i(f,Y)$ can be obtained from the functional $\Pi_i(f,y)$. However, the convergence in (8.31) is convergence in $\hat{\Pi}$ probability and hence given an observation path Y. Theorem 8.2 does not show how to obtain $\hat{\Pi}_i(f,Y)$ for this path Y from $\{\Pi_i(f,y)\colon y\in H\}$. We will now show that under additional conditions on the signal process (X_i) and h, the unnormalized conditional density $\hat{p}_i(x,y)$ of X_i can be obtained as the continuous extension of $\{p_i(x,\tau Y)\colon Y\in \mathscr{H}\}$, where τ is the isomorphism between \mathscr{H} and H given by (8.28). As a consequence, $\hat{\Pi}_i(f,Y)$ for a given Y can be obtained as the limit of $\Pi_i(f,\hat{Y}_k)$, where $Y_k\in\mathscr{H}$ is any sequence converging to Y in uniform norm.

Throughout the rest of this section, we assume that the process (X_t) and the function h satisfy the conditions of Theorem 5.6 [i.e., (5.37), (5.38), (5.40), (5.56), (5.57), (5.58), and (5.39) hold].

Let $\Omega^{\bullet} = \{\omega_0 \in \Omega_0: t \to \omega_0(t) \text{ is H\"older continuous}\}$. Recall that Z_t is the coordinate process on Ω_0 defined by (8.5). We will use $Z(\omega_0)$ to denote the path $Z_t(\omega_0)$ [so that $Z(\omega_0) = \omega_0$] for notational convenience. For each $Z \in \Omega^{\bullet}$, consider the PDE

(8.49)
$$\frac{\partial \Psi_t}{\partial t}(x,Z) = \frac{1}{2} \sum_{i,j=1}^d \alpha_{ij}(t,x) \frac{\partial^2 \Psi_t(x,Z)}{\partial x^i \partial x^j} + \sum_{i=1}^d \hat{b}_i(t,x,Z) \frac{\partial \Psi_t(x,Z)}{\partial x^i} + \hat{c}(t,x,Z) \Psi_t(x,Z),$$

where

$$(8.50) b_i(\cdot,\cdot,Z) = -b_i + \sum_{j=1}^d \frac{\partial a_{ij}}{\partial x^j} + \frac{1}{2} \sum_{j=1}^d a_{ij} \frac{\partial}{\partial x^j} \left(\sum_{k=1}^m h_i^k Z_i^k \right)$$

and

$$\partial(\cdot,\cdot,Z) = -\frac{1}{2}|h_{t}|^{2} - \sum_{j=1}^{d} \frac{\partial b_{i}}{\partial x_{i}} + \frac{1}{2} \sum_{i,j=1}^{d} \frac{\partial^{2} a_{ij}}{\partial x^{i} \partial x^{j}}$$

$$+ \frac{1}{2} \sum_{i,j=1}^{d} a_{ij} \left[\frac{\partial^{2}}{\partial x^{i} \partial x^{j}} \left(\sum_{k=1}^{m} h_{t}^{k} Z_{t}^{k} \right) + \frac{\partial}{\partial x_{i}} \left(\sum_{k=1}^{m} h_{t}^{k} Z_{t}^{k} \right) \right]$$

$$\cdot \frac{\partial}{\partial x_{j}} \left(\sum_{k=1}^{m} h_{t}^{k} Z_{t}^{k} \right)$$

$$+ \sum_{i=1}^{d} \left[\left(-b_{i} + \sum_{j=1}^{d} \frac{\partial a_{ij}}{\partial x^{j}} \right) \frac{\partial}{\partial x^{j}} \left(\sum_{k=1}^{m} h_{t}^{k} Z_{t}^{k} \right) \right] - \sum_{k=1}^{m} \frac{\partial h_{t}^{k}}{\partial t} Z_{t}^{k}.$$
(8.51)

Equation (8.49) is known as the robust form of Zakai's equation and is formally the equation satisfied by

$$\Psi_t(x,Z) = \hat{p}_t(x,Z) \exp\left(-\sum_{k=1}^m h_t^k(x)Z_t^k\right),\,$$

where $\hat{p}_t(x, Z)$ is a solution of SPDE (2.33).

Our first result is on the existence, uniqueness, and continuous dependence (on Z) of the solution to the PDE (8.49).

THEOREM 8.6. Suppose the conditions of Theorem 5.6 hold. Then

- (i) For all Z ∈ Ω*, the PDE (8.49) with the initial condition Ψ₀(x, Z) = φ(x)
 has a unique solution Ψ₁(x, Z) in the class G. [See Theorem 5.5 for definition
 of G.]
- (ii) The mapping Z → Ψ · (·, Z) from Ω* into C([0, T] × ℝ^d) (equipped with the topology of uniform convergence on compacta) is continuous.

We are now in a position to prove parts (i) and (ii) of Theorem 5.6, which we had not proved earlier.

PROOF OF THEOREM 5.6. For $\eta \in H$, let

$$(8.52) p_t(x,\eta) = \Psi_t(x,Z) \exp\left(\sum_{i=1}^m h_i^i(x)Z_i^i\right),$$

where

$$(8.53) Z_t^i = \int_0^t \eta_s^i ds.$$

Here, $\Psi_i(x,Z)$ is the unique solution to (8.49) in the class \mathcal{F} . Using the product rule, it is easy to check that $p_i(x,\eta)$ defined by (8.52) satisfies (5.41) for a.e. t. Clearly also (5.59) holds. If p' satisfies (5.59) and satisfies (5.41) for a.e. t and if Ψ' is defined by

(8.54)
$$\Psi'_t(x,Z) = p'_t(x,\eta) \exp\left(-\sum_{i=1}^m h_i^i(x)Z_i^i\right),$$

where Z, η are related by (8.53), then it follows that Ψ' is a solution of (8.49) and belongs to the class \mathcal{F} and hence, in view of Theorem 8.6, $\Psi' = \Psi$ and also p' = p. This proves part (i) of Theorem 5.6. Part (ii) follows from the definition of p given in (8.52) and Theorem 8.6(ii). \square

THEOREM 8.7. Fix f to be a bounded continuous function from \mathbb{R}^d into \mathbb{R} and let 0 < t < T. Recall that

$$\begin{split} \hat{\sigma}_{t}(f,Z) &= \int f(X_{t}(\omega)) \\ &\cdot \exp\left[\sum_{i=1}^{m} \int_{0}^{t} h_{s}^{i}(X_{s}(\omega)) dZ_{s}^{i} - \frac{1}{2} \int_{0}^{t} |h_{s}(X_{s}(\omega))|^{2} ds\right] d\Pi(\omega), \end{split}$$

where the stochastic integral $f_0'h_0'(X_s(\omega))dZ_s'$ is the $It\bar{o}$ integral on the product space $(\Omega,\mathscr{A},\Pi)\otimes(\Omega_0,\mathscr{A}_0,\Pi_0)$, Π_0 being the Wiener measure on Ω_0 . Then there exists a version $\sigma_i'(f,Z)$ defined for all $Z\in\Omega_0$, of $\bar{\sigma}_i(f,Z)$, i.e.

(8.55)
$$\sigma_i'(f,Z) = \hat{\sigma}_i(f,Z), \quad \Pi_0 \text{ a.e. } (Z),$$

such that the mapping $Z \to \sigma'_i(f,Z)$ is continuous from Ω_0 into \mathbb{R} (wrt the topology of uniform convergence on Ω_0).

For the proof we refer the reader to Kallianpur-Karandikar (1983b, Proposition 8.4). The desired version is given by

$$o_i'(f,Z) = \int_{\Omega} f(X_i(\omega)) \exp\left(\sum_{i=1}^m \left(h_i^i(X_i(\omega))Z_i^i - \int_0^i Z_i^i dh_s(X_s(\omega))\right) - \frac{1}{2} \int_0^i \left|h_s(X_s(\omega))\right|^2 ds\right) d\Pi(\omega).$$

We are now ready to prove the two main results of this section. The first one is on the existence of a "pathwise version" of the unnormalized conditional density for the model (8.3).

THEOREM 8.8. For $Z \in \Omega^*$ let $\Psi_l(x,Z)$ be the unique solution to (8.49) with the initial condition $\Psi_0(x,Z) = \phi(x)$ (see Theorem 8.6) and let $\hat{p}_l(x,Z)$ be defined by

(8.56)
$$\hat{p}_{t}(x, Z) = \Psi_{t}(x, Z) \exp\left(\sum_{k=1}^{m} h_{t}^{k}(x) Z_{t}^{k}\right), \quad Z \in \Omega^{*}.$$

Note that since $Z(\omega_0) \in \Omega^*$ Π_0 -a.e., $Y(\tilde{\omega})$ given by (8.3) belongs to Ω^* $\tilde{\Pi}$ -a.s. Then $\{\hat{p}_t(x, Y(\tilde{\omega})): \tilde{\omega} \in \tilde{\Omega}\}$ is a version of the unnormalized conditional density of X_t given \mathscr{F}_t^Y [where Y is given by (8.3)], i.e., for $f \in C_b(\mathbb{R}^d)$,

(8.57)
$$E_{\tilde{\Pi}}(f(X_t)|\mathcal{F}_t^Y) = \frac{\int f(x)\hat{p}_t(x,Y)\,dx}{\int \hat{p}_t(x,Y)\,dx}, \quad \tilde{\Pi}\text{-}a.e.$$

PROOF. Using the integration by parts formula, it follows that for $\eta \in H$, $0 \le t \le T$

(8.58)

$$\int_0^t \! h_s \big(\, X_s (\, \omega \, \big) \big) \eta_s \, ds = h_t \big(\, X_t (\, \omega \, \big) \big) Z_t - \int_0^t \! Z_s \, dh_s \big(\, X_s (\, \omega \, \big) \big), \qquad \text{Π-a.e. ω},$$

where

$$(8.59) Z_t = \int_0^t \eta_s \, ds, \quad 0 \le t \le T.$$

Let $f: \mathbb{R}^d \to \mathbb{R}$ be a bounded continuous function. From (8.58) and the definitions of $\sigma'_l(f, Z)$, $\sigma_l(f, \eta)$, it follows that if $\eta \in H$, $Z \in \Omega_0$ are related by (8.59), then

(8.60)
$$\sigma'_t(f, Z) = \sigma_t(f, \eta).$$

Also, from (8.52) and (8.56), it follows that if η , Z are related by (8.59), then we have

$$\hat{p}_t(x,Z) = p_t(x,\eta), \quad 0 \le t \le T, x \in \mathbb{R}^d.$$

Now, (8.60), (8.61), and Theorem 5.5 imply that for all $Z \in \mathcal{H}$,

$$\sigma'_{i}(f,Z) = \int f(x)\hat{p}_{i}(x,Z) dx.$$

The mapping $Z \to \hat{p}_{\ell}(x,Z)$ is continuous in the topology of uniform convergence on compacta [by Theorem 8.6 and (8.56)] and also the mapping $Z \to \sigma'_{\ell}(f,Z)$ is continuous by Theorem 8.7. Thus, as \mathscr{H} is dense in Ω_0 , the identity (8.62) continues to hold for all $Z \in \Omega^{\bullet}$.

Now, as the measure $\Pi[Y]^{-1}$ is equivalent to Π_0 (on Ω_0) the relation (8.55) implies that

(8.63)
$$\theta_i(f,Y) = \sigma_i'(f,Y) \quad \tilde{\Pi}\text{-a.e.}$$

$$= \int f(x)\hat{p}_i(x,Y) dx, \quad \tilde{\Pi}\text{-a.e.}$$

since $Y \in \Omega^{\bullet}$ a.e. $\tilde{\Pi}$. This and the Bayes formula, Theorem 4.9, prove (8.57) for all $f \in C_b(\mathbb{R}^d)$. \square

Pardoux (1979) has obtained the above result under conditions that are somewhat different from ours and include boundedness assumptions on h, $\partial h/\partial h$, $\partial h/\partial x_j$, and $\partial^2 h/(\partial x_i \partial x_j)$. More recently, Pardoux (1982) has shown it under less restrictive assumptions that permit h to have linear growth. It may be noted, however, that our proof essentially uses the Bayes formula and does not rely on stochastic differential equations.

The problem of robust filtering in the unbounded case has also been considered in Baras, Blankenship, and Mitter (1981) and Baras, Blankenship, and Hopkins (1983). They show under certain conditions that Equation (8.49) admits a unique solution $\overline{\Psi}$ but do not identify p_i defined by (8.56) to be the unnormalized conditional density—a point of considerable importance from the standpoint of filtering theory.

The next result, whose proof is really contained in the proof of the previous theorem, shows that (under certain conditions) the unnormalized conditional density of X, for the model (8.3) is a continuous extension of the unnormalized conditional density of X, for the model (8.1).

THEOREM 8.9. Suppose that the conditions of Theorem 5.6 are satisfied. Let $p_i(x, \eta)$ be the unnormalized conditional density of X_i given by Theorem 5.6. Then

(i) There exists a continuous function

(8.64)
$$\hat{p}_{\cdot}(\cdot,Z) \colon \Omega^{\bullet} \to C([0,T] \times \mathbf{R}^{d})$$

such that for all $n \in H$.

$$\hat{p}_t(x,Z) = p_t(x,\eta), \qquad 0 \le t \le T, x \in \mathbb{R}^d,$$

where $Z \in \mathcal{K}$ is given by

$$(8.66) Z_t = \int_0^t \eta_* ds.$$

(ii) $\beta_i(x, Y)$ is a version of the unnormalized conditional density of X_i given \mathcal{F}_i^Y

PROOF. Indeed, we have already shown that the choice of \$\hat{p}\$ given by (8.56) satisfies all the requirements. \$\sigma\$

REMARK 8.1. If the conditions of Theorems 8.8 and 8.9 are strengthened by the assumption of boundedness in place of linear growth in (5.38) and (5.58) then these theorems remain true with Ω^* replaced by Ω_0 in their statement. For $Z \in \Omega_0$, $\partial(t,x,Z)$ may not be locally Hölder continuous in (t,x) so that we cannot appeal to the results of Besala (1979) on parabolic PDEs with unbounded coefficients. However, for fixed t, $0 \le t \le T$, $Z \in \Omega_0$, $\partial(t,x,Z)$ is locally Hölder continuous in x and then instead, we can use Theorem 12 of Chapter 1 in Friedman (1964) to obtain a solution $\Psi_t(x,Z)$ of (8.49) for all $Z \in \Omega_0$.

For the rest of the proof, the same arguments given earlier for the case $Z \in \Omega^*$ yield the required results. Then we have $\beta_i(x, Y)$ for every $Y \in \Omega_0$.

REMARK 8.2. Theorems 8.8 and 8.9 (and their versions with Ω^* replaced by Ω_0 under the stronger conditions as outlined in Remark 8.1) show that the robustness results of the stochastic calculus approach to nonlinear filtering can be obtained from the finitely additive white noise theory.

COROLLARY 8.10. Suppose that the conditions of Theorem 5.6 are satisfied. Let $\{Y_k\}$ be the polygonal approximation to Y given by (8.40) where the sequence of partitions $\{t_i^k\}$ satisfies (8.39). Then $Y_k \to Y$ uniformly and hence by Theorem 8.9,

$$(8.67) p_{\cdot}(\cdot, \dot{Y}_{\bullet}) \rightarrow \hat{p}_{\cdot}(\cdot, Y), \tilde{\Pi}\text{-}a.e.$$

In particular, for all continuous $f: \mathbb{R}^d \to \mathbb{R}$ with compact support,

(8.68)
$$\sigma_{\ell}(f, \dot{Y}_{k}) \rightarrow \hat{\sigma}_{\ell}(f, Y), \quad \tilde{\Pi}\text{-}a.e.$$

It follows from this and (8.23) that for such an f.

(8.69)
$$\Pi_t(f, \dot{Y}_k) \rightarrow \tilde{\Pi}_t(f, Y), \quad \tilde{\Pi}_t$$
-a.e.

- 9. Directions of further work. The theory worked out in this article is by no means complete. We are aware of many questions that could be asked to which we do not now have an answer. We conclude by listing some of the problems that can be treated (and on which work is already in progress) using our approach although a further development of the theory of Sections 3 and 4 might be necessary to ensure complete success:
- (1) Finitely additive white noise theory of prediction and smoothing.
- (2) Robustness in the general (infinite-dimensional) measure-valued case.
- (3) Innovations problem for the nonlinear filtering problem. [Some progress on this problem has been made in the recent unpublished work of Seo and Mazumdar (1984).]
- (4) Applications of the theory to statistical parameter estimation and detection problems and to random fields.
- (5) Further analysis of the optimal filter as a functional of the observation y.
- (6) Robustness of the filtering solution in a class of finitely additive models in which the noise deviates from Gaussian white noise.

- (7) Discrete approximations to the filtering problem. (For discretization of Itô-type SDEs continuing work is reported by Pardoux and his colleagues [Pardoux and Talay (1984)].)
- (8) Extension of the white noise theory to the more general model in which signal and noise need not be independent.

A very important and interesting problem is the study of the optimal filter as a function of the observations. Lemma 5.4 (which has a very simple proof) gives some information on this question. M. Chaleyat-Maurel, in a paper to appear in the J. Funct. Anal., has shown that (for the signal and noise dependent case, under the assumption that the coefficients are C^{∞}) the optimal filter in the stochastic calculus theory is a C^{∞} function of the observation, in the sense of Malliavin. In other words, it possesses directional derivatives of any order in directions belonging to the Sobolev space H^1 . It is natural to expect analogous results to hold in the setup of the white noise theory.

We would like, in conclusion, to observe that the theory outlined in this paper has not been developed in any polemical spirit, to be set in opposition to the conventional theory that has so many brilliant achievements to its credit. From one point of view, the white noise theory may be regarded as another "language" in which to formulate and solve the nonlinear filtering problem (at least, in the signal and noise independent case). The results of Section 8 show that it is consistent with the "language" of the conventional theory. However, it is not clear at this stage whether the white noise approach might not lead to robustness results that have no counterpart in the conventional theory.

Appendix

Markov process and its extended generator. Let $(\Omega, \mathscr{A}, \Pi)$ be a countably additive probability space and let $\{\mathscr{A}_t\}_{0 \le t \le \infty}$ be an increasing family of sub- σ fields of \mathscr{A} such that \mathscr{A}_0 contains all Π -null sets in \mathscr{A} . For a measurable space (S_t, \mathscr{S}_1) , let $\mathscr{A}(S_t, \mathscr{S}_1)$ be the class of real-valued bounded measurable functions on (S_t, \mathscr{S}_1) . Let (S, \mathscr{S}) be a measurable space. Recall that an S-valued $\{\mathscr{A}_t\}$ -adapted process (X_t) is a family of mappings from Ω into S such that for all t,

$$(A.1) X_{\iota}^{-1}B \in \mathscr{A}_{\iota}, \text{for all } B \in \mathscr{S}.$$

DEFINITION. Let $\{X_i\}$ be an S-valued $\{\mathscr{A}_i\}$ -adapted process. Say that $\{X_i\}$ is Markov wrt the family (\mathscr{A}_i) if for all $i \geq 1, 0 \leq s \leq t_1 < t_2 < \cdots t_i < \infty$, $j \in \mathscr{J}(S^i, \mathscr{S}^i)$, where (S^i, \mathscr{S}^i) is the *i*-fold product of (S, \mathscr{S}^i) ,

(A.2)
$$E_{\Pi}(f(X_{t_1}, X_{t_2}, \dots, X_{t_n}) | \mathscr{A}_s) = g(X_s), \quad \Pi\text{-a.s.}$$

for some $g \in \mathcal{J}(S, \mathcal{S})$.

The equation (A.2) is known as the Markov property and is usually given in many equivalent forms. One of the most commonly used versions is

$$(A.3) \quad E_{\Pi}\left(f(X_t,\ldots,X_t)|\mathscr{A}_{\bullet}\right) = E_{\Pi}\left(f(X_t,\ldots,X_t)|\sigma(X_{\bullet})\right), \quad \Pi\text{-a.s.}$$

which is easily seen to be equivalent to (A.2). [Here, $\sigma(X_s)$ denotes the smallest σ field on Ω wrt which X_s is measurable.]

We will assume that the process $\{X_t\}$ is \mathscr{A}_t -progressively-measurable, i.e., for all t, the mapping $(s, \omega) \to X_s(\omega)$ from $[0, t] \times \Omega$ is measurable wrt $\mathscr{R}([0, t]) \otimes \mathscr{A}_t$.

We also assume that the Markov process (X_t) admits a transition probability function $P(\cdot, \cdot, \cdot, \cdot)$, i.e., there exists a function

$$P: \{(s, x, t, B): 0 \le s \le t < \infty, x \in S, B \in \mathcal{S}\} \rightarrow \mathbb{R}$$

such that

- (i) for all $0 \le s \le t, x \in S$, $P(s, x, t, \cdot)$ is a probability measure on (S, \mathcal{S}) ;
- (ii) for all $t < \infty, B \in \mathcal{S}$, the mapping $(s, x) \to P(s, x, t, B)$ is $\mathscr{B}([0, t]) \otimes \mathcal{S}$ measurable;
- (iii) for all $0 \le s \le t_1 \le t_2, x \in S, B \in \mathcal{S}$,

(A.4)
$$P(s,x,t_2,B) = \int_c P(s,x,t_1,dx)P(t_1,z,t_2,B);$$

(iv) for all $0 \le s \le t$, $B \in \mathcal{S}$,

$$(A.5) E_{\Pi}(1_{B}(X_{t})|\mathscr{A}_{s}) = P(s, X_{s}, t, B), \Pi-a.s.$$

It should be observed that (A.2) implies the existence of a function P satisfying (A.5), but in general it may not be possible to choose a version of P satisfying the conditions (i), (ii), and (iii) above.

The Markov process $\{X_i\}$ is called time homogeneous if

$$P(s,x,t,B) = P(0,x,t-s,B)$$

for all $0 \le s \le t < \infty$, $x \in S$, $B \in \mathcal{S}$. In what follows, we do not assume that $\{X_i\}$ is time homogeneous.

We want to remark that a Markov process on a finite interval [0,T] can be defined exactly as before: We require that (A.2) holds for $0 \le s \le t_1 \le t_2 \le \cdots \le t_i \le T$. In this case we say that $\{X_i\}$ admits a transition probability function $P(\cdot,\cdot,\cdot,\cdot)$ if there exists a function $P:\{s,x,t,B\}: 0 \le s \le t \le T, x \in S, B \in \mathcal{S}\} \to \mathbb{R}$ satisfying (i)-(iv) above, with $t,t_1,t_2 \le T$.

Given an S-valued Markov process $\{X_t\}_{0 \le t \le T}$ wrt $\{\mathscr{A}_t\}$, which admits a transition probability function P, let us define

$$\mathcal{A}_t = \mathcal{A}_T, \qquad t \ge T,$$

$$X_t = X_T, \qquad t \ge T$$

and

$$P(s,x,t,B) = P(s,x,T,B), \quad \text{for all } t \ge T, x, B \text{ if } s < T,$$

$$= 1_B(x), \quad \text{for all } s \ge T, t \ge T, x, B.$$

Then it is easy to check that $\{X_t\}_{0 \le t < \infty}$ is an S-valued Markov process wrt the family (\mathscr{A}_t) and that $P(\cdot,\cdot,\cdot,\cdot)$ is its transition probability function.

Thus, all the definitions and results which we will give later for a Markov process on $[0, \infty)$ also apply to a Markov process on [0, T].

We now associate a "two parameter" semigroup with the Markov process $\{X_t\}$ as follows.

For $l \in \mathcal{J}(S, \mathcal{S}), 0 \le s \le t$, let

$$(A.6) \qquad (V_i^s f)(x) = \int_{\mathcal{C}} f(\zeta) P(s, x, t, d\zeta).$$

In view of our assumptions on P, it follows that $V_i^*f \in \mathcal{J}(S, \mathcal{S})$ and that for $f \in \mathcal{J}(S, \mathcal{S}), 0 \le s \le t_1 \le t_2$

$$(A.7) V_{i_0}^{\mathfrak{s}} f = V_{i_0}^{t_i} (V_{i_0}^{\mathfrak{s}} f).$$

The semigroup V_t^* is related to the Markov process $\{X_t\}$ via the following property, which can be checked easily using (A.5): For all $f \in \mathcal{J}(S, \mathcal{S}), 0 \le s \le t$,

$$(A.8) E_{\Pi}(f(X_t)|\mathscr{A}_s) = (V_t^*f)(X_s). a.s. \Pi.$$

We now want to define the notion of a generator of the Markov process $\{X_i\}$. We have not assumed $\{X_i\}$ to be time homogeneous and hence we first associate a one parameter semigroup $\{T_i\}$ with the process $\{X_i\}$ as follows: Let $\hat{S} = [0, \infty) \times S$ and let $\hat{S} = [0, \infty) \otimes S$. For $f \in \mathcal{F}(\hat{S}, \hat{S})$, $0 \leq t < \infty$, let

$$(A.9) \qquad (T_t f)(s,x) = \int_S f(s+t,\zeta) P(s,x,s+t,d\zeta).$$

It is easy to see that

(A.10)
$$(T,f)(s,x) = [V_{s+t}^s, f(s+t,\cdot)](x).$$

From the property (iii) of P or from (A.7),(A.10) it follows that T_t is a one parameter semigroup, i.e.,

$$(A.11) T_{t_1}(T_{t_1}f) = T_{t_1+t_2}f.$$

The semigroup T_i is related to the Markov process $\{X_i\}$ via the property

(A.12)
$$E_{\Pi}(f(s+t,X_{s+t})|\mathscr{A}_{s}) = (T_{t}f)(s,X_{s}), \quad \Pi\text{-a.s.},$$

which follows from (A.8), (A.10) or directly from (A.5). The relation (A.12) implies (the well known fact) that the process $\hat{X}_t = (t, X_t)$ is a time homogeneous S-valued Markov process wrt the family $\{\mathscr{A}_t\}$, and that T_t is the semigroup associated with \hat{X}_t in the usual terminology [see Dynkin (1964)].

For $f_i, f \in \mathcal{J}(\hat{S}, \hat{\mathcal{S}})$, say that $f_i \to f$ weakly if $f_i \to f$ pointwise and $\{f_i\}$ is uniformly bounded.

Let

$$\mathcal{J}_0 = \{ f \in \mathcal{J}(\hat{S}, \hat{\mathcal{S}}) : T_t f \to f \text{ weakly as } t \downarrow 0 \}.$$

We assume that \mathcal{J}_0 is dense in $\mathcal{J}(\hat{S}, \hat{S})$, i.e.,

(A.13) for all
$$f \in \mathcal{J}(\hat{S}, \hat{S}), \exists I_i \in \mathcal{J}_0, \text{s.t. } I_i \to f \text{ weakly.}$$

This is a technical condition on $\{X_t\}$ and means that $(T_t f)$ is continuous at 0 for a rich class of functions f.

Let \mathcal{D} be the class of functions $f \in \mathcal{J}_0$ such that there exists $g \in \mathcal{J}_0$ satisfying for all t,

(A.14)
$$(T_t f)(s,x) = f(s,x) + \int_0^t (T_u g)(s,x) du, \quad (s,x) \in \hat{S}.$$

Since in (A.14), g is required to belong to \mathcal{J}_0 , it follows that $(T_ug)(s,x)$ is a continuous function of u. Thus (A.14) implies that

$$\frac{T_t f - f}{t} \to g \quad \text{weakly as } t \downarrow 0$$

and thus (A.14) determines g uniquely.

For $f \in \mathcal{D}$, let

$$(A.16) \mathscr{L} f = g,$$

where g is related to f by (A.14). \mathscr{L} will be called the extended generator of the Markov process X, and \mathscr{D} is the domain of \mathscr{L} .

The following lemma gives an important property of the generator \mathcal{L} .

LEMMA A.1. Let $i \in \mathcal{D}$. Then

(A.17)
$$\left\{ f(\hat{X}_t) - \int_0^t (\mathcal{L}f)(\hat{X}_u) du, \mathcal{A}_t \right\}$$
 is a martingale.

PROOF. To prove (A.17), it suffices to show that for all s, t,

(A.18)
$$E_{\Pi}\left(f(\hat{X}_{t+s}) - \int_{s}^{s+t} (\mathcal{L}f)(\hat{X}_{u}) du | \mathscr{A}_{s}\right) = f(\hat{X}_{s}), \quad \Pi\text{-a.s.}$$

From the definition of \mathcal{L} , we have

$$(A.19) \qquad (T_t f)(\hat{X}_s) = f(\hat{X}_s) + \int_0^t [T_u(\mathcal{L}f)](\hat{X}_s) du,$$

which in view of (A.12) implies

$$E_{\Pi}\left(f(\hat{X}_{t+s}|\mathscr{A}_{s}) = f(\hat{X}_{s}) + \int_{0}^{t} E_{\Pi}(\mathscr{L}f)(\hat{X}_{s+u})|\mathscr{A}_{s}\right) du$$

$$= f(\hat{X}_{s}) + E_{\Pi}\left(\int_{0}^{t} \mathscr{L}f)(\hat{X}_{s+u}) du|\mathscr{A}_{s}\right).$$
(A.20)

The interchange of conditional expectation and integral in the last step is justified because of the assumption that the paths of X_i are progressively measurable.

(A.18) now follows immediately.

REMARK. Using the condition (A.13), it can be proved that the class \mathscr{D} is large enough. Indeed, if (A.13) holds, then \mathscr{D} is a "measure determining" class. This fact is useful in the uniqueness assertions in Section 6.

d-dimensional diffusion processes. An \mathbf{R}^d -valued Markov process $\{X_i\}$ (with the family $\mathscr{A}_i = \sigma(X_i; s \leq t) \forall \{\Pi \text{ null sets}\}$ on a countably additive probability space $(\Omega, \mathscr{A}, \Pi)$ having a generator $\mathscr L$ with domain $\mathscr D$ is called a diffusion process if

- (i) $\Pi\{\omega: t \to X_t(\omega) \text{ is continuous}\} = 1$ and
- (ii) $C_0^{1,2}([0,\infty)\times\mathbb{R}^d)\subseteq \mathcal{D}$ with

(A.21)
$$(\mathcal{L}f)(t,x) = \frac{\partial f}{\partial t}(t,x) + \frac{1}{2} \sum_{i,j=1}^{d} \alpha_{ij}(t,x) \frac{\partial^{2} f}{\partial x_{i} \partial x_{j}}(t,x)$$

$$+ \sum_{i=1}^{d} b_{i}(t,x) \frac{\partial f}{\partial x_{i}}(t,x)$$

for all $f \in C_0^{1,2}([0,\infty) \times \mathbb{R}^d)$, where $a_{i,j}, b_i$ are measurable functions and the matrix $((a_{i,j}(t,x))$ is symmetric nonnegative definite for all (t,x).

The matrix-valued function a is called the diffusion coefficient and b is called the drift coefficient of the process $\{X_t\}$.

The question of the existence of a process $\{X_i\}$ with given diffusion and drift coefficients a, b and when a, b characterize the law of $\{X_i\}$ has been treated exhaustively by Stroock-Varadhan (1979).

The following moment estimate was obtained in Kallianpur (1980) under stronger conditions.

THEOREM A.2. Let $\{X_i\}$ be an \mathbb{R}^d -valued diffusion on $(\Omega, \mathscr{A}, \Pi)$ with diffusion coefficient a and drift coefficient b satisfying, for each T > 0,

$$|a_{i,i}(t,x)| \le C_T$$

and

$$|b_i(t,x)| \le C_T(1+|x|^2)$$

for all $0 \in t \le T$, $x \in \mathbb{R}^d$, $i, j \ge 1$ and a suitable constant $C_T < \infty$. Also suppose for some $C_1 > 0$,

$$(A.24) E_{11} \exp(C_1 |X_0|^2) < \infty.$$

Then, for each T>0, there exist constants $C_2>0$, $C_3<\infty$ [depending on the constants C_T , C_1 appearing in conditions (A.22), (A.23), (A.24)] such that

$$(A.25) E_{\bigcap} \exp \left(C_2 \sup_{0 \le t \le T} |X_t|^2 \right) \le C_3.$$

OUTLINE OF PROOF. When the process $\{X_i\}$ is given as a solution to an Itô stochastic differential equation, the existence of C_2 , C_3 satisfying (A.25) is proved in Kallianpur (1980, Theorem 5.7.2). First, an application of Lemma A.1 gives that

$$V'(t) = X_t' - \int_0^t b_i(s, x_s) ds$$

is a martingale and its quadratic variation is given by

$$\int_0^t a_{ii}(s,x_s) \, ds.$$

Using Burkholder's inequality on moments of V, we can complete the proof proceeding as in the above reference. A close examination of the various constants appearing shows that C_2 , C_3 depend only on C_T , C_1 . \Box

We will now derive the Feynman-Kac formula which gives a useful representation of a solution to a PDE. This formula is used in the literature under various sets of conditions [see, e.g., Friedman (1976)]. It was proved in Kallianpur-Karandikar (1984a) under the first set of conditions given in the next result. An outline of the proof under the second set of conditions was given in Kallianpur-Karandikar (1983b).

THEOREM A.3. Suppose $\{X_t\}$ is a diffusion process with drift coefficient b and diffusion coefficient a and suppose that (A.24) holds. Let $c\colon [0,\infty)\times \mathbb{R}^d\to \mathbb{R}$ be a continuous function. Suppose that $v\in C^{1,2}([0,T]\times \mathbb{R}^d)$ is a (classical) solution to the PDE

(A.26)
$$\frac{\partial v}{\partial t} + \frac{1}{2} \sum_{i,j=1}^{d} a_{ij} \frac{\partial^2 v}{\partial x_i \partial x_j} + \sum_{i=1}^{d} b_i \frac{\partial v}{\partial x_i} + cv = 0.$$

Suppose that either (A.27) holds or that the conditions (A.22), (A.23), (A.28), (A.29) hold where

(A.28)
$$|v(t,x)| \le \exp(K_1(1+|x|)), \quad (t,x) \in [0,T] \times \mathbb{R}^d$$

for a suitable constant $K_1 < \infty$,

(A.29)
$$c(t,x) \le K_2(1+|x|), (t,x) \in [0,T] \times \mathbb{R}^d$$

for some constant $K_2 < \infty$.

Then, for all $0 \le s \le T$,

(A.30)
$$v(s, X_s) = E_{\Pi} \left(v(T, X_T) \exp \left(\int_s^T c(t, X_t) dt \right) |\sigma(X_s)| \right).$$

PROOF. Fix $0 \le s < T$. Using "integration by parts formula" for local martingales and the fact that v satisfies (A.26), it can be shown that

$$N(t) = v(t, X_t) \exp\left(\int_{-t}^{t} c(u, X_u) du\right), \quad s \le t \le T$$

is a local martingale. For the details of this step, see Kallianpur-Karandikar (1984a). To complete the proof, we will show that N(t) is a martingale which clearly implies (A.30).

If (A.27) holds, then N is a bounded local martingale and hence is a martingale. If (A.22), (A.23), (A.28), (A.29) hold then

$$E_{\Pi}\Big(\sup_{s \le t \le T} |N(t)|\Big) \le E_{\Pi} \exp\bigg(\big(K_1 + K_2\big)\Big(\sup_{s \le t \le T} |X(t) + 1|\Big)\bigg) < \infty$$

by Theorem A.2. Hence N(t) is a martingale. This completes the proof.
